# Protester killed in Kangpokpi; shutdown in Kuki-Zo areas from midnight

**PTI, IMPHAL:** A protester was killed while 25 others, including women, were injured in clashes between Kuki demonstrators and security forces in different parts of Manipur's Kangpokpi district on Saturday, officials said.

The deceased has been identified as Lalgouthang Singit. The 30-year-old received bullet injuries during the clashes at Keithel-manbi and died on the way to hospital, police said.

At least 25 protesters sustained different types of injuries during the clashes with security forces at Gamgiphai, Motbung and Keithel-manbi, police said, adding they have been admitted to the nearby public health centre for treatment.

Clashes erupted between demonstrators and security forces in the Kuki-dominated district after police fired tear gas to disperse them, as they opposed Union Home Minister Amit Shah's directive allowing free movement



**114 WEAPONS RECOVERED BY SECURITY FORCES ACROSS MANIPUR**

**PTI, IMPHAL:** In a series of operations, security forces have recovered 114 weapons, improvised explosive devices (IEDs), grenades and ammunition across Manipur after the expiry of a two-week period for voluntarily surrendering looted and illegally held arms in the ethnic strife-torn state, an official statement said on Saturday. Intelligence-based operations were launched in the hill and valley districts of Bishnupur, Senapati, Thoubal, Jiribam, Chandel, Churachandpur, Kangpokpi, Imphal East and Imphal West. Altogether 114 weapons, IEDs, grenades, ammunition and war-like stores were recovered during these operations, an army statement said.

The situation worsened when protesters set fire to private vehicles and attempted to stop a state transport bus traveling from Imphal to Senapati district.

Protesters also blocked NH-2 (Imphal-Dimapur highway) and burned tyres

to obstruct movement of government vehicles.

The protest was also directed against a peace march by the Federation of Civil Society (FOCS), a Meitei organisation.

The march, involving over 10 vehicles, was halted by security forces at Sekmai before it could reach

## SEVEN MEMBERS OF BANNED OUTFITS IN MANIPUR HELD

**PTI, IMPHAL:** Seven members of four proscribed outfits were arrested in separate operations in strife-torn Manipur, police said on Saturday. Two cadres of the banned Kangleipak Communist Party (PWG) were apprehended from Lamphel in Imphal West district on Friday, while another member of the same outfit was held near the gate of Bir Tikendrajit International Airport, a senior officer said. They have been identified as Moirangthem Jiban Singh (27), Laishram Tiken Singh (40) and Thoudam Premkumar Singh (38), he said. An amount of Rs 50,000 was also recovered from those who were arrested in Lamphel. Two members of the proscribed Kanglei Yaol Kanna Lup (KYKL) were arrested on Thursday near the Lokchao river along the India-Myanmar border in the Tengnoupal district. "These members of the militant group have been identified as Keisham Naocha alias Ningsingba (38) and Ningthoujam Sanjoy (18) and handed over to the local police for necessary legal actions," an officer said. A 24-year-old cadre of the outlawed KCP (Taibanganba), identified as Mayanglam Bam Borish Singh, was also arrested on Friday, he said. Security forces arrested another member of the banned PREPAK, identified as Ningthoujam Dhananjay.

Police claimed they had been told to stop the march as they did not have permission.

"We are just following orders. We have been told to stop the march. If they want to go, they can go in the state buses arranged by the government," a po-

liceman said.

However, FOCS members objected saying they were just following what Shah's instruction allowing free movement across the state from Saturday.

A purported video released by Kuki-Zo village volunteers group from an undisclosed location said

it was against the government of India's decision regarding free movement and demanded a separate administration. The authenticity of the video could not be corroborated by PTI.

"Any attempt to enter our areas will be met with strong resistance. No free movement before separate administration" a volunteer was heard saying in the video.

Opposing the free movement initiative, the Kuki Zo Council has imposed an indefinite shutdown in all Kuki-Zo areas from Saturday midnight, a statement said.

"It is crucial for the central government to address the underlying issues to prevent further unrest and protect public safety. The Kuki-Zo Council urges the government to reconsider its stance to avoid further escalation of tension and violent confrontation," it added.

The council also stated, "We cannot guarantee free movement of Meiteis across buffer zones and cannot take responsibility for any untoward incidents."

## 19 nabbed over cheating in class 10 Eng exam, 14 from principal's house

**PTI, HARDOI (UP):** In two separate raids here, the Uttar Pradesh Special Task Force arrested 19 people in connection with cheating during the class 10 English exam of the UP Board, an official said on Saturday.

### UP BOARD EXAM

The paper took place in the morning shift (8.30 am to 11.45 am) on Friday.

In the first instance, 14 people were found solving the question paper at the residence of a school principal, the official said.

A Special Task Force team, along with District Inspector of Schools Balmukund Prasad, raided the Jagannath Singh Public

Inter College at Katiyamau village in HarDOI district.

Acting on a tip-off, they also raided the principal's house 3-4 kilometres away and found five men and nine women writing the answers. One of them introduced himself as a teacher of the school.

The STF recovered 20 answer sheets from them.

In the second event, two women were found solving the paper outside the Jai Subhash Mahabali Inter College in the Dalt Nagar area of the district, the official added.

Centre-in-charge, Ram Milan, and the examination in-charge, Manish Singh, along with a teacher, were nabbed

by the STF in the raid.

Balmukund Prasad told PTI that the two gangs had been impersonating students who appeared for the exam. He said the STF arrested 19 people in all, 14 of them solvers, confiscating the answer sheets, which were then sealed.

Balmukund Prasad said the centre administrators and static magistrates of both the schools will be replaced.

## Two killed, 13 injured as vehicle overturns on Samruddhi Expressway

**PTI, MUMBAI:** Two people were killed and 13 others injured after a vehicle overturned and was hit by a car on the Mumbai-Nagpur Samruddhi Expressway on Saturday morning, police said.

The accident occurred at Malsawargaon in Buldhana district around 9 am when a vehicle with 15 people from Yavatmal was heading to Shirdi, an official from Sindkhed Raja police sta-

tion said.

He said one of the tyres of the vehicle burst, causing it to overturn, and a car rammed into it from behind.

The official said the deceased were identified as Vidya Sable and Motiram Borkar.

He said 13 injured persons were taken to a nearby hospital, where three of them are in critical condition.

## We are chasing tech, it should come out of India: IAF chief

**PTI, NEW DELHI:** IAF Chief Air Chief Marshal A P Singh on Saturday said the Indian ecosystem needs to reach a stage where new technology comes out of India and others are chasing it.

At an interactive session at the India Today Conclave here, he also said one of the lessons from the ongoing conflicts is that one needs to be prepared for a protracted, long-drawn war.

"So, along with our

capabilities, we need to build our capacity, a capacity to last a long-drawn war," the IAF chief said, adding the earlier idea that wars are going to be "short and swift" has changed.

"And, we need back up of the industry so that we continue to fill up losses that we have. Second, the primacy of control of air, has come out loud and clear," he added.

And, the role of technology, especially un-

manned vehicles, has come to the fore from the conflict, the air chief marshal said when asked about the lessons from ongoing conflicts in the world.

Air Chief Marshal Singh, however, said with advancement in technology, "we need to catch up".

He was also asked about reports that Pakistan is going to get a fifth generation fighter aircraft from a neighbouring country.

## Sangini initiative fights period poverty in with sanitary pad dispensers, incinerators

**PTI, BEGUSARAI:** To tackle period poverty and empower young girls, sanitary pad dispensers and incinerators were installed in two schools in Manjhaul here as part of the Sangini initiative that aims to transform Begusarai into a model district in menstrual hygiene.

This innovative project by non-profit organisation NOBA GSR (Netarhat Old Boys Association Global Social Responsibility), supported by Press Trust of India (PTI), aims to ensure menstrual hygiene management in rural schools so that girls no longer miss out on education due to their periods. The installa-

With more than 700 installations in schools, the statement said, the initiative has significantly reduced absenteeism and dropout rates among adolescent girls.

Each dispenser is equipped with SIM-enabled technology that allows real-time tracking of stock levels, ensuring timely refills that make menstrual hygiene products accessible.

NOBA GSR Operations Manager Mani Raj Singh highlighted the initiative's broader mission.

Saurabh Kumar, NOBA GSR's Begusarai official, shared the local impact.
