Jiribam DC appeals for peace, communal harmony in Manipur district

PTI, IMPHAL: Manipur's Jiribam deputy commissioner Krishna Kumar on Monday appealed to the people of the district to uphold peace, unity and communal harmony and assured that the administration, in coordination with security forces, remains committed to ensuring the safety, security and wellbeing of every resident, an official statement said.

In a public appeal, Kumar said, "Jiribam has always been a beacon of communal brotherhood, cultural diversity, coexistence and mutual respect. 12 MILITANTS ARRESTED IN MANIPUR

PTI, IMPHAL: Security forces arrested at least 12 militants in Manipur belonging to different proscribed outfits in the last two days, police said on Monday. Three active cadres of the banned United People's Party of Kangleipak (UPPK) were held from Langol Type-II area in Imphal West, along with a member of the Kanglei Yaol Kanna Lup (KYKL) in Tengnoupal district along the India-Myanmar border on Saturday, they said. On Sunday, police arrested a woman cadre of the outlawed National Revolutionary Front of Manipur from Imphal East district. Five members of the People's Revolutionary Party of Kangleipak PREPAK (Pro) were also apprehended in two separate operations at Khongman Nandeibam Leikai in Imphal East district and Heinoukup in Imphal West district on Sunday, police said. Two active cadres of the banned Kangleipak Communist Party (PWG) were arrested from Lamphel and Samroun in Imphal West district, they added. Investigation is underway.

ONE-HOUR DEBATE IN LOK SABHA FOR APPROVAL OF PRESIDENT'S RULE IN MANIPUR

PTI, NEW DELHI: The Lok Sabha will have an hour-long discussion on the statutory resolution seeking approval of the proclamation of President's Rule in Manipur. The decision was taken at a meeting of the Lok Sabha's Business Advisory Committee (BAC), chaired by Speaker Om Birla, on Monday. The Lok Sabha will take up a discussion on the Manipur budget, presented by Union Finance Minister Nirmala Sitharaman, from Tuesday. The discussion on the Manipur budget has been clubbed with the debates on the second batch of Supplementary Demands for Grants for 2024-25 and the Demands for Excess Grants for 2021-22 and six hours have been allotted for it. The BAC also decided to cancel the sitting on March 13 on account of Holi. It recommended that the Lok Sabha sit on Saturday, March 29, to compensate for the March 13 sitting. It has allotted 10 hours for a discussion on the Railways and one day each for debates on the Demands for Grants of the ministries of Jal Shakti, and agriculture and farmers' welfare.

Maoist gunned down in MP

PTI, MANDLA (MP): Madhya Pradesh police's anti-Naxal Hawk Force gunned down a Maoist and captured two of his accomplices after an encounter in tribal-dominated Mandla district of the state, an official said on Monday. Around 205 rounds were fired during the gun-battle - 125 from the Naxals and 80 by the Hawk Force - which took place in a thickly forested area on Sunday, he informed. A.315 bore firearm was recovered from the outlaws, the official added.

On March 8, intelligence reports suggested the presence of Naxalites in the Kanha National Park area under Khatiya police station limits of the district, Balaghat Zone Inspector General of Police Sanjay Singh told reporters.

Notify teacher posts for special needs children: SC to States

PTI, NEW DELHI: The Supreme Court has directed states and union territories to notify by March 28 the number of sanctioned posts of teachers to educate children with special needs.

A bench of Justices Sudhanshu Dhulia and K Vinod Chandran observed despite its 2021 judgment, none of

the states or UTs made appointments on such sanctioned posts.

In fact, a large majority of the states didn't even identify the sanctioned posts required in the state, despite there being figures relating to children with special needs, the court said.

"Each state and UT shall come out with notifications

with the number of posts that they have sanctioned for teachers who have to impart education to children with special needs," it added.

The March 7 order said after the posts were sanctioned and notified preferably within three weeks - on or before March 28, 2025 - at least two newspapers "hav-

ing wide circulation" would carry ads in the respective states aside from the websites of the education department and the state government concerned.

The bench was hearing a plea filed by Rajneesh Kumar Pandey, through advocate Prashant Shukla, claiming a dearth of special educators in Uttar Pradesh

and other states. The petition filed by 17 teachers, who claim to have undertaken the required training to teach children with special needs, said to make Right to Education a success, it was essential to appoint qualified professionals in each school to help kids prepare for life challenges.

Following uproar, Designers Shivan & Narresh apologise for Gulmarg fashion show

PTI, NEW DELHI: Designer duo Shivan & Narresh, who are facing backlash for displaying "obscene" garments at a fashion show in Gulmarg last week, have said their sole intention was to celebrate creativity and regret any hurt caused by the event during the holy month of Ramzan.

The Delhi-based designers, whose full names are Shivan Bhatiya and Narresh Kukreja, showcased their skiwear collection on March 7 to mark the 15th anniversary of their label. The issue

was raised in the Assembly and Jammu and Kashmir Chief Minister Omar Abdullah has ordered an inquiry into the matter.

Abdullah on Monday said his government would have never given permission for such an event.

We have already ordered an inquiry into it but preliminary facts revealed that it was a private four-day event organised by a private party in a private hotel...Some people are saying that such a show should not have happened in the month of Ramzan. After what I have seen,

I am of the opinion that it should not have taken place any time of the year, he said in the Assembly.

In an X post on Sunday, Kashmir's chief minister, Mirwaiz Umar Farooq called the fashion show "outrageous". Following criticism on social media and elsewhere, Shivan & Narresh posted a statement of apology on their official X page.

"We deeply regret any hurt caused by our recent presentation in Gulmarg during the holy month of Ramadan. Our sole intention was to celebrate crea-

tivity and the ski & apres-ski lifestyle, without any desire to offend anyone or any religious sentiments.

"Respect for all cultures and traditions is at our heart, and we acknowledge the concerns raised. We sincerely apologise for any unintended discomfort and appreciate the feedback from our community. We remain committed to being more mindful and respectful," they said in the statement.

Abdullah responded to Farooq's post, saying the shock and anger are totally understandable.

Stage collapses at MP protest, over dozen injured
