# NEP destructive Nagpur plan, will not accept it, says Stalin

PTI, CHENNAI: Tamil Nadu Chief Minister M K Stalin on Tuesday dubbed the National Education Policy a "destructive Nagpur plan" and reiterated that the state would not accept it even if the union government was to provide Rs 10,000 crore. Addressing a government event at Chengelpet near here, Stalin said: "Yesterday, you would have seen Parliamentary proceedings on television. He is talking arrogantly that Tamil Nadu would be provided Rs 2,000 crore only if Hindi and Sanskrit are accepted. Who? It was Union Education Minister Dharmendra Pradhan."

The state was opposing the National Education Policy since it would com-

pletely destroy the growth of education in Tamil Nadu. "The NEP, rather than trying to bring students into education, has all action plans to ease students out of education," he alleged. Assailing the NEP for allowing dominance of the union government in the matter of education, he

listed several reasons for opposing it. Injecting communalism into education, privatisation of education, creating a situation wherein only the rich could access higher education, public examination even for small children, NEET-like entrance examination for arts, science and

engineering courses were among the reasons, the chief minister alleged. Only after considering all such factors, Tamil Nadu became firm that it would not accept the NEP. Reiterating his accusation that Pradhan blackmailed the state to accept NEP for release of funds, the chief minister said he had already made it categorical that Tamil Nadu would not accept it. "I had said categorically in no uncertain terms that we will not accept your destructive Nagpur plan even if you provide Rs 10,000 crore (by going beyond approximately Rs 2,000 crore, due to the state). I am saying that again here," the chief minister affirmed.

## FIR filed for attack on ED vehicle after raids at Baghel's house

PTI, RAIPUR: The Durg Police has filed an FIR into an incident of obstructing and stoning of a vehicle that was part of the Enforcement Directorate team that searched the residence of former Chhattisgarh chief minister and senior Congress leader Bhupesh Baghel in a case against his son, official sources said. The complaint has been filed at the 'Old Bhilai' police station in the said district on Monday night by the driver of the private vehicle.

The ED had raided Baghel's residence in Bhilai's Mansarovar Colony and 13 other locations in Durg as part of a money laundering investigation

against his son Chaitanya Baghel in an alleged liquor scam case. The searches went on for about eight hours during which the ED seized about Rs 30 lakh in cash and some documents, according to sources.

## TELANGANA TUNNEL COLLAPSE Robot with AI-based camera joins search operation

PTI, NAGARKURNOOL (TELANGANA): A robot equipped with an AI-based camera joined the operation on Tuesday to locate the seven people trapped inside the partially collapsed Srisailem Left Bank Canal (SLBC) tunnel since February 22. A team from a Hyderabad-based robotics company, along with a robot equipped with an AI-based camera, entered the tunnel on Tuesday morning. Additionally, 110 rescue personnel were deployed, an official statement said. The Telangana government has decided to deploy robots to minimise risks to rescue personnel, as water and slush inside the tunnel pose significant challenges.

## MP: Cong MLAs protest with plastic snakes, accuse govt of hoarding jobs

PTI, BHOPAL: Congress MLAs on Tuesday staged a protest by carrying plastic snakes in the Madhya Pradesh assembly complex, alleging that the ruling BJP was sitting on government job vacancies "like a serpent". A state minister later called the Congress' act "shameful" and said the opposition was misusing the Vidhan Sabha premises for a "photo-op". Before the state budget session proceedings for the day commenced, Congress MLAs, led by Leader of Opposition Umang Singh, gathered in front of Mahatma Gandhi's statue in the assembly building while carrying plastic snakes in baskets and placards. They raised slogans, accusing the government of failing to provide jobs to the youth of the state. Singh claimed unemployment was rising in the state. The youth were running from pillar to post for

jobs, while recruitments have been stopped in government departments like police, education, irrigation and health, he further claimed. "The BJP government is biting the youth like a snake in the name of jobs. This government is sitting like a serpent on jobs," the LoP charged. "Hence, we held this symbolic protest to awaken the government on the issue of unemployment," he said.

The Congress leader claimed that more than 70,000 posts are lying vacant in the education department alone, but the government has not paid attention. Reacting to the protest by Congress MLAs, state cabinet minister Vishwas Sarang claimed the opposition leaders were misusing the assembly building premises for a "photo opportunity" and to draw media attention.

## Bureaucrats can't be allowed to frustrate grassroot democracy: SC

PTI, NEW DELHI: The Supreme Court has said bureaucrats couldn't be allowed to "frustrate grassroot democracy" and upheld a Bombay High Court order reinstating a woman as the sarpanch of a Maharashtra village. A bench of Justices Surya Kant and N Kotiswar Singh said it noticed several recent instances from the state where bureaucrats misbehaved with the elected representatives of Panchayats. "We have given judge-

ments in two-three cases where babus were found to be misbehaving with the elected representatives. This is happening typically in Maharashtra. These babus should be under the elected representatives. These bureaucrats cannot be allowed to frustrate the grass root democracy," it said. The court also came across bureaucrats trying to open old cases to disqualify elected representatives especially at grass-root level. "They (bureaucrats) try

to open old cases like your grandfather has encroached upon government land and hence you are disqualified," Justice Surya Kant told the counsel for Archana Sachin Bhosale, whose election as the sarpanch was set aside by the high court on January 29. Reinstating Kalavati Rajendra Kokale as the sarpanch, the top court upheld the high court quashing the June 7, 2024 order of the collector of Raigad district declaring a vacancy for the post of sarpanch in village Ainghar, Taluka-Roha.
