

AG assures HC: Petitioner's concerns on Porvorim corridor to be addressed

Submits suggestions made by amicus curiae appear to be reasonable, states every possible effort will be made to resolve issues placed on record

PANJIM: Advocate General Devidas Pangam on Thursday assured the High Court that all the suggestions given by the petitioner will be placed before the PWD principal chief engineer for consideration and for finding out a resolution while constructing the six-lane elevated corridor at Porvorim.

While hearing a public interest litigation (PIL) writ petition filed by Adv Moses Pinto and miscellaneous civil application by Eurico Mascarenhas, the AG

Pangam submitted that the suggestion made by amicus curiae Adv Abhijit Gosavi appear to be reasonable and the same will be placed before the PWD principal chief engineer for consideration and for finding out a resolution. He also submitted that every possible effort will be made to resolve the issues which have been placed on record by Adv Gosavi.



A joint meeting will be organised from time-to-time between the PWD principal chief engineer and the contractor along with other agencies, he said.

The Court appreciated the efforts of Adv Pinto and Adv Gosavi in bringing to their notice the ground realities of National Highway-66 elevated corridor project.

Adv Pinto placed on record

photographs to indicate the extent of inconvenience that is being caused as a result of such ongoing road work. The report dated March 12, 2025 was handed over to the Advocate General as well as to the contractor.

Adv Pinto suggested that the concerned authorities be directed to take immediate remedial measures to mitigate the hazards identified in this report. He



stated that the project contractor be instructed to comply with all safety regulations and contractual obligations under the supervision of an independent monitoring agency.

Adv Gosavi also placed some issues that require urgent attention. He suggested that the contractor should file a detailed plan of action in respect of implementation of drainage

system in place.

Also Coqueiro Junction to Damian de Goa service road section be immediately hot mixed to allow smooth movement of traffic and to deploy traffic personnel to ensure proper flow of traffic and avoid traffic congestion in the area.

The matter has been posted for further consideration on April 7.

Social activist Polgi booked for hurting religious sentiments

VASCO: The Mormugao Police on Thursday booked social activist Xencor Polgi following complaints from several devotees of His Holiness Padmashree award-dee Pujya Sadguru Brahmeshanandacharya Swami.

The complainants alleged that Polgi made objectionable remarks about the recently held Goa Spiritual Festival, organised by the Satguru Foundation at Baina Beach.

The complaint claims that Polgi intentionally outraged religious sentiments by making derogatory remarks against Swamiji, accusing him of supporting political leaders and promoting enmity on religious grounds. It is also alleged that Polgi circulated these statements on social media, potentially disturbing public harmony.

A large number of devotees gathered at the Mormugao Police Station on Thursday afternoon, demanding Polgi's immediate arrest.

Tourists attack taxi driver in Calangute

CALANGUTE: A taxi driver was allegedly assaulted by a group of tourists at Naikawaddo, Calangute, on Wednesday after one of them fell off a two-wheeler, reportedly after being struck by the tourist taxi. The vehicle was also vandalised in the incident.

According to Calangute police, the incident occurred at around 4 pm when a tourist, riding a two-wheeler with a woman pillion rider, collided with the side rear-view mirror of the taxi and fell onto the road. The group of tourists, who were on four

two-wheelers, became enraged with the taxi driver and allegedly began assaulting him with their helmets when he stopped to assist the fallen tourist.

To escape the attack, the taxi driver reportedly fled the scene, leaving his vehicle and passengers at the site of the accident. The tourists then allegedly smashed the windscreen and damaged the rear-view mirrors of the taxi. The vehicle had picked up passengers from Mopa Airport and was en route to drop them at their hotel in Calangute.

Following the incident, the taxi driver lodged a complaint

at Calangute police station. Three of the tourists, identified as Manish Tomar (40), Vijay Rajput (47), and Dhruv Rajput (21), have been booked by the police.

A large number of taxi drivers later gathered at the Calangute police station on Wednesday night, demanding strict action against the tourists. "Tourists come to Goa and think they can beat up the locals and get away with it. These types of incidents are increasing. There has to be strict action against such tourists. It is fortunate that the passengers inside the car were not injured," taxi drivers said.

Kenyan woman arrested for running global sex trafficking racket

PANJIM: The Crime Branch of Goa Police has arrested Nancy King'ori, alias Alian, a Kenyan national, for allegedly running an international human trafficking racket.

According to police, the case came to light when the victim, also a Kenyan national, lodged a complaint on March 3 stating that the accused had procured her and forced her into prostitution since November 18, 2024.

Police sources revealed that the accused Alian procured young women from Kenya on the pretext of providing them jobs in the hospitality industry in Goa, confiscated their passports and then forced them into flesh trade.

the photos of the victim girls on Massage Republic and add her contact number to solicit clients online," said a cop and added that most of the clients were Arabs, African and Indian men who were charged from Rs 10,000 to Rs 30,000.

"The victims were kept in the North Goa coastal belt and were shifted between Goa, Mumbai and Bangalore," said the cop.

The case came to light when the victim managed to contact an NGO in Kenya who in turn requested ARZ to extend a helping hand and rescue the victim. A complaint was filed with the Crime Branch and SP Rahul Gupta then dispatched a team to Bangalore, rescued the victim and arrested the accused.

A special team led by LPSI Pragati Malik and staff

from the Crime Branch Police Station arrested King'ori and brought her to the Crime Branch Police Station in Ribandar on March 13.

The accused was produced before the Judicial Magistrate First Class (JMFC) in Mapusa, which remanded her to seven days of police custody.

The investigation is ongoing under the supervision of PI Prashal PN Dessai, DySP Crime Rajesh Kumar, and SP Crime Rahul Gupta, IPS.

"The Crime Branch has done a commendable job by arresting the accused from Bangalore as this will deter others from trafficking women from foreign countries," said Arun Pandey, founder and Director of ARZ.

Full-fledged mining to restart in Goa within 6 months: Union Min

Chief Minister Pramod Sawant disclosed that Goa has identified one or two critical minerals, and exploration for them will commence soon.

As part of the festival's commencement, Ponda Shigmo Festival Working Committee Chairman Ritesh Naik, Chairperson Anand Naik, and several committee members sought blessings at the Zareshwar temple in Ponda. On March 12, they carried out a traditional

Goa signs MoU with Portuguese organisation to promote heritage, art
