TEACHER SUSPENDED OVER QUESTION PAPER THEFT' AT GOA VARSITY

Fact-finding committee will submit report in 48 hours, but no formal complaint has been lodged yet

PANJIM: The Assistant Professor whose name has come up in the alleged question paper theft at Goa University was suspended pending enquiry on Monday by university Vice-Chancellor Harilal B Menon, though he admitted that no formal complaint on the question paper theft had been made to him so far.

The allegations kept the university campus on the boil all through the day, with Akhil Bharatiya Vidyarthi Parishad (ABVP) activists protesting and raising slogans, demanding the teacher's suspension.



The suspension of the Assistant Professor at the School of Physical and Applied Sciences came in response to a formal complaint lodged at the Agasaim Police Station by a group of activists

The teacher's name first got embroiled in a controversy in September 2024, when he is alleged to have accessed the cabin of a colleague to retrieve chemicals for experiments The matter was resolved after the Assistant Professor apologised, though no formal complaint was lodged After activists submitted a complaint to Agassaim Police Station on Sunday, he was handed a suspension order on Monday pending enquiry Akhil Bharatiya Vidyarthi Parishad (ABVP) activists protested and raised slogans, demanding the teacher's suspension on Monday

led by Kashinath Shetye on Sunday. Menon confirmed that a two-member fact-finding committee has been constituted to investigate and submit a report within 48 hours.

Menon clarified that further action would be taken based on the findings of the committee. "There will be further disciplinary action if the committee submits a report that substantiates the claims," he said. Governor and Chancellor of Goa University, P S Sreedharan Pillai has also asked for a detailed report from the Vice-Chancellor.

During the day, the ABVP activists raised slogans and gheraoed the Vice-Chancellor on campus, preventing him from leaving the university to meet the Vice-Chancellor. The ABVP members staged a demonstration outside the Vice-Chancellor's office, shouting slogans and calling for swift action.

AGENCY, NEW DELHI: Delhi Police is set to launch 'Shishtachar' squads, also known as 'anti-eve teasing' squads, to improve women's safety in the national capital. The initiative will "focus on enforcing the law, rather than imposing personal or cultural morality on individuals", read a circular issued by the Delhi police.

The decision follows a promise made by the Bharatiya Janata Party before the Delhi assembly elections to introduce 'Anti-Romeo Squads' and install CCTV cameras in public spaces as part of their poll manifesto.

As per an order signed by Delhi Police Commissioner Sanjay Arora, "These squads will comprise trained personnel, who shall focus on preventing, deterring, and responding to such offences on a real-time basis."

Each district will have two Anti-Romeo Squads led by an Assistant Commissioner of Police (ACP). Every squad will include an inspector, a



sub-inspector, and five male police officers, along with four female personnel. The Anti-Auto Theft Squad (AATS) will also support the teams by providing technical assistance.

The squads will also deploy plainclothed female police officers to identify and deter perpetrators.

ident Welfare Associations (RWAs), Market Welfare Associations (MWAs) and local volunteers to enhance vigilance and identify more vulnerable spots, the squad will focus on victim protection, ensuring survivors don't face public scrutiny.

> The primary focus will be on 'hotspots and vulnerable areas' that pose risks to women's safety. These locations will be identified by the District Deputy Commissioners of Police (DCPs). Officers will operate in plain clothes to monitor suspicious activities and take action against offenders.

The squads will also conduct surprise checks on public transport and interact with Delhi Transport Corporation (DTC) drivers, conductors, and passengers to encourage them to report incidents. The directive further states, "The squads will operate with a multi-faceted approach involving prevention, intervention, and victim assistance.

The squads will send weekly reports to senior officers, with their work being overseen by the Assistant Commissioner of Police.

According to Delhi Police data, 4,273 cases of rape, molestation and eve-teasing were reported in the city until December 15 last year. Out of these, 1,971 cases were registered at various police stations across Delhi.

With the launch of 'Shishtachar' squads, authorities hope to create a safer environment for women and curb such crimes in the city.
