#### MAN BOOKED FOR SELLING 'ILLEGAL' **E-CIGARETTES AT ARAMBOL**

**PANJIM:** Mandrem Police have booked a 31-year-old Abdul Azeez for allegedly selling illegal e-cigarettes at a shop near Mount Carmel Church, Arambol and seized 11 e-cigarettes from him.

According to police, the seizure was made following a raid conducted at a shop styled as "MOBI PUFF" opposite Mount Carmel Church, Arambol, and it was found that the alleged accused resident of Korkhankar Wada, Arambol, and native of Kasaragod, Kerala, was selling e- cigarettes. An FIR has been registered and the case is being investigated by PSI Pratik Garudi.

#### **DABOLIM ACCIDENT VICTIM** SUCCUMBS TO INJURIES

VASCO: A scooter rider from New Vaddem, Vasco, who sustained grievous injuries in an accident at Dabolim, died while undergoing treatment at Goa Medical College and Hospital, Bambolim.

According to the police, the deceased identified as Mahadev Madar along with pillion rider Mabusab Nadaf was proceeding from Dabolim Junction to Varunapuri on a scooter. When he reached near Dabolim Airport, he lost control of the vehicle and hit the road divider. Both sustained injuries and were rushed to GMC, but Madar succumbed to the injuries.

The post-mortem certified the cause of death due to "Head injury consequent to blunt force impact by surface and/or object. However, viscera is preserved for chemical analysis". The body was handed over to the family for final rites. Vassco PSI Nikhil Dessai is conducting further investigation.

#### CAMURLIM RESIDENT ARRESTED FOR **ALLEGEDLY MOLESTING A WOMAN**

**PANJIM:** The Colvale Police have arrested Godwin Fernandes from Darbarwado, Camurlim, for allegedly outraging the modesty of a woman. According to police, the accused allegedly took photographs of a woman and inappropriately touched her while she was spreading wheat outside her home. An FIR has been registered and investigations are on, the police added.

#### PARKED MOTORCYCLE STOLEN IN MARGAO

MARGAO: Aniceto Luis, a resident of Nuvem, lodged a complaint with Fatorda Police stating that an unknown person/s stole his motorcycle worth Rs 1 lakh, parked in an open space, opposite a hospital near the KTC bus stand. The police have visited the site and registered an offence under Section 303 (2) BNS 2023 ASI, Hiralal Gaude of Fatorda Police Station is conducting further investigation.

#### MAN FOUND DEAD IN LOUTOLIM

MARGAO: Maina-Curtorim Police found a decomposed body of a male in a locked room at Orgao-Loutolim. The police said that on receiving information from a resident, a team was sent to the site.

The police said that when they visited the spot, they found the front door of the house was locked from inside. They managed to break open the door with the help of Verna Fire Brigade personnel. On entering the house, they found a male body lying on bed in a decomposed state. The police said the deceased was identified as M Vaz of Orgao.

The police conducted the panchanama and the body was referred for post-mortem examination at South Goa District Hospital, Margao. Maina-Curtorim PSI Praful Giri is conducting further investigations.

## **Complaints against KTCL** for violating passenger rights

MARGAO: GOACAN, a consumer rights organization, has filed four separate complaints against the Kadamba Transport Corporation Limited (KTCL) for systemic failures in complying with mandatory provisions for passenger convenience and rights. The complaints highlight violations across multiple buses, which lacked reserved seats for Persons with Disabilities (PwDs), senior citizens,

and ladies, as well as the mandatory display of the KTCL WhatsApp complaint number. In one instance, GOA-CAN coordinator Roland Martins, a senior citizen,

was forced to stand during his journey due to the absence of reserved seating. The bus conductor, when informed, directed him to file a complaint at the Margao control room instead of addressing the

issue. Additionally, the ticket issued bore an incorrect bus number, complicating the grievance redressal process.

The complaints, addressed to the State Commissioner for PwDs, Directorate of Social Welfare, Directorate of Women & Child Development, and the Department of Civil Supplies & Consumer Affairs, allege widespread non-compliance across KTCL buses.

GOACAN has cited violations of the Rights of Persons with Disabilities Act, 2016, and other regulations, emphasising the lack of reserved seats and complaint mechanisms on several buses.

GOACAN has demanded depot-wise compliance reports with photographs to ensure adherence to regulations and also urged KTCL to display an email ID for complaints, in addition to the WhatsApp number, to streamline grievance redressal.

# **KTCL** bus rams into roadside

VASCO: Portion of a roadside house at Chicalim collapsed after a Stateowned KTCL bus rammed into it on Tuesday.

The accident occurred when the driver of the Vasco-Panjim bound bus tried to avoid colliding with a two-wheeler. There were only two passengers in the bus and luckily no one was injured.

The driver said that he was proceeding behind a school bus when suddenly a two-wheeler came in front of the bus. On seeing the rider, he applied brakes, but in the process, the bus veered to the side, and rammed into a roadside house. The driver said that he informed the KTCL officials and added that a formal accident report would be filed with the police.

An occupant of the house said that

she was talking on the phone with someone when she heard a loud sound. "When I rushed outside, I saw that a part of our house had collapsed as the KTC bus had rammed into it. Luckily, no one was injured," she said.

MARGAO: Shyam Sawant, a geologist from Directorate of Mines and Geology, lodged a complaint with Curchorem Police that prior to March 17, unknown accused person illegally extracted and transported laterite stones from Coranguinim, Sanguem, without obtaining any permission from competent authority and thereby causing loss to the State Government to the tune of Rs 50,00,000 approximately.

#### PATNA YOUTH SUCCUMBS WHILE **UNDERGOING TREATMENT IN GMC**

MARGAO: Twenty-year-old Ankit Verma from Patna expired while undergoing treatment in the Goa Medical College at Bambolim after consuming an unknown substance at Baina Beach.

#### WOMAN DIES BY SUICIDE AT AMONA

MARGAO: A 23-year-old woman from Cotta-Amona, Quepem and native of Uttar Pradesh died by suicide in rented room. The Quepem Police said they received phone call from PCR Panjim informing them that the woman died by suicide and accordingly a police team was rushed to the spot. The police conducted the Panchanama and the Sub Divisional Magistrate (SDM) was informed about the incident since the woman died within seven years of marriage.

The body has been preserved at South Goa District Hospital, Margao for medico legal formalities. Autopsy certified the cause of death as "asphyxia as a result of hanging". Quepem LPSI Rifha Barretto is conducting further investigation.

CALANGUTE: A month following a complaint by the Calangute Constituency Forum (CCF) of an alleged illegal construction on sand dunes at Candolim beach, the Goa Coastal Zone Management Authority (GCZ-MA) has scheduled a site inspection on Wednesday.

"This illegal concrete construction in CRZ 1A area at Dando, Candolim in survey no 112/19 by Viking Media and Entertainment is in clear violation of the CRZ notification and environment protection act (EPA) as it involves the destruction of existing sand dunes which are ecologically-sensitive areas protected under CRZ rules. The ongoing activity not only violations of the CRZ rules and EPA is only allowing the environment damaging activities to continue

"Such violations pose a serious threat to Goa's fragile coastal ecosystem. We urge the authority to take immediate steps to schedule hearings for the pending complaints and take them up on priority. issue stop-work orders in cases where ongoing activities are in violation of CRZ rules and EPA provisions, conduct necessary inspections and investigations to assess the extent of environmental damage caused due to these violations, and initiate appropriate legal action against violators to prevent further degradation of coastal areas," the CCF said.

What is even more alarming is the response of the Vice-Chancellor (VC) and senior officials, who have denied the existence of any evidence instead of taking decisive action. This raises suspicions about whether the VC is complicit in protecting those responsible for such unethical practices."

Kamat highlighted that when Goa Forward's student wing, led by Kritik Mandrekar, approached the VC, they were met with dismissive responses, indicating an attempt to cover up the scandal.
