Schools unlikely to open on April 1

Classes 1 to 5 will begin in June, while classes 6 to 10 and class 12 may start earlier

PANJIM: The school academic year in Goa is unlikely to begin on April 1, since the government is yet to comply with notifying an amendment to the rules under Section 29 of the Goa School Education Act.

Disposing of the writ petition filed by Manuel Sidney Antao and seven others on the matter on Monday. the High Court of Bombay at Goa noted the government's statement that a new rule would be notified this week, facilitating the start of the academic year for students in classes 1 to 5 in June, while classes 6 to 10 and class 12 would commence in the second week of April.

Advocate Vivek Rodrigues, counsel for the petitioners, confirmed that the High Court's order aligned with the statement made by Advocate General Devidas Pangam. Rodrigues emphasised that the government had failed to adhere to the mandatory requirements of Section 29 of the School Education Act, particularly regarding the notification of changes to the academic calendar.

The Court pointed out that the draft amendment required a seven-day break between the end of the previous academic year and the start of the new term, which had not been factored into the initial plan.

12 held for ransacking Mumbai show venue get bail

PTI. MUMBAI: Police on Monday arrested Shiv Sena functionary Rahul Kanal and 11 others for ransacking the venue at a Mumbai hotel where stand-up comedian Kunal Kamra made the controversial 'traitor' jibe against Maharashtra Deputy Chief Minister Eknath Shinde.

Hours later, a magistrate's court granted bail to all of them.

Meanwhile, Maharashtra Chief Minister Devendra Fadnavis on Monday sought Kunal Kamra's apology for 'insulting' Deputy CM Eknath Shinde. Slamming Kamra's remarks against Shinde, Fadnavis asserted that 'urban Naxals' and 'Left liberals' supporting such acts will be taught a lesson.

During his performance at the Habitat Comedy Club at the Unicontinental hotel in Khar area, Kamra had referred to Shinde. who heads the Shiv Sena, as a 'traitor' and went on to sing a parody of him.

Enraged over the comments, Shiv Sena workers led by Kanal ransacked the venue of Kamra's show on Sunday.

The Khar police have identified 19 people and named them in the FIR filed in connection with the incident. Also, 15 to 20 persons involved in the ransacking of the venue remain unidentified.

Centre notifies 24% hike in salaries for MPs

PTI, NEW DELHI: The Centre on Monday notified a 24% hike in the salaries of members of Parliament with effect from April 1, 2023, on the basis of the Cost Inflation Index, taking their monthly salaries to Rs 1.24 lakh besides certain allowances and perks.

A notification issued by the Ministry of Parliamentary Affairs also increased the daily allowances for sitting members and pension and additional pension for every year of service in excess of five years for former members.

However, some parliamentarians appeared dissatisfied with the salary hike.
