MARGAO: The Margao Municipal Council (MMC) is facing a severe financial setback, with the total revenue arrears for the 2023-24 fiscal year soaring to an alarming Rs 36.83 crore.

However, there seems to be no effective recovery mechanism in place to address this issue.

In addition to the mounting arrears, the civic body has uncovered 141 "illegal" establishments operating without a trade licence during the same period. While show-cause notices were issued to them, it remains unclear whether any steps have been taken to bring them under the tax net

MMC chairperson Damodar Shirodkar said the council collects a meagre Rs 1.5 to 2 lakh daily to-

Equally disconcerting is the failure of the South Goa Planning and Development Authority (SGPDA) to pay garbage fees amounting to Rs 1.12 crore, yet no action has been taken to re-

only 4,441 are currently paying. Similarly, 2,358 businesses were identified, but only 1,671 are paying trade taxes.

Voicing concerns over the lack of accountability, former MMC chairperson Savio Coutinho said that the council survives mainly on the contributions of loval taxpayers, while failing to take action against the defaulters.

"The council hardly cares about netting in the revenue from defaulters," he said, pointing out instances of corruption in the council. He alleged that public money is being misused which include Rs 65 lakh from sopo contractors, Rs 18 lakh allegedly misappropriated by a clerk and Rs 8 lakh reportedly siphoned off by e-rickshaw providers.

MMC chairperson Damodar

Shirodkar said that the civic body is actively working to recover the pending arrears.

"On a daily basis, the MMC collects Rs 1.5 to 2 lakh towards recovery of arrears, with the overall revenue collection amounting to Rs 6 to 7 lakh per day," he said.

Shirodkar mentioned that special drives were conducted in the past to recover pending arrears and that the civic body is committed to resolving the issue. He confirmed that a special re-

covery team has been set up to take up the issues of revenue losses and property assessments.

Citizens and stakeholders await further developments regarding the effective recovery of pending dues and the resolution of the systemic issues that continue to plague the civic body.

The Margao municipality has unveiled its budget for the year 2025-26, projecting revenue of Rs 94.49 crore and an expenditure of Rs 99.88 crore, resulting in a financial deficit of Rs 5.39 crore. MMC chairperson Damodar Shirodkar explained that the shortfall would be covered by boosting revenue through increased taxes and income from unlicensed establishments after a recent survey. However, opposition councillors have criticised the budget, arguing that it lacks a realistic approach.

shop owners, homeowners, and street vendors will have to bear the brunt of these hikes, which could lead to an increase in prices for essential goods and services, ultimately affecting the entire community, the councillors said.

They pointed out that the MMC failed to consult the public or properly inform them before proposing the hikes. This lack of transparency raises serious concerns about governance and accountability, the memorandum stated.

The Fatorda councillors alleged that the MMC unfairly burdens those who are already paying taxes while allowing illegal businesses to operate without consequences.

They also called on the MMC to take urgent steps to recover uncollected taxes, bring illegal businesses under the tax net, implement the audit report's recommendations, engage with the public, address inefficiencies, and ensure accountability before imposing any additional financial burdens on citizens. They also urged the completion of the pending GIS survey.

# New sewer line to bring relief to Nuvem farmers after six-year wait

MARGAO: After enduring years of sewage contamination in their fields, farmers from Nuvem and Davondem-Fatorda are finally set to get relief, with the Sewerage and Infrastructural Development Corporation of Goa Limited (SIDCGL) and Public Works Department (PWD) Division XXI preparing to commission a new sewer line from Arlem to Fatorda by Tuesday, March 25.

The previous sewer line in the area had been plagued by frequent leaks, leading to wastewater seeping into Boktim tollem in Nuvem and other agricultural zones. This contamination forced many farmers to abandon their fields.

## Govt staff on Saturday duty to get comp off

PANIIM: Government staff working on Saturday will be now given compensatory off as the North Goa Collector has withdrawn the part of the memorandum which read as 'no compensatory off shall be granted to the staff who are attending the offices on Saturday' following recommendations by the Goa Human Rights Commission (GHRC).

In the action taken report submitted to the Commission, the North Goa Collector Dr Sneha Gitte, IAS, has stated that the memorandum dated October 30, 2024 has been withdrawn to the extent that "no compensatory off shall be granted to the staff who are attending the offices on Saturday."

These conditions are that the concerned staff shall mark his/her attendance on the bio-metric machine after every two hours on Saturday, and the Mamlatdar/ Joint Mamlatdar concerned shall certify the same.

On February 26, the GHRC had asked the North Goa Collector to withdraw the part of the memorandum that "no compensatory off will be granted to the staff attending the offices on Saturday."

The two-member Commission comprising acting Chairperson Desmond D'Costa and Member Pramod Kamat in their inquiry report had stated that as per Central Civil Service Rules, a government servant other than a Gazetted Officer working on holidays, has to be given compensatory leave in lieu of duty performed on holidays, as a rule, which

generally has to be availed of within a month." The Collector had issued the Memorandum asking the staff working in the

offices of the Deputy Collector and Mamlatdar to attend offices on Saturday, for the disposal of Tenancy and Mundkar cases, in a time-bound manner, by assisting the Presiding Officers of Revenue Courts.
