GOLD JEWELLERY WORTH RS 3.78 LAKH STOLEN FROM QUEPEM SHOP

MARGAO: A jewellery shop in Quepem was burgled in broad daylight, with three unidentified women allegedly making off with gold ornaments worth approximately Rs

Pinki Mithun Pal, the owner of Bhavani Gold, located in the Dita Classic Building in Quepem, lodged a complaint with the police, stating that the incident occurred between

According to the report, three women entered the shop posing as customers. While pretending to browse jewellery, they diverted the owner's attention and stole a gold chain, gold necklace and two gold rings before fleeing. Quepem police have registered a case under Section 305 r/w 3(5) of the Bharatiya Nyaya Sanhita (BNS), and investigations are in progress.

UNIDENTIFIED MAN FOUND DECAPITATED ON VASCO RAILWAY TRACK

MARGAO: Vasco Railway Police discovered the decapitated body of an unidentified man, aged between 30 and 35 years, lying on a railway track near Tanya Hotel, Vasco. The incident came to light after a written memo was received from the Deputy Station Superintendent, who was alerted by locomotive pilot Ram Vijay Kumar. Upon reaching the scene at KM 107/700-800, authorities found the man's head severed from his body and lying between the tracks, while the rest of the body was beside the railway line. Police suspect suicide, as initial inquiries suggest the man may have deliberately come into the path of a moving train. However, an official investigation, led by Inspector Amarnath Passi, is ongoing.

36-YEAR-OLD FOUND DEAD AT KOPORMODDI-ASSOLDA, QUEPEM

MARGAO: A 36-year-old man was found dead near a water tap at Kopormoddi-Assolda, Quepem, prompting a police investigation into the cause of his death. The deceased has been identified as Ivan Shavar Periera, a resident of Kopormoddi, Assolda, originally from Sangargali, Gunji, Khanapur, Belgaum. The discovery was reported via an anonymous phone call, following which police visited the scene. A preliminary investigation was conducted, and the body was shifted to SGDH Margao for legal formalities. A post-mortem examination determined the cause of death as haemorrhagic shock due to blunt force trauma to the scalp, in a person with fatty liver disease.

TWO ARRESTED IN CONNECTION WITH CORTALIM MURDER

MARGAO: Two labourers have been arrested in connection with the murder of 20-year-old Anil Muthamaihi, a labourer from Zambol, Cortalim, originally from Putudumaha, Odisha. Santosh Indar Mallick (32) of Bahaliaguda, Odisha, and Pradhan Nalika Mandal (35) of Agilipadar, Odisha, were produced before the Judicial Magistrate First Class (JMFC) Vasco, where they were remanded in police custody for seven days. Police confirmed that Jihusaya Mandal (39), a labourer at a poultry farm in Zambol, Cortalim, who was also injured in the attack, is currently receiving treatment at Goa Medical College, Bambolim. His statement is expected to be recorded soon. Inspector Melson Colaco of Verna Police Station stated that the knife used in the crime has been recovered. According to the complaint filed by Kuni Majhi, the wife of the deceased, two unidentified assailants, aged between 29 and 30, entered the poultry farm at around 12.30 pm on March 20, 2025 and demanded free chicken. When denied, they allegedly attacked her husband, Anil Muthamajhi, and Jihusaya Mandal with a knife. Muthamajhi succumbed to his injuries, while Mandal survived with serious wounds.

BLAZES IN MARGAO: FIREFIGHTERS TACKLE TWO FIRES AND OIL SPILL

MARGAO: A fire broke out in an open space near Ravindra Bhavan, Fatorda, causing significant damage. According to Margao Fire Station Officer (FSO) Gil Souza, firefighters responded swiftly with a fire tender and managed to extin guish the blaze within an hour. The operation was carried out by Sub-Officer NV Takkar and his team. Meanwhile, another fire broke out in Gogal-Margao, where dry grass caught fire, causing damage. Leading Firefighter SP Dessai and his team used one fire tender to bring the situation under control. In a separate incident, fire personnel cleared an oil spill on a flyover bridge to prevent accidents. The operation, led by PP Dessai and his team, was completed

SCOOTER-CAR COLLISION IN MARCELA LEAVES TWO INJURED

MARGAO: A collision between a car and a scooter near Marcela market left two people injured, one seriously. According to South Goa District Police, Uttam Sawant from Valpoi-Sattari sustained minor injuries when a car veered right and crashed into an oncoming motorcycle. The rider, Sapnesh Bandekar from Adcolna-Ponda, suffered severe injuries to his right leg and other parts of his body. The car driver, identified as Preetam Jambotkar of Old Goa, originally from Sindhudurg, Maharashtra, has been booked under Sections 281, 125(a), and 125(b) of the BNS following a complaint lodged with Mardol police.

Court stays disqualification of Curti-Khandepar panch Bhika Kerkar

PONDA: The District and Sessions Court, Panjim, has stayed the disqualification of Curti-Khandepar Panchayat member Bhika Kerkar, allowing him to vote in the upcoming elections for Sarpanch and Deputy Sarpanch on March 26. The next hearing in the case is scheduled for April 11.

Kerkar, who represents Ward 11, was disqualified last week by Ponda Block Development Officer (BDO) Miksha Naik. He challenged the order in court, which on Monday granted a stay on his disqualification.

The order was stayed after Kerkar's legal team, led by Adv Nitin Sadresai, argued that the BDO's ruling did not establish clear findings of pecuniary interest in the resolutions passed at the Panchayat meeting.

AI-powered scams on the rise: Cybercrime PI issues warning

CALANGUTE: The increasing threat of cybercrime and the importance of online safety were highlighted at an awareness meeting in Calangute, where Cybercrime Police Station PI Deepak Pednekar urged people to be cautious while using social

"Be wary of over-romantic gestures or overwhelming love from people online. Take your time to get to know someone," he advised, stressing that cybercriminals use artificial intelligence (AI) to mimic voices from social media videos for extortion.

"Online frauds have entered all fields. It's a time of cybercrime pandemic. Don't think it won't happen to you. Everybody will get affected by it. Only one thing will save you - awareness," he warned. Pednekar provided tips and listed websites where victims can seek help for removing fake profiles or

The awareness session, held at St Alex Church Hall, was attended by a large number of residents. A detailed presentation showcased various types of online crimes, including fake investment scams and fraudulent online gaming apps.

Pednekar highlighted that online scams predominantly target senior citizens, while other frauds, such as sextortion rackets, primarily exploit men. He also warned against deceptive dating and matrimonial sites, as well as fraudulent shopping websites that closely resemble legitimate ones.

"Always check the URL because that cannot be faked. Amazon will be Amazon, but a fake site will have one or two additional letters," he cautioned.

He further advised people to use the security settings available on mobile phones and platforms like Google, which can help prevent hacking attempts.
