

## BUDGET WOOS INDUSTRY WITH SOPS AND SUPPORT

**PORVORIM:** Stressing on development of infrastructure to boost tourism in the State, Chief Minister **Pramod Sawant** on Wednesday presented a revenue surplus budget for the financial year 2025-26, providing incentives for tourism entrepreneurs setting up star hotels in rural Goa, incentives for the food processing industry, stress on upskilling and emphasis on education.

The big focus was on entities ready to invest over Rs 5,000 crore in the State, with the CM promising incentives such as full SGST reimbursement for five years, 50 per cent waiver on stamp duty and registrations, subsidy on supply of various amenities for five years and other benefits.

## Old Goa project: No NOC given, says Church

Archdiocese of Goa & Daman clarifies position on PRASAD scheme, says objections on Heritage Interpretation Centre and parking lot not addressed

**MARGAO:** The Archdiocese of Goa and Daman has categorically stated that it has not issued a No Objection Certificate (NOC) for the implementation and execution of the proposed PRASAD scheme at Old Goa. The project has been in the eye of a storm this week, with protestors alleging that unsupervised excavation and construction work was being carried out at the site where historical artefacts like cannon balls have been discovered. The Se Old Goa Village Panchayat also stated that it was 'clueless' about the project. Now the Church's statement has put the government project on a stickier wicket than ever before.

The Church clarification came in response to reports suggesting that the Basilica and the Archdiocese were taken into confidence while finalising plans for a facilitation centre for tourists under the PRASAD scheme.

Fr Noel D'Costa, the Financial Administrator of the Archdiocese, stated that he had represented the Church in meetings regarding the PRASAD scheme. He explained that once the proposals were

Their evaluations focused on ensuring that any interventions would not compromise the sanctity of the spaces. Based on these assessments, certain elements - such as barricades to regulate entry, Segways and e-autos for movement, water ATMs, CCTV cameras, external lighting, baggage

scanners, metal detectors, self-propelled sweeping machines, dust bins, landscaping, seating arrangements, and informational signage - were considered acceptable.

## Akshay Patra sparks 'mid-day' debate in House

**PANJIM:** The government's decision to rope in Akshay Patra Foundation to provide mid-day meals to students came in for heavy criticism in the Assembly on Wednesday, with the Opposition accusing the government of side lining self-help groups (SHGs) involved in producing the mid-day meals. Fatorda MLA Vijai Sardesai even claimed that half of the Foundation's 52 kitchens had been caught diverting food grains and mismanaging funds.

However, replying to a calling attention notice jointly tabled by opposition members over the government decision to rope in Akshay Patra Foundation, Chief Minister Pramod Sawant said that the SHGs supplying mid-day meals to schools will not be sidelined and will be protected. "No Self-Help Group (SHG) or Mahila Mandal will be discontinued from the

supply of mid-day meals to the existing school children as allotted earlier by the Directorate of Education. However, it is made clear that if the supply is not as per the standards or the Central government guidelines for National Programme of Nutritional Support to Primary Education (NP-NSPE), 2006 issued by Ministry of Education, Department of Elementary Education & Literacy, Government of India, their contract will be terminated,"

the CM said.

Sawant further informed the House that the government is yet to finalise the list of schools or number of students for the supply of mid-day meal from The Akshaya Patra Foundation, Bangalore.

In all, five - Ghanshyam Seva Samiti, Delhi; Kendriya Bhandar, Mumbai; National Federation of Farmers, Procurement, Processing & Retailing Co-operatives of India Ltd (NA-COF) New Delhi; Stri Shakti, Mumbai and The Akshaya Patra Foundation, Bangalore - submitted their bids. After thorough verification by the bid opening committee, the Akshaya Patra Foundation, Bangalore was short-listed.

Fatorda MLA said that the Akshaya Patra Foundation attempts to impose a particular diet on students. He suggested that Human Resource Department could bring together all the SHGs in the State and bid for the Central scheme.

## Insensitive, inhuman: SC stays Allahabad HC's rape ruling

**PTI, NEW DELHI:** The Supreme Court on Wednesday stayed the Allahabad High Court's recent observations on grabbing of a woman's breasts and pulling the drawstrings of her 'pyjama' not amounting to an attempt to rape and said it reflected total 'insensitivity' and 'inhuman approach'.

Taking a strong exception to the high court's observations made in its March 17 verdict, the apex court termed it a 'very serious matter'.

"In normal circumstances, we are slow in granting stay at this stage. But since the observations appearing in paragraphs 21, 24 and 26 are totally unknown to the cannons of law and depict total insensitive and inhuman approach, we are inclined to stay the said observations," a bench of Justices B R Gavai and Augustine George Masih said.
