MARGAO: Despite repeated demands to address the ongoing pollution, Colva Creek at the iconic Colva Beach remains choked with black sludge, sewage, and garbage, raising serious concerns among locals and tourists.

This unsightly pollution is tarnishing the beauty of the world-famous beach, while also posing a significant health hazard to locals and tourists.

Almeida also criticised the authorities for focusing on infrastructure development instead of tackling the ongoing environmental issues. She pointed out that despite the problem continues to multiple show-cause no-

"The creek is completely polluted, and those responsible seem indifferent to their duties," she said.

Simao Rodrigues, another resident of Colva, expressed his disappointment with the authorities' handling of the situation.

"We have lost the beauty of Colva Beach. The authorities are failing to clean the creek regularly, even though they are aware of the pollution," he said. Rodrigues added that local businesses are unfairly blamed for the contamina-

Locals say the lack of proper management has led to severe air pollution and an increasingly unpleasant environment, particularly around the popular beach.

reported that the waste, left at the site for long hours before transportation, emits a strong stench, making the area unbearable to even walk past. A recent inspection revealed that both dry and wet waste are dumped together before being transported to the treatment plant.

According to the site supervisor, the waste collected from shacks and other establishments is first brought to this location before being segregated at the plant. However, residents argue that the system is inefficient and contributes to environmental degradation. Colva Sarpanch Suzie Fernandes emphasised the need for a new collection site. She clarified that while the Tourism Department regu-

BETUL BLAST: Firm booked for illegal gunpowder storage

MARGAO: The Cuncolim police have registered an offence against the management and staff of Hughes Precision Manufacturing Pvt. Ltd., Verna Industrial Estate, for allegedly violating safety regulations regarding the storage and transportation of propellant (gunpowder), leading to the blast and fire accident at Magazine No.1 of the warehouse last

Thursday. The police have booked the accused under Sections 223, 288, 326(g), and 125 of the Bharatiya Nyaya Sanhita (BNS), as well as Sections 5, 6 read with 9B and 9C of the Explosives Act, 1884.

According to Cuncolim police, the case is based on a complaint filed by Deputy Collector and Sub-Divisional Officer (SDO) Manohar L. Karekar on March 20. The complaint alleges that the company failed to adhere to the safety guidelines and standing instructions issued during the licensing process for handling explosives.

Further investigations revealed that, on March 22, the company illegally stored 11,000 kg of

11,000 kg of gunpowder allegedly stored without licence in a separate section of warehouse; company risked lives of police and firemen attending to the blast site by not informing them of the stockpile

gunpowder in Magazine No.2 without obtaining the necessary licence from the Petroleum and Explosives Safety Organisation (PESO). This was in violation of Licence 34/01/2024/EXP/ MAG/M.0.4555, dated November 12, 2024, issued by the District Magistrate, South Goa.

Authorities have accused the company of failing to inform police, fire officials, and other emergency responders about the additional stock of explosives in Magazine No.2 during the rescue operation at Magazine No.1. The negligence allegedly endangered human lives and property.

Salcete Meanwhile, Mamlatdar has sealed the godown used to store gunpowder, and Cuncolim police have sealed the exhibits at the scene of the explosion.

New Mandovi Bridge closed for traffic from today; to be opened on April 5

MARGAO: The New Mandovi Bridge will be closed to all vehicular traffic from March 27 to April 5 to facilitate road resurfacing, safety upgrades, and painting work, the Public Works Department (PWD) has announced.

The PWD Executive Engineer, Works Division-VII (NH), Panjim, who oversees NH-66 from Patradevi to Zuari Bridge, issued the closure order to ensure smooth execution of the maintenance work.

During this period, traffic will be diverted as follows: Vehicles up to 12 tons GVW will be routed via the Old Mandovi Bridge. Vehicles exceeding 12 tons GVW will be redirected to the Atal Setu Bridge.

Commuters are advised to plan their travel accordingly to avoid inconvenience, and four-wheelers are urged to use the Atal Setu bridge.
