

# Cong seeks law for SC, ST & OBC quota in private, non-minority educational institutions

PTI, NEW DELHI: The Congress on Monday demanded that the government bring in a legislation for SC, ST and OBC quota in private, non-minority educational institutions in the country.

In a statement, Congress general secretary, communications, Jairam Ramesh noted that the Parliamentary Standing Committee on Education, Women, Children, Youth, and Sports had recommended a new legislation to implement Article 15(5).

Article 15(5) allows the state to make special provisions by law for the advancement of socially

and educationally backward classes, Scheduled Castes, and Scheduled Tribes, including reservation in educational institutions, both public and private, except for minority educational institutions.

Ramesh said the Congress had during the last Lok Sabha polls committed itself to bringing legislation to implement Article 15(5) of the Constitution in private educational institutions.

"In its 364th Report on the Demand for Grants for the Department of Higher Education, the Parliamentary Standing Committee

on Education, Women, Children, Youth, and Sports also recommended a new legislation to implement Article 15(5) as well. The Indian National Congress reiterates this demand," Ramesh said.

The Constitution (Ninety-third Amendment) Act, 2005 took effect from January 20, 2006 and this amendment introduced Article 15(5) in the Constitution.

"Nothing in this article or sub-clause (g) of clause (1) of Article 19 shall prevent any special provision, by law, for the advancement of any socially and educationally backward classes

of citizens or for the Scheduled Castes or the Scheduled Tribes insofar as such special provisions relate to their admission to educational institutions, including private educational institutions, whether aided or unaided by the State, other than the minority educational institutions referred to in clause (1) of Article 30," it reads.

Explaining the chronology of legislation to implement Article 15 (5), Ramesh said the Central Educational Institutions (Reservations in Admission) Act, 2006 was passed in Parliament and reservations for scheduled castes,

scheduled tribes and socially and educationally backward classes of citizens in central educational institutions introduced with effect from January 3, 2007.

Citing the case of Ashoka Kumar Thakur versus Union of India on April 10, 2008, he said by a 2-0 margin Article 15(5) is held Constitutionally valid only for state-run and state-aided institutions and reservations in private unaided institutions left open to be decided in the appropriate course.

In the IMA versus Union of India May 12, 2011, he

said, by 2-0 margin, Article 15 (5) is upheld for private unaided non-minority educational institutions.

Citing another case, Ramesh said, "Prmati Educational and Cultural Trust versus Union of India Jan 29, 2014. By 5-0 margin Article 15(5) is, for the first time, upheld as it is explicitly.

"This means reservations for scheduled castes, scheduled tribes and socially and educationally backward classes of citizens in private educational institutions is also constitutionally permissible," he added.

## Gunshots fired in Kathua during search for terrorists, night cordon laid

PTI, JAMMU: A police team came under fire from terrorists in a combing operation in Kathua district Monday night, sources said. The operation was underway in the Panjirthi area of the Ramkote belt. In the wake of the violent encounter, a night cordon has been laid to ensure that the three terrorists trapped in the forest do not escape, sources said.

Earlier in the day, Deputy Inspector General Shiv Kumar Sharma said the operation will continue until the last terrorist is neutralised, as he urged the people living near the border to report any suspicious activities.

"The operation is ongoing, and as long as there is even one terrorist left, the Jammu and Kashmir Police

will persevere in its mission. Our force is dedicated to eradicating terrorism and ensuring the safety of Jammu and Kashmir," Sharma told reporters in Reasi.

Security forces have intensified their search for the three, bolstered by aerial surveillance and sniffer dogs. Six people were detained after receiving fresh reports of suspected movement involving three individuals believed to be terrorists who had escaped after an encounter in Kathua, officials said.

In a confrontation with the terrorists last Thursday, two terrorists and four policemen were killed, while three others, including a deputy superintendent of police, were injured.

## Eight months on, landslide-hit Mundakkai, Chooralmala remain ghost towns

PTI, WAYANAD: Suhara Joseph, 56, was taking a respite from the scorching heat under the shade of a shop in Chooralmala in Wayanad district, blankly looking across the Bailey bridge at the rubble where her house once stood.

She had just returned from the spot where her home had been completely wiped away, with not even a trace left, as huge boulders swept it away on July 30 last year in the worst landslide Kerala has ever witnessed.

She reluctantly returned to the shade, as she was alone and afraid of fainting in the scorching sun.

"I am least concerned about the house and the properties we lost, but I can't get over the fact that the people who were so close to us are all gone," Suhara told PTI, choking with emotion as tears rolled down her cheeks.

Suhara survived because she was at a hospital for her husband's treatment. All the neighbours who had visited them at the hospital the previous night perished.

Eight months after the disaster, the Mundakkai and Chooralmala regions resemble a ghost town, with an eerie silence surrounding them.

Once a bustling hub of tourist activity, this beautiful valley in Meppadi, Wayanad, is now devoid of residents or visiting tourists.

## SC-appointed task force starts work, to seek views on mental health issues of students

PTI, NEW DELHI: The Supreme Court-appointed National Task Force (NTF) has started its functioning and will seek public opinion in preparing its reports on tackling mental health issues in educational institutions across the country.

In a landmark judgment on March 24, a bench headed by Justice JB Pardiwala took note of the recurring cases of student suicides in higher educational institutions and formed the NTF to address the mental health concerns of students and prevent such incidents.

The top court had also directed the Delhi Police to register an FIR on the complaints of the family members of two students

who died by suicide while studying at the Indian Institute of Technology (IIT), Delhi, in 2023.

The NTF, headed by Justice S Ravindra Bhat, a former SC judge, comprises a distinguished panel of experts, including Dr. Alok Sarin, Prof. Mary E. John, Arman Ali, Prof. Rajendra Kachroo, Dr. Aqsa Shaikh, Dr. Seema Mehrotra, Prof. Virginius Xaxa, Dr. Nidhi Sabharwal, and Ms. Aparna Bhat.

The Task Force also includes ex-officio members from key government departments, including the Department of Higher Education, the Ministry of Women and Child Development.

In its first meeting held on March 29, 2025, the Task Force outlined its plan to explore the root causes of suicides in higher education institutions and develop a comprehensive report with actionable recommendations.

The NTF aims to assess current policies, review relevant laws, and consult

with various stakeholders to create an inclusive approach to improving student welfare.

The Task Force has been given a timeline of four months to submit an interim report and eight months for the final report.

The process will involve public consultations, interactions with educational institutions, and discussions with mental health professionals, students, and parents.

The Task Force is also set to launch a website and a social media handle to encourage public engagement and receive suggestions.
