PANJIM: The government on Thursday directed the Electricity Department to ensure that cutting, dismantling or disconnecting of cables providing internet services or television cable services was kept in abeyance till further orders.

The order can be seen as a rejection of the activism of department employee Kashinath Shetye, who had led a team on a cable-cutting spree in end February, sparking an internet blackout across Goa and leaving important institutions like banks and hospitals crippled.

Shetye had said of his drive: "I will not succumb to pressure from anyone. Either the cables have to go,

Trump buffets India with steep 27% tariffs; Delhi is studying 'implications'

The US imposed a steep 27% tariff on all goods, barring pharmaceuticals, semiconductors, energy and certain minerals not available in

dia, calling the country the "worst offenders" of unfair trade practices.

Export of products such as shrimp, carpet, medical devices and gold jewellery to the US will be impacted. On the other hand, exports of electronics, textiles, and pharma will get an edge over its competitor countries.

Exemption of energy from the tariffs would also mean that India can continue to export fuels like gasoil and gasoline

The goods that were exempted from the tariffs made up for just over 25 per cent of the to the US.

The Indian government reacted cautiously, saying it is "carefully examining the implications" of the announcements and will also study opportunities that may arise due to this new development in the US trade policy.

Supreme Court refuses to relax ban on firecrackers in Delhi-NCR Says pollution affects those working on the streets the most

Retirement fund body eases claim process

PTI, NEW DELHI: Retirement fund body Employees' Provident Fund Organisation (EPFO) said applicants seeking withdrawal from provident approve the bank account funds online do not have to upload the image of a cancelled cheque and their bank accounts need not be verified by employers.

The move is expected to fast-track the claim settlement process for nearly eight crore members and ensure ease of doing business for employers.

At present, members of EPFO, while applying for withdrawal of funds from PF accounts online, need to upload an image of cheque

leaf or attested photocopy of the passbook of the bank account seeded with the UAN or PF number. The emplovers are also required to details of the applicant.
