# HC tells govt to list steps taken to rescue children forced to beg at traffic signals

PANJIM: The High Court of Bombay at Goa has directed the State government to file an affidavit within three weeks detailing its plan to rescue children forced to beg at traffic signals and implement child protection measures under the Juvenile Justice Act and the Bharat Nyaya Sanhita,

"Depending on his suggestions, the Court may ask the government to implement them, if found feasible," the Court observed.

Directing the State government to submit its affidavit, the Court noted that merely registering offences under the Goa Prevention of Begging Act, 1972, and the Juvenile Justice (Care and Protection of Children) Act. 2015, is not a sufficient solution.

"It is necessary to address the root cause of this menace. The focus should be on prohibiting begging rather than merely prosecuting parents. A wholesome solution is required to resolve the issue," the Court

## High Court orders removal of encroachments at Mala-Panjim

Directs restoration of govt land to original state in 15 days

PANJIM: The High Court of Bombay at Goa has ordered the removal of encroachments on government land belonging to the North Goa Planning and Development Authority (NGPDA) at Mala, Panjim, and directed authorities to restore the land to its original condition

within 15 days. On March 26, 2025, the Deputy Collector and Sub-Divisional Officer (SDO) of Tiswadi issued an order to Alex Fernandes and Paulo Fernandes, both residents near Mala Lake, instructing them to remove or demolish the illegal structures they had erected on a 244-square-metre area of government land. The order also mandated that the

# Labourer gets life sentence for murder

MARGAO: The Principal District and Sessions Court sentenced a 43-year-old labourer to life imprisonment for murdering a fellow labourer by attacking him with an axe. The court also directed the convict to pay a fine of Rs 1 lakh, of which Rs 75,000 must be given to the victim's family.

According to the Maina Curtorim Police, Vivek Dev Singh, from Jharkhand, allegedly murdered a fellow labourer following a quarrel over a minor issue. The fatal attack took place inside their rented room in a house at Colleadongor, Raia.

The police stated that the house owner of the rented room had lodged

a complaint after witnessing the brutal assault. The accused had struck Mukesh Singh on the head with an axe, inflicting grievous injuries that resulted in instant death. Following the incident, the police shifted the body to South Goa District Hospital

lice recovered the murder weapon—the axe used in the crime. Public Prosecutor VG Costa, arguing before the court, presented evidence that Vivek Dev Singh had attacked Mukesh Singh while he was asleep, leading to his brutal and cold-blooded murder.

PANJIM: In a contempt petition concerning the illegal sand extraction activities in Goa, the High Court has directed the North Goa Collector to issue a show cause notice to the Bicholim Mamlatdar.

The notice demands an explanation from the Mamlatdar as to why he did not take timely action based on a report submitted by the Sankhali Talathi regarding the rampant illegal sand extraction at Virdi, located along the river Valvanti.

The case highlights concern over illegal sand mining in the region, which has been a subject of growing scrutiny due to environmental damage and regulatory lapses. The court's directive is a significant step in addressing the issue, and the next hearing on the matter has been scheduled for April 29.

This development comes as part of ongoing efforts by the judiciary to ensure stricter enforcement of laws surrounding environmental protection and prevent illegal mining activities that have detrimental impacts on Goa's natural resources.

## **'Lifting of Muthalik** ban spells trouble for Goa tourism'

CALANGUTE: Former Calangute MLA Agnelo Fernandes has expressed serious concerns over the lifting of the ban on Ram Sena leader Pramod Muthalik, warning that the move could have disastrous consequences for Goa's tour-

ism industry. Goa is no longer the peaceful destination it once was, and this is deterring visitors. Speaking to reporters, he stated:

"Tourism is almost dead in Goa. Our hotels are almost empty. After Covid, a lot of tourists were coming to Goa, but now there are many other options, so most people go elsewhere. Peaceful atmosphere is no longer there in Goa."

He further alleged that the current political climate in Goa is contributing to this decline, saying:

"The political climate in Goa is also vitiated. There is polarisation. Two weeks ago, the government lifted the ban on Muthalik. When Parrikar was CM, whatever his faults, he was secular and peaceful. That is why he stopped Muthalik. This government is not stopping

him. There is a polarisation happening, and with this, our tourism will die."

Fernandes accused the BJP-led government of using polarisation as a political tool to secure electoral gains, warning that this approach would have longterm consequences for the tourism industry.

"Just because elections Fernandes claimed that are coming, they're trying to polarise society. But it's bad for the long-term and will affect the tourism industry," he said. Pramod Muthalik, the

> leader of the Ram Sena, gained notoriety in 2009 after members of his organisation attacked a pub in Mangalore, assaulting women and claiming that their presence in such establishments was against Indian culture. In August 2014, Muthalik and his associates were banned from entering Goa amid concerns that their brand of "moral policing" could disrupt the state's tourism-dependent economy.

In 2015, the Supreme Court dismissed a petition by Muthalik seeking permission to enter Goa, ruling that he and his followers engaged in "moral policing."

Goa Pradesh Mahila Congress President, Dr Pratik-

sha Khalap, criticised the government for failing to prioritise women's welfare. "Women make up more

than 50% of the population, yet we are used only as a vote bank. The government has made no provisions for women, and the state government remains indifferent to our welfare," she said.

Dr Khalap also highlighted the rising number of crimes against women, contradicting the Chief Minister's claims that Goa is the safest state for women. "Last year, 367 cases

of crimes against women were reported. Since the beginning of 2025, 63 cases have already been registered. Meanwhile, the Chief Minister claims Goa is a safe state for women—perhaps he should inspect the dark streets without functioning lights or CCTV cameras at

She also slammed the Goa Women's Commission Chairperson for stating that women should not expect much from the government.

"If such statements are made, then the Chief Minister and all those appointed to these commissions should resign. There is a complete failure of law and order, and we will continue to raise our voices against

injustices," she declared. Emphasising the need for women's participation in governance, Dr Khalap added, "For better administration and governance, we need more women in the Parliament and the State Assembly. The Women's Reservation Bill must be implemented without delay."
