He also said Waqf owns the largest chunk of properties in the country, leaving aside those owned by Defence and Railways.

"It has been said here that Muslims will be harmed by the step we are taking. Many people said this is unconstitutional, illegal and the right of Muslims is being snatched away... Very categorically, I want to reject all these allegations," Rijiju said. Speaking on 'Wagf by User', the Minority Affairs Minister said properties already registered with proper documentation will not be dealt with retrospectively. "In Wagf By User, the properties already registered and cases that have already been settled, we won't go prospectively and deal with that. It would be with a prospective effect.

"However, if there is any disputed land or any matter that is sub judice, then we cannot do away with the right of the courts. So all the Wagf properties which are registered with proper documentation, they will remain so," Rijiju said. He stressed that the entire exercise was aimed at bringing in the three pillars of transparency, accountability and efficiency.

"We are not here to damage anybody's religious affiliation," Rijiju said.

Citing a previous court judgment, the minister said it makes it clear that Waqf is a statutory body and not a representative body of Muslims.

"In the amendment, we have made it clear that any person practising Islam for more than five years can dedicate properties to Wagf. There is no iota of doubt in who can create Waqf," he said.

"The new provisions that we have brought in, is that all the recognised sects of Muslims will constitute the Wagf Board -- there will be Shias, there will be Sunnis and other backward classes will also be there in the Waqf Board as members so that the interests of all would be taken into account and I don't think there should be any opposition to that. We are making it so inclusive," Rijiju informed. He further said out of 22 members in the Central Wagf Council, not more than four will be non-Muslims including ex-officio members, besides three members of Parliament who can be of any religion. The Council must include two women members, he added.

The question of the majority being non-Muslims does not arise, he reiterated.

"If we develop a Waqf property properly in the next few years, Muslims will prosper," said the minister, appealing to the members in the Upper House to engage in a productive discussion and extend support to the bill. Rijiju said 31,999 cases are pending in the Waqf Tribunal

and more than 14,000 litigants are Muslims, adding that the right to appeal has also been added.

"We have not done this for any personal gain," said the minister, as he emphasised that the intent behind the proposed legislation was to put an end to the malpractices of people grabbing other people's property.

"We should not say anything which creates a furore or gives rise to a conflict," Rijiju said, urging members to share perspectives on the bill in a manner that enhances the quality of the debate.

He expressed the hope that all members would extend support to the proposed legislation.

RETIREMENT FUND BODY EASES CLAIM PROCESS

These measures will significantly streamline the process of claim settlement and reduce grievances related to claim rejections, it stated.

These requirements were initially relaxed on a pilot basis for certain KYC-updated members. Since the pilot launch on May 28, 2024, the move has already benefited 1.7 crore EPF members. Following the successful pilot, EPFO has now extended this relaxation to all members, the ministry said. Since the bank account is already verified along with the EPF members' details at the time of seeding of bank accounts with the UAN, this additional documentation is no longer necessary, it said, adding, this will eliminate the possibility of claim rejections due to poor-quality/unreadable uploads and reduce associated grievances. During the financial year 2024-25, 1.3 crore members submitted requests for seeding their bank accounts and the requests after due matching with the respective bank/NPCI are to be approved by the employer through DSC/E-Sign. It is seen that around 36,000 requests for seeding of bank accounts are being raised by the members on a daily basis and the banks take an average of 3 days to complete the verification However, after the bank account verification, the average time taken by the employer to approve the process is about 13 days resulting in piling up of workload at the level of the employer and consequent delay in the seeding of bank account for the member.

VASCO: A motorcyclist lost his life. and another rider sustained injuries in a collision between two bikes near Birla Cross Junction, Cortalim, on Tuesday night.

According to the Verna police, the accident occurred when Simon Leema, a native of Honnavar, Uttar Kannada, Karnataka, was riding rashly and negligently. Upon reaching the traffic signal, he crossed the highway towards Pirni without proper caution, leading to a collision with another two-wheeler and a secondary impact with a car.

In the crash, Avinash Ponj, a resident of Vallant, Bardez, sustained grievous injuries, while Simon Leema was also critically injured. The car driver, Marc Joaquim Fernandes, escaped unhurt. Leema later succumbed to his in-

juries. The Verna police conducted a panchanama and sent the body for a post-mortem examination, which confirmed the cause of death as "damage to the chest, abdomen, and cervical spine consequent to blunt force impact, resulting in vital organ damage." Following the post-mortem, po-

lice handed over the body to the deceased's relatives for last rites.

PANJIM: The leopard which was moving around the Harmal Nanoskar Wada for many days was finally trapped by the Forest Department in the early hours of Thursday.

The leopard, whose presence had created a panic in the village after it killed a pet dog was caught at around 3 am and is currently under the care of wildlife officials.

According to Forest Department officials, the big cat is approximately one-year-old and will undergo a medical examination before being released. Once the necessary clearance is obtained from the Chief Wildlife Warden, the animal will be relocated to a sanctuary.

This marks the second leopard rescue in the state this year. In January, a 14-month-old female leopard was successfully rescued by the Forest Department's wildlife rescue team after it strayed into a residential area in Borim. Officials had then stated that the big cat had ventured into human habitation in search of food.

The Forest Department continues to monitor leopard activity in the region to ensure both wildlife conservation and human safety.

Leopards and bison often end up into residential areas in Pernem taluka as their habitat has been dwindling. "Of late, hills and forests in the taluka are being deliberately torched by miscreants and land is sold to outsiders for a price. Run out of habitat and food, the wild animals often end up in villages," said a cashew farmer.
