# China slaps 34 % tariff on US goods in tit-for-tat move

PTI, BEIJING: China on Friday slapped a 34 per cent additional tariff on imports from the US in a tit-fortat response to President Donald Trump's move to impose a similar levy on Chinese goods. Beijing also announced export controls on certain rare earth metals, aiming to hit American defence computer and smartphone industries.

The tariffs on all products imported from the US will be imposed from April 10, the Customs Tariff Commission of the State Council announced Friday.
