682 INDIANS DEPORTED FROM US SINCE JANUARY: MEA

"The vast majority of these deportees had attempted to enter the US illegally, but were apprehended at the US border itself and thereafter deported to India after due verification. As such, these deportations may not have any impact on the overall remittance flows to India," he said.

According to the minister, the government continues to be engaged with the US to promote mutually advantageous and secure mobility frameworks for streamlining the movement of students and professionals and facilitating short-term tourist and business travel.

The issues of illegal immigration and human trafficking are also being addressed by taking strong action against bad actors, criminal facilitators, and illegal immigration networks, he said.

"The Government of India continues to work in close coordination with the US government on all instances of deportation of individuals who were found to have illegally entered the US, or have overstayed their visa validity, or have been found living in the US without any documentation or have criminal convictions against them.

"The list of persons identified for deportation by the US side is closely scrutinised and verified by the concerned agencies of the Government of India. Only those persons who have been verified to be Indian nationals are accepted to be deported to India," he said.

In response to a separate question on the issue, the minister noted that government does not maintain data on the number of people who may have entered the US via illegal means and routes.

CONGRESS, AIMIM LEADERS MOVE SC AGAINST WAQF BILL

Jawed, a Lok Sabha MP from Kishanganj in Bihar, was a member of the Joint Parliamentary Committee on the bill and has alleged in his plea that the bill "introduces restrictions on the creation of Waqfs based on the duration of one's religious practice".

"Such a limitation is unfounded in Islamic law, custom or precedent and infringes upon the fundamental right to profess and practice religion under Article 25," it said.

In his separate plea, Owaisi said the bill takes away from Wagfs various protections which were accorded to Wagfs and Hindu, Jain, and Sikh religious and charitable endow-

Owaisi's plea, filed by advocate Lzafeer Ahmad, said, "This diminishing of the protection given to Waqfs while retaining them for religious and charitable endowments of other religions constitutes hostile discrimination against Muslims and is violative of Articles 14 and 15 of the Constitution, which prohibit discrimination on the grounds of religion."

The plea argued the amendments "irreversibly dilute" the statutory protections afforded to Waqfs and their regulatory framework while giving undue advantage to other stakeholders and interest groups, undermining years of progress and pushing back Waqf management by several

"Appointing non-Muslims on the Central Waqf Council and the State Waqf Boards disturbs this delicate constitutional balance and tilts it to the detriment of the right of Muslims as a religious group to remain in control of their Waqf properties," Owaisi said.

persons who converted to Islam recently and wished to dedicate property for religious or charitable purposes, violating Article 15 of the Constitution.

Article 15 deals with prohibition of discrimination on grounds of religion, race, caste, sex or place of birth.

Jawed's plea similarly argued the amendment to include non-Muslims in the administrative composition of the Waqf Board and the Central Waqf Council was an "unwarranted interference" in religious governance unlike Hindu religious endowments, which were exclusively managed by Hindus under various state enactments.

"This selective intervention, without imposing similar conditions on other religious institutions, is an arbitrary classification and violates Articles 14 and 15," it said

The plea said the enhanced role of state authorities in Waqf administration impinged on the rights of the community and the bill shifted the key administrative functions, such as the power to determine the nature of Wagf properties, from the Waqf Board to the district collector.

"This transfer of control from religious institutions to government officials dilutes the autonomy of Waqf management and contravenes Article 26(d)," it said.

The proposed law, the plea said, also modified the process of dispute resolution by altering the composition and powers of the Waqf tribunals.

"It reduces representation of individuals with expertise in Islamic law, influencing the adjudication of Waqf-related disputes," it said. The plea said the change disproportionately affected willingness to resort to legal recourse through specialised tribunals, in contrast to the robust protections provided to other religious institutions under their respective endowment laws.

"These amendments undermine property rights protected under Article 300A," it alleged.

FOUR SPACE TOURISTS RETURN TO EARTH AFTER PRIVATE FLIGHT OVER POLES

The Chinese-born Wang, now a citizen of Malta, invited Norwegian filmmaker Jannicke Mikkelsen, German robotics researcher Rabea Rogge and Australian polar guide Eric Philips, all of whom shared stunning vistas during their voyage.

"It is so epic because it is another kind of desert, so it iust goes on and on and on all the way," Rogge said in a video posted by Wang on X while gazing down from orbit. Mikkelsen packed the capsule with camera equipment and spent much of her time behind the lens.

All four suffered from space motion sickness after reaching orbit, according to Wang. But by the time they woke up on day two, they felt fine and cranked open the window cover right above the South Pole, he said via X.

Besides documenting the poles from 270 miles (430 km) up, Wang and his crew took the first medical X-rays in space as part of a test and conducted two dozen other science experiments. They named their trip Fram2 after the Norwegian sailing ship that carried explorers to the poles more than a century ago. A bit of the original ship's wooden deck accompanied the crew to space.

Their medical tests continued at splashdown. All four got out of the capsule on their own, heaving bags of equipment so researchers could see how steady returning space crews are on their feet. They pumped their fists in jubilation.

SpaceX said its decision to switch splashdown sites from Florida beginning with this flight was based on safety. The company said Pacific splashdowns will ensure that any surviving pieces of the trunk — jettisoned near flight's end — falls into the ocean.

The last people to return from space to the Pacific were the three NASA astronauts assigned to the 1975 Apollo-Soyuz mission.

GOVT BODIES UNDER HC SCRUTINY OVER POLLUTION IN SALPEM LAKE

These promises came only after the court's intervention forced officials to acknowledge years of inaction.

As the April 15 hearing approaches, the MMC is preparing to file an affidavit on the steps initiated by the civic body against the 317 establishments. SIDCGL has issued a work order dated March 17 for trenchless laying and commissioning of a sewerage network and pumping station at the Fatorda market, with a 120-day completion timeline.

Meanwhile, residential communities in Malbhat, Calconda and surrounding areas find themselves caught in an impossible situation. With no underground sewerage infrastructure available, 154 households now face potential penalties for practices that developed in the absence of proper public facilities. An additional 163 commercial establishments have also been identified for discharging waste into storm drains that feed the lake.

The vacuum technology solution proposed by the PWD years ago for densely populated areas remains unimplemented, highlighting how inter-agency coordination failures have exacerbated the environmental damage. This technology, which would allow sewerage installation without extensive excavation, was shelved despite expert recommendations.

Compounding concerns about infrastructure quality, residents of Nagmodem recently protested when they noticed that land excavated near the western bypass underpass to lay a sewage chamber was sinking. When asked about it by the media, a senior SIDCGL official downplayed the issue, claiming it was merely 'settlement of soft soil' rather than actual sinking. While insisting that rectification work would be completed soon, the official acknowledged the need for continued monitoring of the site.

STOP 'DUKAANDARI', START INNOVATING: **GOYAL TO START-UPS**

While acknowledging India's position as the world's third-largest start-up ecosystem, Goyal stressed that scale alone wasn't enough. "We are very proud of what India has done but are we the best in the world as yet? Not yet."

He pointed to the lack of deep-tech startups in India as a major concern. "Only 1,000 startups in India's deep-tech space is a disturbing situation," he remarked, adding that the country needs to focus on innovation beyond e-commerce and services.

"Dukaandari ka hi kaam karna hai ya one of scale, to make a mark in the world?" He questioned, urging entrepreneurs to think beyond short-term business models and work toward global technological leadership.
