

Illegal IMFL manufacturing unit busted in Mira Road; five held

THANE: Maharashtra Excise department officials busted a racket involved in the illegal manufacture and sale of Indian Made Foreign Liquor (IMFL) in Thane district and arrested five individuals. Officials seized the illicit liquor mimicking prominent brands valued at Rs 47 lakh from the residence of the suspected mastermind who is on the run. Excise Superintendent for Thane, Pravin Tambe, on Saturday, stated that officials raided a lane near a hotel in Mira Road area on April 1 and apprehended one Ramkesh Sitaram Gupta. Illicit liquor with an estimated value of Rs 1,25,470 was seized from him. Following interrogation, officials arrested a tempo driver and the supplier on Friday. The seized liquor included popular IMFL brands like Royal Challenge and DSP Black Whiskey, the official said.

Minor gang-raped in MP's Sidhi district; five arrested

SIDHI (MP): Police have arrested five persons in connection with the alleged gang rape of a minor and filming of the sexual assault in Madhya Pradesh's Sidhi district, an official said on Saturday. While four of the accused forced themselves on the girl, the fifth person was present at the scene during the crime, police said. The minor was targeted in July last year, and the survivor and her mother approached the Sihawal police post under Amliya police station on Thursday, the official said. Superintendent of Police Ravindra Verma said that the mother had asked two of her acquaintances to drop the girl off at her home on a motorcycle. However, they took the minor to a house located in village Bamuri, where four men allegedly raped her. Another person was present there, said the official, citing the FIR. Police registered a case under the Bharatiya Nyaya Sanhita and Protection of Children from Sexual Offences (POCSO) Act and launched a probe, he said.

IMD predicts heatwave conditions in Delhi over next six days

NEW DELHI: Delhi recorded a maximum temperature of 35.7 degrees Celsius on Saturday, which was 1.7 notch above the seasonal average, according to the India Meteorological Department (IMD). The minimum temperature was recorded at 19.5 degrees Celsius, which was 0.7 notch above average. The humidity levels at 8.30 am stood at 47 per cent. The IMD has forecast mainly clear sky with heat wave for Sunday. The maximum and minimum temperatures are expected to be around 39 degrees Celsius and 20 degrees Celsius, respectively. The weather department on Friday forecast heatwave conditions in Delhi over the next six days, with the mercury likely to soar to 42 degrees Celsius.

ATM with Rs 7.5 lakh stolen in Nagpur

NAGPUR: An automated teller machine (ATM) with Rs 7.5 lakh cash was stolen in Nagpur city, police said on Saturday. The incident took place at the Mankapur Square in the city early on Friday. Three persons, their faces covered, arrived at the ATM of the Punjab National Bank and sprayed black paint on the CCTV camera before snapping network cables, an official said. The thieves, perhaps armed with powerful tools, dislodged the machine and took it away. It had Rs 7.5 lakh cash, said the official from Mankapur police station. A case has been registered and efforts are being made to track down the thieves, he added.

Siblings among three children of family drown in Rajasthan

JAIPUR: Two siblings and their cousin sister drowned in a pond in Rajasthan's Banswara district, police said Saturday. Yuvraj (4), his sister Jinal (6) along with their parents had gone to their maternal uncle's house to attend a wedding. On Friday morning the parents went back to their home in Khunti Narji village, leaving the children at their maternal uncle's house in Khunta Galia village. Sallopat SHO Devi Lal Khatik said. The same afternoon, Yuvraj and Jinal went to the pond with their maternal uncle's daughter Meenakshi (9) to graze cattle. Yuvraj went to the pond to drink water when his foot slipped and he fell inside. Seeing him drowning, Jinal also jumped into the pond. Later, Meenakshi also jumped into the water to rescue them but all three drowned, he said. When the children did not return for a long time, the family went out looking for them and found their bodies floating in the pond, the police said.

Pakistan intruder shot dead along int'l border in Jammu

Given Islamic burial after Rangers refused to take body

PTI, JAMMU: A Pakistani infiltrator was shot dead by BSF troops along the International Border here, officials said on Saturday, as authorities ensured his proper Islamic burial after the Pakistan Rangers refused to accept his body at a flag meeting. The unidentified Pakistani man, aged around 35 years, was killed when the Border Security Force (BSF) personnel opened fire after noticing suspicious movements near a border outpost in the Abdullina area in the R S Pura sector late on Friday night, officials said.

BSF troops, who are on high alert in view of Union Home Minister Amit Shah's scheduled three-day visit to Jammu and Kashmir from Sunday, lodged a strong

protest with the Pakistan Rangers following the incident, the officials said.

"On the intervening night of April 4 and April 5, the alert BSF troops saw suspicious movements in the Jammu border area and an intruder was seen crossing the IB," a

BSF spokesperson said. He said the intruder was challenged by the troops but he paid no heed and kept moving. "Sensing a threat, the BSF troops neutralised the intruder. The identity and motive of the intruder are being

ascertained," he added. The spokesperson said a strong protest has been lodged with the BSF's Pakistani counterpart. According to sources, the BSF informed the police department, which sent the body for post-mortem and other legal formalities. Later, around 1:10 pm, the BSF conducted a short-duration flag meeting with the Pakistan Rangers near the site of the incident, the sources said. A strong protest was lodged with the Pakistani side over the infiltration attempt. The Pakistani side refused to accept the body of the intruder during the meeting, the sources said, adding that the deceased was aged around 35 years and was not found in possession of any incriminating material.

5 killed, 11 injured after mini bus rams into parked truck in K'taka

PTI, KALABURAGI (KARNATAKA): Five people, including a 13-year-old girl, died and 11 others were injured after a mini bus they were travelling in allegedly rammed into a parked truck near Nelogi Cross in Jewargi taluk of this district in the wee hours of Saturday, police said.

The passengers, all residents of Bagalkote, were en route a dargah in the Kalaburagi district when the accident occurred at around 3.30 AM, they said. According to the police, the truck whose tyre got punctured was parked on the left side of the road. The driver was busy

changing the tyre when the mini bus carrying passengers to dargah hit the truck from behind. The impact of the accident was such that five people died on the spot while several other passengers were injured, a Srinivasulu, Superintendent of Police of Kalaburagi, said.

Indian Youth Cong protests against govt silence over US tariff imposition

PTI, NEW DELHI: The Indian Youth Congress (IYC) on Saturday slammed the Modi government for its silence on the 26 per cent export tariff imposed by US President Donald Trump, calling it a sign of India's failed foreign and economic policy. At a protest held in the capital, IYC National President Uday Bhanu Chib alleged that the new tariff would "destroy the Indian market" and severely harm sectors such as agriculture, small industries, chemical production and electronics manufacturing. "Prime Minister Narendra Modi does not have the guts to speak against Trump. His silence is costing the Indian economy dearly," Chib alleged. The Union government must stop "parading" its "so-called" friendship with the US and come clean on how it plans to protect India's interests, he added.

Echoing similar concerns, Delhi Pradesh Youth Congress President Akshay Lakra said the tariff hike was evidence of the Modi government's diplomatic and economic failures. "From supporting Trump's election campaign to completely bowing before him, what has Modi achieved? Today, the US is slapping 26 per cent tariff on our products, and our economy, which is already grappling with inflation and unemployment, is heading towards deeper trouble," Lakra said. The IYC workers burned an effigy of Trump during the demonstration and attempted to take out a protest march but were stopped by police, said an IYC statement. The IYC warned that if the government continues to be silent, it will intensify protest in the coming days.

Mumbai teen's 'Project Zul' introduces robotics to J&K students

PTI, JAMMU: A Mumbai-based teenager is inspiring students in Jammu and Kashmir with his project Zul - a pioneering science, technology, engineering and mathematics (STEM) initiative aimed at igniting their passion for robotics and coding. Spearheaded by 17-year-old Arav Kaul from Mumbai's Dhirubhai Ambani International School, the program was launched to equip students in grades 9 and 10 with hands-on skills in microcontroller programming. "The initiative seeks to foster innovation and technological growth in the region, empowering young minds with practical knowledge for the future", Arav said.

A STEM initiative refers to a program or effort aimed at promoting education, skills and careers in these fields. Arav met Lieutenant Governor Manoj Sinha here, who commended the initiative, recognising its alignment with the region's aspirations for technological transformation and youth empowerment. "Robotics is more than technology - it's about problem-solving and creative thinking," Arav said, emphasising his mission to make STEM education accessible and enjoyable. Teachers have enthusiastically embraced the training, describing it as engaging and practical, and are integrating these skills into their classrooms, he said.
