They are claiming that work is complete, but the fact is that 18th June Road, Dr Pissurlekar Road, Atmaram-Borkar Road and Old Patto Bridge to Income Tax Office and Handicrafts building to Four Pillar Junction are yet to be done. Why did the authorities not announce in the beginning itself that these roads will not be ready March 31, 2025?'

Waqf Act: Protests erupt across country

Police vehicles torched, stones hurled in Bengal; mob gets violent in Manipur

PTI, BAHARAMPUR, JAM-MU, IMPHAL: Protests continued across various parts of the country against the recently enacted Waqf (Amendment) Act, on Tuesday.

In Murshidabad district of West Bengal, a protest turned violent, as police vehicles were set ablaze and stones were allegedly hurled at security personnel in the Muslim-majority region. The incident occurred in the Jangipur area, where a large number of people had assembled in the afternoon demanding the withdrawal of the controversial legislation.

According to a senior district police officer, demonstrators began pelting the police with stones and in the ensuing chaos, some police vehicles were also set on fire.

"Security has strengthened in the area following the incident," the officer said, adding that a few police personnel were injured in the clash. A heavy deployment of police forces has been made in the area to prevent further unrest. State minister and West Bengal president of Jamiat Ulema-e-Hind, Siddiqullah Chowdhury, condemned the police action.

SC TO HEAR PLEAS AGAINST WAQF ACT ON APR 15, CENTRE FILES CAVEAT

PTI. NEW DELHI: The Supreme Court would likely on April 15 hear a batch of pleas challenging the constitutional validity of the Waqf (Amendment) Act, 2025. The Centre, however, on Tuesday filed a caveat in the apex court and sought a hearing before any order was passed in the matter.

A Govt notification, in the meantime, said Waqf (Amendment) Act, 2025, which was passed by Parliament last week, comes into force on Tuesday.

"In exercise of the powers conferred by sub-section (2) of section 1 of the Waqf (Amendment) Act, 2025 (14 of 2025), the Central Govt hereby appoints the 8th day of April, 2025 as the date on which the provisions of the said Act shall come into force," the Ministry of Minority Affairs notification said.

SC slams TN Governor for delaying bills

PTI, NEW DELHI: In a major boost to the DMKled Tamil Nadu government, the Supreme Court on Tuesday upheld the validity of 10 State bills that were re-enacted and stalled by Governor R N Ravi. The apex court ruled that the Governor's second round of reserving the bills for Presidential assent was unconstitutional and liable to be set aside.

The SC held that the Governor had acted in bad faith by delaying assent and violating the spirit of Article 200. The court declared that the bills were "deemed to have been assented to" from the date they were re-submitted after being passed again by the Assembly. Crucially, the court set strict timelines for Governors: one month to act on bills presented, and three months if returning bills or reserving them against the Council of Ministers' advice. It rejected the concept of "pocket veto" or indefinite delay

Planning legislation to regularise irregular structures: CM

PANJIM: Chief Minister Pramod Sawant announced on Tuesday that the Goa government is considering issuing an Ordinance or introducing a Bill to regularise irregular structures in the state, but emphasised that no illegal structures will be allowed moving forward.

Speaking to the media after a committee meeting with Cabinet Ministers, MLAs, and officials, Sawant confirmed that action will be taken against all illegal structures in compliance with a High Court order issued on March 6, 2025. "We will not permit the erection of illegal structures in the state," Sawant said.

The CM also detailed measures to prevent illegal constructions, noting that flying squads and helplines at the taluka level have been activated by both District Collectorate offices to monitor and report such

structures. "Prompt action will be taken against any illegal construction," he added.

Additionally, Sawant confirmed that officers have been instructed to remove encroachments on government-acquired roadside land. He advised individuals with structures on these lands to remove them voluntarily at the earliest.

Revenue Minister Atanasio 'Babush' Monserrate also weighed in, stating that all illegal encroachments along roadways, particularly those hindering road widening projects, will be demolished. However, Monserrate clarified that the High Court's directive only required municipal councils and village panchayats to submit reports on illegal structures within their jurisdictions and did not mandate demolitions. "No houses will be demolished," he asserted.
