

#### Case against unidentified person over bomb threat to IndiGo flight

MUMBAI: A First Information Report (FIR) was registered here on Tuesday against an unidentified person for leaving a bomb threat note on a Jaipur-Mumbai flight of IndiGo, police said. The flight with 225 passengers on board landed in Mumbai safely around 8.50 on Monday night and a search revealed that the threat was a hoax. An Airport Police Station official said that about 20 minutes after the flight took off at 7.05 pm, a cabin crew member found a note in the lavatory saying, 'Open it... Surprise, Bomb Is Waiting for you guys, not a joke.' After the flight landed in Mumbai, the aircraft was taken to a remote bay for a thorough check but nothing suspicious was found.

#### MP: Principal suspended after video shows peon evaluating answer sheets

NARMADAPURAM (MP): The principal of a government college in Narmadapuram district and a professor were suspended after a viral video purportedly showed a peon evaluating students' answer sheets. Sources said that aggrieved students had contacted local MLA Thakurdas Nagvanshi, who then lodged a complaint with the authorities. Rakesh Verma, the principal of Pipariya-based Bhagat Singh Government College, claimed that he and Professor Ramgulam Patel were suspended on April 4. Verma stated that the answer sheet evaluation work had been assigned to a guest teacher, who then handed it over to a peon via a book lifter posted in the college. A complaint was raised in January this year after the video clip surfaced on social media, Verma added.

#### Five-day police custody for 'fake' cardiologist in Madhya Pradesh

**BHOPAL:** A court in Madhya Pradesh's Damoh on Tuesday remanded alleged fake cardiologist, Narendra John Camm, linked to the death of seven patients, to police custody for five days. A day earlier, he was arrested in Pravagraj, Uttar Pradesh. "Chief Judicial Magistrate Sneha Singh remanded Camm to police custody for five days on our request," Public Prosecutor Satish Kapasya told PTI. Police had registered a First Information Report (FIR) against Camm amid allegations that he possesses a bogus medical degree on charges of forgery and dishonest misappropriation on a complaint lodged by Damoh district's Chief Medical and Health Officer (CMHO) MK Jain. Damoh Superintendent of Police (SP) Shrut Kirti Somwanshi had said the accused would be interrogated on questions raised by the CMHO in his complaint.

#### Delhi Police busts gang behind 'digital arrest' fraud; four held

**NEW DELHI:** The Delhi Police has busted a cyber fraud syndicate involved in digitally extorting money through forged documents of CBI and ED and arrested four members of the gang, an official said on Tuesday. According to police, the accused held a 45-year-old woman, her daughter and her elderly father virtually hostage on video calls for two straight days, and extorted Rs 8.10 lakh by threatening legal action under a fictitious money laundering case. The incident came to light after the victim, a private sector employee residing in Lahori Gate here, filed a complaint at the National Cybercrime Reporting Portal (NCRP). "The woman reported that she received a call from an unknown number where the caller claimed to be from the Telecom Department and accused her of using a fake SIM card. The situation escalated when she started receiving continuous video calls from numbers impersonating officials from the Enforcement Directorate (ED) and the Central Bureau of Investigation (CBI)," Deputy Commissioner of Police (North) Raja Banthai

#### Man rapes 10-year-old girl, slits her throat before throwing body from 6th floor; held

THANE: A 10-year-old girl was allegedly kidnapped and raped by a man who slit her throat and threw her body from the bathroom window of his sixth floor flat in Maharashtra's Thane city, police said on Tuesday. The 20-year-old man, identified as Asif Akbar Mansoori, was arrested for the crime that took place on Monday night in the 10-storey building at Samrat Nagar in Mumbra area, they said. The incident was reported at 11.48 pm on Monday to the Thane Municipal Corporation's disaster management cell, its chief Yasin Tadvi said. As per the preliminary probe, the accused, who hails from Sultanpur in Banka district of Bihar, allegedly lured the victim residing in a nearby building by offering her toys. He then took her to his flat on the sixth floor, where he raped her and then slit her throat with a sharp weapon. After that, he took her body to the bathroom of his house and threw it from its window, a police official said.

# In a first, SC fixes timeline for governors to give assent to bills passed by assemblies

PTI. NEW DELHI: In a the Constitution. landmark ruling, the Supreme Court on Tuesday held that governors cannot sit over bills passed by the state legislature and fixed a timeline of one to three months for their actions under the Constitution.

A bench of justices I B Pardiwala and R Mahadevan said the expression "as soon as possible" permeates Article 200 with a sense of expediency, and does not allow the governor to "sit on the bills and exercise pocket veto over them".

"Similarly, by virtue of the first proviso intrinsically and inextricably attached to the option of withholding of assent, there is no scope for the governor to declare simpliciter withholding of assent meaning thereby absolute veto is also impermissible under Article 200," it said.

#### SC PULLS UP TN GOVERNOR FOR SITTING ON BILLS, TERMS IT ILLEGAL

PTI, NEW DELHI: In a major victory to DMK-led Tamil Nadu government, the Supreme Court on Tuesday cleared 10 bills which were stalled and reserved by Governor R N Ravi for President's consideration, and also set a timeline for all governors to act on the bills passed by state assemblies. A bench of Justices J B Pardiwala and R Mahadevan held, "In the facts of the present case, the reservation of the 10 bills for the consideration of the President in the second round would be termed as illegal, erroneous in law and just liable to be set aside. As a result, any subsequent action taken upon the said bills by the President also does not survive and is thus set aside." In an unprecedent move, the bench fixed a timeline between a month and three months for the governors to decide the fate of the bills cleared by the state assemblies, keeping in mind the constitutional significance of Article 200 and the role it plays in the federal polity of the country. "The bills having been pending with the Governor for unduly long period of time and the Governor having not acted bonafide in reserving the bills for the consideration of the President... are deemed to have been assented by the governor on the date when they were presented to him after reconsideration," the court said.

holding of assent or reservation of the bills for the consideration of the president upon the aid and advice of the state council of ministers, the governor is expected to take such action forthwith subject to

a maximum period of one month," the bench said.

The top court said that in case of withholding of assent, contrary to the advice of the state council of ministers, the governor must return the bills together with a message within a maximum period of three months.

It said in case of reservation of bills for the consideration of the president, contrary to the advice of the state council of ministers, the governor shall make such reservation within a maximum period of three months.

"In case of presentation of bills after reconsideration in accordance with the first proviso (of Article 200), the governor must grant assent forthwith subject to a maximum period of one month," it said.

The use of the expression "as soon as possible" makes it clear that the Constitution infuses a sense of urgency upon the governor and expects him to act in expediency, the bench noted.

# Doctors warn of serious health risks as IMD issues yellow alert amid spiralling temp

PTI, NEW DELHI: The mercury has been soaring in Delhi and doctors have warned that exposure to extreme heat can lead to a range of health issues -from mild rashes and muscle cramps due to excessive sweating and salt loss, to serious conditions like heat

exhaustion and heatstroke. Delhi recorded its first heatwave of the season on Monday with the maximum temperature touching 40.2 degrees Celsius. The city is currently under a yellow alert, which will remain in

place till Wednesday. In the India Meteorological Department's (IMD's) colour code, a yellow alert stands for "be aware" and advises people to avoid heat exposure, wear lightweight, light-coloured and loose cotton clothes, and cover their heads.

Under these conditions, vulnerable groups such as children, the elderly, pregnant women, and individuals with pre-existing conditions such as cardiac or kidney dis-

ease are at a greater risk. Dr Mukesh Mehra, senior

director (Internal Medicine) at Max Super Speciality Hospital in Patpargani, said extreme heat can overwhelm the body's natural cooling system, leading to severe health consequences. "Heatstroke, the most

serious form of heat-related illness, occurs when the body temperature exceeds 104°F. It often manifests itself with symptoms such as confusion, dry and hot skin, rapid heartbeat, and even seizures. Other signs include dizziness, headache, nausea, and vomitorgans like the brain and heart may be strained due to reduced cooling and redirected blood flow. Recognising these symptoms early and seeking immediate medical attention is essential to pre-

vent life-threatening compli-

cations," Mehra added. Apart from heat rash and muscle cramps caused by excessive sweating and loss of electrolytes, more serious conditions such as heat exhaustion can lead to dizziness, fatigue, heavy sweating, and nausea, he said.
