Notices to 15 Ponda flats for releasing sewage into the open

PMC allows 7-day period to prevent sewage flow into the open, after which disconnection notices will be enforced

PONDA: To address the issue of apartments, commercial establishments. and hotels releasing waste into the open, the Ponda Municipal Council (PMC) said that 15 notices have been sent to these establishments with a mandate for immediate sewage connections to avoid water disconnections.

It is pertinent to note that the 15 MLD sewage treatment plant (STP) has been in operation since last year.

It has come to the PMC's attention that approximately 88 buildings, including apartments, commercial establishments, and hotels, are releasing waste into the open.

PMC Chief Officer Yogiraj Gosavi stated that since issuing 15 disconnection notices, some buildings have started the application

process for sewage connections. The ultimate goal is to achieve 100 per cent residential building connection to the operational

He said, "The release of sewage and hotel waste into open nullahs and drains has resulted in worsening conditions, causing pollution and foul odour for nearby residential areas. Septic tank overflows have also been reported. To combat this, the PMC had warned the violators two months ago."
Gosavi said, "The PMC

has allowed a seven-day period for corrective action to prevent sewage flow into the open, after which disconnection notices will be enforced. The town residents are encouraged to establish sewage connections. Temporary measures are also mandated within this seven-day period for bungalows, flats, hotels, and restaurants, alongside the initiation of the sewage connection application pro-

He said, "in October, PMC had a meeting with the sewage corporation and a deadline was set for people to apply for sewage connection by December; however, only 200 applications have been received to date. Charges are Rs 3,000 per apartment, with commercial rates applicable for hotels. A charge of 35 percent of the water bill will be applied for sewage, with a 50 percent penalty for

"Presently, disconnection notices have been issued to 15 residential houses, prompting them to apply for sewage connections. Councillors have been actively distributing sewage application forms to encourage local residents to apply for sewage connections." Gosavi added.

Launch mini buses in Merces up to GMC, urge Santa Cruz elders

PANIIM: The Senior Citizens' Welfare Association for Santa Cruz constituency, on Wednesday submitted a memorandum to the Imagine Panaji Smart City Development Limited (IPSCDL) and KTC chairman urging them to introduce Bungee bus service (mini buses) in Merces up to Goa Medical College and Hospital (GMC), Bambolim.

In the letter it stated that the Merces village was about 2.5 to 3-km away from Panjim bus stand but the irony was that the government had never introduced independent bus service for the Merces village. Due to absence of the independent bus service for Merces, the people had to depend on the Chimbel or Batim-bound buses, which are plying through Merces.

According to association president John Nazareth, there are several wards in Merces such as Vaddy, Temba, Carmita,

Carmibhat, Moloca, Oilem Bhat, Bamon Bhat, etc, which are away from the bus stops on which the Chimbel and Batim-bound buses stop. Owing to this problem, the villagers specially the senior citizens had to totally depend upon their children or neighbours to transport them to Panjim or to the bus stops to travel to Chimbel or Batim-bound bus service or having no option they are compelled to hire taxis to visit Panjim or GMC, Bambolim for treatment. Finding no help, the senior citizens remain inside their own houses and it affects their health, he said.

Nazareth said that recently the North Goa District and Sessions Court was shifted to Merces and the employees travelling by public transport had to make use of Chimbel or Batim bus service, but had to alight at the first stop named Madani and walk a distance of about 800 metres for about five to 10 minutes.

Goa's temple town grappling with severe parking space shortage

Ponda residents face parking difficulties at key locations as vehicles are parked for extended periods

PONDA: Goa's temple town is rapidly developing with new residential and commercial projects, which has exacerbated the severe shortage of parking spaces in Ponda.

The town's residents are facing parking difficulties near key locations - State Bank of India, mamlatdar building, police station. market and bus stand.

Over 1.5 lakh residents from four constituencies of Hotchips, Luis-e-nana Meson the taluka, frequently visit government offices, markets, schools, and the Bagayatdar Bazaar, leading to significant congestion and vehicles often parked along roadsides also result in traffic disruptions. Despite



the vast areas within the jurisdiction of panchayats in the taluka, the town is geographically small, which intensifies the problem.

Naresh Naik, a local said, "Finding a parking space in the town has become a major challenge. The parking scarcity often forces motorists to park their vehicles on main roads or in no-parking zones. This leads to conflicts with traffic officials who issue fines, as people demand designated parking areas before receiving challans."

The practice of individuals parking vehicles for extended periods while they go to work or industrial estates further compounds the issue. This leaves those visiting the market or government offices struggling to find parking, as roadside spaces remain occupied.

PMC chairperson Anand Naik said, "Some people keep their vehicles in parking area for the entire day thus causing inconvenience to others PMC has taken decision to introduce pay parking system to decongest the town and has also identified some areas for parking. The pay parking system will come into force after hotmix carpeting of all roads."

Vishal Fadte from Ponda said, "While the PMC is making efforts, the residents continue to face parking problems due to the shortage of spaces. There is a need to identify additional parking areas before implementing the pay parking

Auto major to refund full amount towards defective bike plus fine

PANJIM: The Goa State Consumer Dispute Redressal Commission has ordered an automobile company to refund full amount paid by the complainant towards defective two-wheeler and compensation of Rs 50,000 for the mental agony and inconvenience caused to the complainant.

Socoro Willy D'Costa of Palcutta-Orlim, Salcete. had filed an appeal against the order dated 24/07/2024 passed by the North Goa District Consumer Disputes Redressal Commission. He had sought direction to the automobile company M/s Royal Enfield, a unit of Eicher Motor Ltd, Chennai and its authorised dealer Saini Motors, Margao, to replace the "defective" bike with extended warranty for additional three years and to pay him a compensation of Rs 20,000.

D'Costa had purchased an Enfield bike from the authorised dealer on November 11, 2020 and he found some technical issues with the bike and it started malfunction in a bad way day-by-day. He also said that the chassis was faulty and the compa-

ny later replaced the chassis but even after replacement the performance was bad which could risk his safety on the road.

The complainant stated that there was negligence on the part of the company and the authorised dealer and alleged that they were running an unfair trade practice.

The company and the dealer denied the allegations made against them. They claimed that the vehicle was provided in a complete road worthy condition without any defects and after due pre-delivery inspection. All the issues raised by the complainant during service were looked into by them and the bike was delivered to him in road worthy condition.

complainant al-The leged that the company replaced the chassis with same number; and once the chassis was replaced, he was unable to bring the bike on the road. If the chassis had to be changed, it should go through the legal process, he said, adding

that the bike was lying idle. The company lawyer stated that they had resolved the problem and there was no manufacturing defects with the bike as it covered mileage of 4,637
