PRIVATE JETTY PLAN IN THE EYE OF THE STORM

Penha de Franca Village Panchayat firm on not granting permission for the project; threatens to launch an agitation

PANJIM: Opposition to the Rs 8-crore private jetty proposed at Malim gathered steam on Sunday with the members of the Penha de Franca Village Panchayat declaring that they would not grant permission for the project as the villagers do not need it.

Speaking to the media-persons, Sarpanch Sapnil Chodankar and panchayat members made it clear that they would not hesitate to take to the streets if required.

Chodankar said, "I have read in a newspaper about the Central government granting permission to a Mumbai-based company to construct a jetty, the panchayat had not been informed or consulted about the project's location."

Chodankar said, "I would like to know the specific location of the jetty. The panchayat will not grant permission for the jetty, as the villagers do not need it. Even the local MLA, who is the Tourism Minister, is unaware of the jetty's location. I will inform the MLA that the jetty's construction would negatively impact the local

PANJIM: Tourism Minister and Porvorim MLA Rohan Khaunte stated that he was unaware of the Rs 8 crore private jetty project at Malim on River Mandovi, till it was reported in the media.

Speaking to mediapersons, he said, "I have read this news in the newspaper. I am not aware of it. I have already checked with the panchayat (officials), who confirmed that they have not granted any permission for the project. How could permission be

granted by the Central government without conducting a proper study?" Emphasising the importance of considering local sentiments, the interests of traditional fishermen, and the overall impact of the project, he said, "As the local MLA, I should have been informed and involved in discussions, and that the community should have been consulted before any decisions were made."

Will not allow highway expansion: Bhoma residents

Say it is a political conspiracy to destroy their village and culture; Corlim locals extend support

PONDA: Accusing politicians of plotting to divide locals and push the national highway (NH) expansion for vested interests, Bhoma villagers sent out a clear message on Sunday: they are prepared to die to protect their village and its culture from destruction.

Residents of Corlim, who had earlier filed a joint petition in the High Court of Bombay at Goa against the NH expansion, came forward to extend their support to Bhoma locals.

Speaking at a meeting, Sanjay Naik said, "Fearing politicians, some people have not stepped out of their houses to attend. But we are ready to die and will shed our blood to save Bhoma."

He called the NH expansion and the Sagarmala project a conspiracy imposed on Bhoma and urged villagers to demand an alternative alignment plan to save the 36 hillside plots. "We will not allow expansion," he said firmly.

Govt not to allow construction around Old Goa churches

Extends buffer zone surrounding them to 200 metres; activists say site should be included in regional plan if the government is sincere

PANIIM: Declaring that no construction will be permitted around the historic churches of Old Goa, the State government on Sunday extended the buffer zone surrounding these UNESCO World Heritage sites from 100 metres to 200 metres.

Speaking to mediapersons after attending an event at Corlim, Town and Country Planning (TCP) Minister Vishwajit Rane said, "I am very firm that a heritage site needs to be protected and we have to have a buffer zone. However, if procedure has been followed to do something within the buffer zone then it is a different matter altogether and it has nothing to do with any permission."

Palm Sunday procession disallowed in Delhi, Catholic body slams move

PTI, NEW DELHI: A prominent Catholic organisation has condemned the Delhi Police's decision to deny permission for the annual Way of the Cross procession, a key religious event observed every Palm Sunday by the Christian community. The Catholic Association of the Archdiocese and well-coordinated with of Delhi (CAAD) described the move as "shocking and unfair".

There was no immediate comment from the Delhi Police regarding the matter.

"This is deeply shocking and unfair. The procession has always been peaceful

'Protected witness' likely to confront Rana during grilling

AGENCIES, MUMBAI: Tahawwur Rana, the 26/11 Mumbai terror attack accused, is likely to be confronted with a "protected witness" who arranged logistics for David Headley in Mumbai, by the National Investigation Agency (NIA) during the interrogation.

NIA began questioning Rana after he was sent to 18day custody following his extradition from the US on a special flight on April 10.

Rana had asked one of his staff members — called 'employee B' (NIA's witness) - to help David Coleman Headley, the main planner of the attacks, with planning and other support, NIA sources said on Sunday, a news channel reported.

As per the sources, 'employee B', did not have information about the terror plans and was only told handle things like picking up Headley, arranging travel, stay, and providing a place to work and live — following Rana's instructions.



"protected witness", allegedly received Headley in Mumbai and arranged logistics for his reconnaissance mission in 2006.

This witness is expected to help establish Rana's role in facilitating Lashkar-e-Taiba's (LeT) planning for the deadly attacks that left 166 people dead and over 230 injured.

Rana used his immigration business to help Headley with visas, hide his Pakistani-Muslim identity, and blend into Indian business and military circles, NIA sources said. He also booked Headley's flight from Karachi and helped create documents for his Moroccan wife.

FinMin: 18% GST on flat upkeep over Rs 7,500

BENGALURU: The Ministry of Finance & Corporate Affairs has issued a clarification to dispel confusion among apartment owners and Resident Welfare Associations (RWAs) regarding the applicability of Goods and Services Tax (GST) on monthly maintenance charges.

The Ministry clarified that RWAs are not required to register for GST or pay the tax if their aggregate annual turnover does not exceed Rs 20 lakh, even if the monthly maintenance charges per member are higher than Rs 7,500. However. GST at the rate of 18% becomes applicable if both conditions are met: the monthly maintenance charges exceed Rs 7,500 per member, and the RWA's annual turnover crosses Rs 20 lakh.

It was further explained that the Rs 7,500 threshold applies separately to each residential apartment. For instance, if a person owns more than one flat in a residential complex, the Rs 7,500 limit is calculated individually for each unit.

Churchill Brothers withdraw from Super Cup tourney, slam AIFF over seeding and title dispute

Veteran club accuses federation of flouting rules and ignoring league standings

MARGAO: Churchill Brothers FC Goa has withdrawn from the Super Cup tournament, starting April 20 in Bhubaneswar, accusing the All India Football Federation (AIFF) of an "irregular and unconventional" seeding process and refusing to recognise them as I-League 2024-25 champions, despite finishing top of the

In a letter addressed to AIFF President Kalyan Chaubey on April 12, the club expressed deep frustration over what it described

In the face of the AIFF's blatant disregard for rules, precedent, and fair play, we have no choice but to CHURCHIL withdraw from the Super Cup 2025 in protest. We had raised objections in a previous letter on April 9 regarding the conduct of the Super Cup draw, but the federation failed to respond or address our concerns. We have received no explanation for the highly irregular process used in conducting the draw Churchill Brothers FC Goa

the Super Cup 2025 in protest," the veteran club wrote. Churchill Brothers said they had raised objections in a previous letter on April 9 choice but to withdraw from regarding the conduct of the

Super Cup draw, but the federation failed to respond or address their concerns. "We have received no explanation for the highly irregular process used in conducting the draw." the club said, alleging that different standards were applied to Indian Super League (ISL) and I-League teams.

According to Churchill, while Super Cup seeding reflected the final ISL standings, the same logic was not extended to I-League teams. Despite topping the table, Churchill Brothers were denied the 14th seed, which instead

went to Inter Kashi through what the club called "an opaque draw of lots."

This has allowed Inter Kashi to falsely project themselves as I-League 2024-25 champions, using the AIFF's decision to legitimise a claim that is entirely baseless," the club said. "The AIFF's continued inaction not only harms Churchill Brothers but undermines the integrity of Indian football. It raises serious doubts about the AIFF's ability to function as a fair and impartial governing body."
