PANJIM: A Buddhist monk from Bangladesh, who was arrested in the State for possessing a fake passport, has recently been deported by the Foreigners Regional Registration Office (FRRO), Goa.

Shourab Barua 25, was arrested at Manohar International Airport in December last year while attempting to flee to the United Kingdom. He was apprehended by the Bureau of Immigration at the airport's departure counter while attempting to travel using an Indian passport, which he had obtained by submitting forged documents in Nashik, Maharashtra.

Class (JMFC), Pernem, and the Court convicted him. He was sentenced to undergo simple imprisonment for two months and 19 days. Upon completion of his sentence, the FRRO Goa made arrangements for his deportation via Mumbai.

The police have now filed a charge sheet against Munna Roy under Section 7(1)(3)(iii) of the Foreigners Order, 1948; Section 14 of the Foreigners Act, 1946; Sections 3(a) and 6(a) of the Passport (Entry into India) Rules, 1950; Sections 3 and 4 of the Passport (Entry into India) Act, 1920; and Sections 212, 336(2), 336(3), 337, 339, 340(2), and 318(4) of the Bharatiya Nyaya Sanhita (BNS). Roy is currently facing trial before the IMFC, Pernem.

180 kg of mangoes with ethylene ripener seized

PANJIM: The Food and Drugs Administration (FDA) conducted a surprise inspection at the sub yard market in Mapusa and seized 180 kg of mangoes that were found to contain sachets of ethylene ripener inside the boxes.

Officials stated that the mangoes have been sent to a laboratory to determine whether they were being a laboratory to artificially ripened using non-approved methods. The test results are expected within seven days and will be made public, they added. Food and Drug Administration officials inspected seven units at Siolim engaged in selling local varieties and eight at the Mapusa Sub Yard dealing in mango varieties from other states. A total of 24 samples of various mango varieties and four samples of other fruits were collected. During the inspection,

PERNEM: Tension prevailed at Mopa, Pernem after the GMR Airports Limited issued notices to Blue Cab prepaid taxi operators to suspend their taxi operations from the Manohar International Airport, Mopa, Pernem from Tuesday, April 15.

The directions have been issued over the failure to obtain security clearance from the Ministry of Home Affairs (MHA), Government of India and the Bureau of Civil Aviation Security (BCAS).

The notices have been issued for non-compliance of the terms of the licence agreement dated November 23, 2023 between the Blue Cab Prepaid Taxi Association, Mopa and the GMR Airports Limited (GAL). Under Clauses 2.1.3 and 7.1.14 of the Licence Agreement, the Blue Cab operators were required to obtain security clearances the MHA and the BCAS. In spite of repeated requests and reminders to comply with the same, the blue cab operators failed to obtain the security clearances, which is a continuing breach of the licence agreement.

Traditional coconut pluckers reclaim livelihood in Sanguem

Agri Dept trains, empowers locals; aims to preserve Goa's traditional occupations

SANGUEM: In a significant boost to traditional occupations and rural self-employment, the Directorate of Agriculture has revived the lost livelihood of coconut pluckers in Sanguem taluka through skill development and free access to modern equipment.

Led by Zonal Agricultural Officer (ZAO) Agresh Shirodkar, a seven-day training programme titled Friends of Coconut Tree (FoCT) was recently held to train individuals - many of whom had previously abandoned the profession - on modern coconut harvesting techniques.

Participants were provided free climbing machines to help them compete with migrant workers, who have dominated the trade in recent years.

ti, Sanguem, a once-unemployed

traditional plucker, who had been

sidelined due to the physically de-

manding nature of manual climbing. "Earlier, without machines, the work took too long and people stopped calling us. But after the training and armed with climbing machines, things changed," Bomo shared. He now earns between Rs 1,000 and Rs 1,500 per day and has regained his dignity through self-reliance.

The FoCT initiative not only empowers local workers but also aims to preserve Goa's traditional professions, which are rapidly disappearing due to mechanisation and the influence of external labour. The programme has already trained 25 individuals, many of whom are now actively plucking coconuts either as professionals or on their own plantations.

Officials say this is just the beginning, with more such training programmes planned across the State to promote heritage-linked employment and reduce dependency on external labour.
