Bogus notes with Rs 4.35 lakh face value seized in MP; 5 held from Indore, Bhopal

INDORE: Police on Tuesday seized counterfeit currency notes with a face value of more than Rs 4 lakh and arrested five persons from different cities in Madhya Pradesh in this connection, an official said in Indore. All five were members of a criminal gang involved in printing and circulating fake currency notes in the state, police said. Talking to reporters, Deputy Commissioner of Police (Crime Branch) Rajesh Kumar Tripathi said three of the accused were apprehended from a hotel in Indore's Anurag Nagar Extension area after cops received a tip-off about their presence. The trio, Abdul Shoaib alias Chhotu (25), Rahees Khan (32) and Prafull Kumar Kori (19), hailed from Chhindwara district, he said

Pune businessman abducted and killed in Bihar: suspects detained

PUNE: A 55-year-old businessman from Pune was allegedly abducted from outside Patna airport and murdered, police said on Tuesday. After Laxman Shinde's body was found in Jehanabad district, around 50 km from Patna, police detained several suspects from nearby villages for questioning. The preliminary investigation suggests that the crime was linked to a sophisticated cyber-led business entrapment scheme, police said. Shinde, the owner of Centrifugal Casting Bearing located in Khedshivapur in Pune, had travelled to Patna by flight on April 11. However, after sending a message to his daughter around 8:30 PM, in which he mentioned heading to Jharkhand, no further communication was established.

Kidnapped baby boy of visually impaired beggar rescued, 1 held

BHUBANESWAR: The Odisha Police on Tuesday rescued the kidnapped one-and-half-year-old boy of a visually impaired beggar in Bhubaneswar and arrested one person in this connection, an officer said. The baby boy was handed over to the mother after medical examination at the Capital Hospital here, Commissioner of Police S Dev Datta Singh told reporters. The baby was kidnapped on Saturday night by an unidentified man when he was playing and his mother and sister were sleeping on the footpath. After getting back her child, the visually challenged woman checked the boy by touching his body parts and confirmed that the kid was hers. "I am absolutely happy. I express my gratitude to Lord Ram before whose temple I beg", the woman said.

145 kg sea cucumbers worth Rs 58 lakh seized by coast quard

NEW DELHI: The Indian Coast Guard (ICG) on Tuesday said it has seized 145 kilograms of sea cucumbers worth Rs 58 lakh during an anti-poaching operation. Sea cucumber harvesting and trade are banned in India under the Wildlife Protection Act, 1972, "On April 13, 2025, Indian Coast Guard Station Mandapam (at Ramanathapuram in Tamil Nadu) seized 145 kilograms of illegal sea cucumbers worth Rs 58 lakh during an anti-poaching operation. A major step towards safeguarding our marine environment and curbing illegal transshipment," the coast guard posted on microblogging site X. The coast guard and Gujarat Anti-Terrorist Squad (ATS) had recently seized 300 kilograms of drugs valued at Rs 1,800 crore, which smugglers dumped into the Arabian Sea before fleeing across the International Maritime Boundary Line.

Wedding of 2 Hathras sisters called off after dowry dispute

HATHRAS: The wedding of two sisters in a tehsil here was abruptly called off after a dispute erupted between their and the grooms' families over dowry demands, police said. The incident has now reached the police, with the brides' family lodging a complaint at the women's police station. Shivani and Bharti, daughters of Sunil, residents of Samadpur village in Sadabad tehsil, were set to marry Mohit and Narayan, two brothers from the nearby Tajpur village. The wedding ceremonies were scheduled for April 14 and the grooms' procession had already arrived at the brides' home. However, the situation took a turn when the grooms' side allegedly demanded a vehicle in addition to the dowry already provided, the police said.

Model Town ASI caught taking bribe from retired Delhi Police inspector

NEW DELHI: The vigilance unit of Delhi Police has arrested an Assistant Sub-Inspector (ASI) posted at Model Town Police Station for accepting a bribe of Rs 2 lakh from a retired inspector of the force, an official said on Tuesday. The accused, identified as ASI Sudesh Kumar Yadav, was caught red-handed while receiving the bribe, a statement of the vigilance unit read. The sleuths swung into action after receiving a complaint on April 14 from the retired officer, a resident of Mahendru Enclave in Model Town. The complainant alleged that ASI Sudesh was demanding a Rs 4 lakh bribe to allow him to carry out repair work at his residence.

SC to hear pleas against Waqf Amendment Act today

PTI, NEW DELHI: The Supreme Court would likely hear on Wednesday a batch of petitions, including the one of AIMIM leader Asaduddin Owaisi, against the constitutional validity of the Waqf (Amendment) Act, 2025. A three-judge bench comprising Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and K V Viswanathan, so far, listed 10 petitions on the issue. In addition to Owaisi's plea, the court listed for hearing the petitions filed by AAP leader Amanatullah Khan, Association for the Protection of Civil Rights, Arshad Madani, Samastha Kerala Iamiathul Ulema, Anjum Kadari, Taiyyab Khan Salmani, Mohammad Shafi, Mohammed Fazlurrahim and RJD leader Manoj Kumar

SC TO CONSIDER LISTING FRESH PLEA AGAINST PROVISIONS OF 2025 WAQF LAW

PTI, NEW DELHI: The Supreme Court on Tuesday agreed to consider listing a fresh plea challenging the constitutional validity of several provisions of the Waqf (Amendment) Act, 2025. A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar took note of the submissions of advocate Vishnu Shankar Jain that a fresh plea was filed and the same be listed for hearing. "All matters where mentioning slips are given, we give dates mostly within a week," the CJI said. As many as 10 petitions, including the one filed by AIMIM leader Asaduddin Owaisi are already listed for hearing on April 16 before a three-judge bench comprising the CJI and Justices Sanjay Kumar and K V Viswanathan. The fresh plea, mentioned by advocate Vishnu Shankar Jain, was filed by Hari Shankar Jain and one Mani Munjal against the Union of India, the Ministry of Minority Affairs, and the Central Wagf Council.

Motivated and baseless: India trashes Pak's criticism

PTI, NEW DELHI: India on Tuesday strongly rejected Pakistan's criticism of the Waqf Amendment Act and said Islamabad should look into its own "abysmal" record in protecting the rights of minorities instead of preaching to others. External Affairs Ministry spokesperson Randhir Jaiswal described Pakistan's comments on the law as "motivated and baseless", asserting that the neighbouring country has no locus standi to comment on a matter that is internal to India.

New Delhi's reaction came after a spokesperson of the Pakistan Foreign Office alleged that the Waqf law is an "infringement" over the religious and economic rights of Indian Muslims.

"We strongly reject the motivated and baseless comments made by Pakistan on the Waqf Amendment Act enacted by the Parliament of India," Jaiswal said.

Truckers' stir to continue as talks with CM fail to break deadlock

PTI, BENGALURU: The indefinite strike of the truckers in Karnataka will continue as talks with Chief Minister Siddaramaiah failed to yield any breakthrough, a truckers' body office bearer said on Tuesday.

Despite the Chief Minister's appeal to the truckers to call off the strike in public interest, the truckers refused to relent, citing the state government's failure to meet their demands including a reduction in diesel prices and concrete assurances on toll-related issues.

The strike launched at midnight between Monday and Tuesday, brought the movement of Karnataka-based trucks to a standstill affecting transportation of goods within and outside the state.

The protest was spearheaded by the Federation of Karnataka State Lorry Owners and Agents Association, which cited rising fuel prices and alleged harassment at toll plazas, as the main reason for the stir.

The association is an umbrella organisation of 129 truckers associations with six lakh members drivers, agents and truck owners.

As the trucks remained stationed at the truck terminals across the state, due to the strike, the Chief Minister convened a meeting with the FOKSLOAA office bearers on Tuesday evening.

Over 10,000 illegal Afghans deported from Pakistan's Punjab since April 1

PTI, LAHORE: The Punjab ghan nationals from across belongings at throwaway has deported over 10,000 Afghan nationals since launching a crackdown against illegal foreign nationals on April 1, police said on Tuesday. The government led by Maryam Nawaz Sharif first detained these Afghans, including women and children, from about 150 Afghan colonies after the deadline for their voluntary return expired on March 31, Punjab Inspector General Usman An-

war said. He said the illegal Afghans were first moved to detention centres from where they were deported

to Afghanistan. "As part of the ongoing campaign to evict foreign nationals residing illegally in Punjab, the government has so far deported over 10,000 undocumented AfAfghans residing illegally in

Punjab had left voluntarily. Anwar further said police had a complete record of the Afghan nationals living in Punjab which helped the law enforcement agencies to reach the illegal foreign-

"The federal government and intelligence agencies are monitoring the deportation campaign," he added.

The intelligence agencies have identified 100,000 Afghans living illegally in Punjab, he said.

The detained Afghans, however, expressed dissatisfaction with the Pakistani government's sudden order to deport them.

Parts of Jammu and Kashmir, Ladakh, Tamil Nadu, Bihar and the northeastern states are likely to experience below-normal rainfall during the monsoon season.

Normal to above-normal monsoon rainfall is expected in large parts of Madhya Pradesh, Rajasthan, Maharashtra, Odisha, Chhattisgarh, Uttar Pradesh and West Bengal, which form the core monsoon zone (agriculture primarily rainfed) of the country.
