China accuses US NSA agents of cyberattacks during Asian Games

China said Tuesday it is pursuing three alleged U.S. operatives accused of carrying out cyberattacks on Chinese infrastructure during the Asian Games held in the city of Harbin in February. A notice from the Harbin police headquarters named them as Katheryn A. Wilson, Robert J. Snelling, and Stephen W. Johnson and said they worked through the National Security Agency. The police said nothing about how they obtained the names or where the three were believed to be at present. The alleged attacks targeted the systems for managing the Games themselves, such as registration, competition entry and travel, all of which stored "vast amounts of sensitive personal data of individuals associated with the Games," the police said.

The attacks continued during the Games in an attempt to "disrupt them and undermine their normal operations," according to the official Xinhua News Agency.

The report also alleged the NSA cyberattacks targeted critical infrastructure in Heilongjiang province, which includes Harbin, such as energy, transportation, water resources, tele-

pany Huawei, Xinhua said.
The report alleged that
the NSA "transmitted unknown encrypted data
packets to specific devices
running Microsoft Windows operating systems
within the province."

Chinese Foreign Ministry spokesperson Lin Jian, dished out further criticisms at a daily briefing, while offering no firm evidence.

The attacks caused "serious harm to China's critical infrastructure, national defense, finance, society, production, and the personal information security of Chinese citizens. The nature of these actions is extremely malicious," Lin said.

"China has expressed

its concerns to the US side

through various means regarding the US cyberattacks on China's critical infrastructure. We urge the US to adopt a responsible attitude on cybersecurity issues, stop cyberattacks on China, and cease unwarranted smears and attacks on China. China will continue to take necessary measures to protect its cybersecurity," the spokesperson

Three policemen killed, 18 injured in IED blast in Pakistan

PTI, KARACHI: Three policemen were killed and 18 others injured on Tuesday when an improvised explosive device (IED) hit a constabulary vehicle in the restive Balochistan province of Pakistan. Balochistan government spokesperson, Shahid Rind, said the Balochistan Constabulary vehicle was hit in the Dasht area of Mastung district while returning from duty. He said three police-

He said the security forces cordoned off the area and an investigation into the attack was underway

No group has claimed responsibility for the attack but the Balochistan Liberation Army often attacks security forces in the prov-

Prime Minister Shehbaz Sharif strongly condemned the attack and directed authorities to ensure immediate medical treatment for the injured.

Sharif vowed to continue the fight against terrorism and said: "We will thwart the nefarious designs of terrorists, who are enemies of humanity. Our war against terrorism will persist until this menace is completely eradicated from the country."

Balochistan has been witnessing violence for about two decades by ethnic Baloch groups who are fighting for greater control over the mineral resources of the province.

The blast comes a day after a Frontier Corps soldier and two terrorists were killed during an attack on a Frontier Constabulary post in Noshki city.

Over 270 rescued scam victims attempt escape in Myanmar

BANGKOK: They walked out of the compound in Myanmar not knowing where they would go. Though they were aiming for the river that separated them from Thailand and freedom, they didn't know if they would make it across. A group of more than 270 men and women, who were rescued from forced labour in scam compounds two months ago but remain in detention in Myanmar, attempted a mass escape Sunday out of fear that they may end up being sent back to prison-like compounds where they face beatings, torture and poten-

for more than two months.

She came to Myanmar for what she thought was a job in customer service more than a year ago, only to realise she had been trafficked. She was forced to work in online scams targeting people across the world.

Facing pressure from China, Thailand and Myanmar's governments launched a massive operation in February in which they released thousands of trafficked people from scam compounds, working with the ethnic armed groups that rule Myanmar's border areas.

That includes this group of 270, most from Ethiopia and other African countries, who attempted to escape after a meeting in which guards suggested they could be returned to scam compounds.

Enough raw materials available to keep British Steel plant operational

AP. LONDON: The UK government said on Tuesday it had bought enough raw materials to keep Britain's last steelmaking blast furnaces operating for the "coming weeks". The announcement came amid fears that the government's decision to wrest control of British Steel from its Chinese owners would deepen tensions between the UK and China. The issue has dominated British politics since Saturday, when Prime Minister Keir Starmer recalled lawmakers from their spring recess so Parliament could pass emergency legislation allowing the government to take operational control of British Steel.

That move was spurred by reports that the company's owners, China's Jingye Group, were trying to shut down steelmaking operations in Scunthorpe, northern England, by starving the plant of the iron ore and coking coal needed to keep the blast furnaces operating.

That raised the prospect that Britain would lose its last plant capable of making high-quality steel from scratch because once blast furnaces are shut down it is difficult and expensive to restart them.

The Department for

Business and Trade said shipments of the raw materials that had been waiting at the port of Immingham will be unloaded on Tuesday after the government agreed to pay for them. A separate shipment is on the way from Australia after the government resolved a legal dispute with Jingye.

US flies long-range bomber for drill with S Korea, as North marks key state anniversary

AP, SEOUL: The United States flew long-range B-1B bombers in a show of force against North Korea on Tuesday, days after the powerful sister of North Korean leader Kim Jong Un vowed to resist a US-led push to eliminate the North's nuclear programme. North Korea often reacts to the US deployment of B-1B bombers and other powerful military assets with missile tests and fiery rhetoric. Tuesday's flyover of the US bombers could draw an angrier response because it happened when North Korea was marking a key anniversary — the 113th birthday of state founder Kim Il Sung, the late grandfather of the cur-

South Korea's Defence Ministry said the US bombers participated in a South Korea-US aerial drill over the Korean Peninsula to strengthen the allies' com-

gramme.
A ministry statement said South Korean F-35 and F-16 fighter jets and American F-16 fighter jets also

took part in the training. It said South Korea and the US will continue to expand their joint military exercises to respond to North Korean nuclear threats.

It was the second time a US B-1B's had participated in a drill with South Korea since President Donald

Trump began his second term in January.

In February, North Korea's Defence Ministry slammed the B-1B's earlier flyover as proof of intensifying US-led provocations since Trump's inauguration. It pledged to counter the strategic threat of the US with strategic means.

Days later, North Korea test-fired cruise missiles in what it called an attempt to show its nuclear counterattack capability.

Trump has repeatedly said he will reach out to Kim Jong Un to revive diplomacy. North Korea hasn't directly responded to Trump's outreach.

Last Wednesday, Kim Yo Jong - Kim's sister and a senior official - derided the US and its Asian allies over what she called their "daydream" of denuclearising the North, insisting that the country will never give up its nuclear weapons programme.

ED questions Robert Vadra in Haryana money laundering case

PTI, NEW DELHI: The Enforcement Directorate (ED) on Tuesday recorded the statement of Robert Vadra, businessman and brother-in-law of Congress leader Rahul Gandhi, for about five hours in a 2008 Haryana land deal-linked money laundering case, official sources said. He has been asked to depose again on Wednesday for continuing the grilling session, the sources said.

Terming the agency's move to summon him as "political vendetta", Vadra said he has spent hours with the ED earlier during questioning (in separate money laundering cases), sharing thousands of pages but still the agency has been raking up cases against him.

The 56-year-old walked down from his residence at Sujan Singh Park in central Delhi to the ED headquarters on APJ Abdul Kalam Road, a two-km stretch. He

entered the ED office at 11 am along with his lawyer while his security team stayed out.

Speaking to reporters on the way to the ED office, he alleged, "This is nothing but political vendetta. Whenever I speak for minorities they try to stop me, crush us... they tried to stop Rahul (Gandhi) in Parliament too. This is misuse of agencies and this is political vendetta,", adding "I will cooperate with them like in the past."

Sources said the ED recorded his statement under the Prevention of Money Laundering Act (PMLA) for about two hours.

ED raids premises of Rajasthan Cong leader Khachariyawas, others

IAIPUR: The Enforcement Directorate on Tuesday raided the premises of Rajasthan Congress leader and former minister Pratap Singh Khachariyawas along with a few others as part of a Rs 48,000-crore PACL Ponzi "fraud"-linked money laundering probe, official sources said. About 15 premises -- including the politician's house in Jaipur and that of another person, Kulwant Singh -- are being searched by the federal probe agency. A security team of the CRPF has also been deployed.

The 55-year-old Congress leader served as minister for transport, food and civil supplies in the cabinet of former chief minister Ashok Gehlot. He has represented the Civil Lines (Jaipur) seat in the Rajasthan Assembly.

Addressing reporters outside his ancestral house here, Khachariyawas, nephew of former

vice president Bhairon Singh Shekhawat, said the ED action was "politically motivated" because he has been speaking against the government.

He asserted he had done nothing wrong and that he was "not afraid" of the ED. The money laundering investigation of 2015 stems from a Central Bureau of Investigation (CBI) FIR against PACL India Limited, PGF Limited, the late PACL promoter Nirmal Singh Bhangoo and others for operating "fraudulent" investment schemes to deceive investors.

Increase in demand for adoption leading to child trafficking: SC cautions parents

Supreme Court on Monday warned parents in the country about the dangers of child trafficking and asked them to be extremely vigilant with their children. A bench of Justices J B Pardiwala and R Mahadevan, which took a stern view of the inter-state child trafficking rackets, said long delays in the adoption process had led to an increase in the demand for children declared legally fit for adoptions, giving rise to children being trafficked for adoption. "We want to convey a message to one and all, more particular-

PTI, NEW DELHI: The Supreme Court on Monday warned parents in the country about the dangers of child trafficking and asked them to be extremely vigilant with their children. A bench of Justices J B Pardiwala and R Mahadevan,

The verdict went on, "Over the years, demands for the adoption of children have increased and there is a significant waiting period for prospective parents to adopt. At any given point in time, there are parents waiting for at least 3-4 years to adopt. Even after being processed and children being matched, the necessary

parent faces when a child dies was different from the suffering when their children were lost to trafficking, it added. "It is worse than death.

Therefore, we humbly urge
one and all to remain very
cautious and vigilant," the
bench said.

If any newborn was traf-

ficked from any hospital, the court said, the immediate action against the hospital should be suspension of licence to run the hospital in addition to other legal actions.

"When any lady comes to deliver her baby in any hospital, it is the responsibility of the administration of the hospital to protect the newborn infant in all respects," the bench said.

The state governments and law enforcement machinery was therefore directed to strengthen their mechanism to check operation of inter-state child trafficking rackets.
