'Very disturbing': Supreme Court on violence over anti-Waqf law protests

PTI, NEW DELHI: The Supreme Court on Wednesday said the violence occurring during protests against the Waqf (Amendment) Act, 2025 is "very disturbing". A bench of Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and K V Viswanathan made the observation while hearing the pleas challenging the constitutional validity of the newly-amended law on waqf.

"One thing that is very disturbing is the violence that is taking place. If the matter is pending here then it should not happen," the CJ said. Echoing a similar sentiment, solicitor general Tushar Mehta, appearing for the Centre, said, "They (protesters) think they can pressurise the system by this."

Senior advocate Kapil Sibal, appearing for a Muslim organisation, opposed the submissions of the law officer and said, "Who is pressuring who

2025 LAW INFRINGES RELIGIOUS FREEDOM OF MUSLIMS TO MANAGE THEIR WAQFS, ARGUES KAPIL SIBAL

PTI, NEW DELHI: Senior advocate Kapil Sibal on Wednesday argued in the Supreme Court that the Waqf Amendment Act, 2025, infringed upon the religious freedom of Muslims in managing their religious and charitable institutions. Arguing before a bench of Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and K V Viswanathan, Sibal referred to the contentious provisions and listed out the objections of Muslim bodies and other petitioners. The top court, during the course of the hearing, proposed to stay certain key provisions of the Act including the power to denotify properties declared waqf by courts and inclusion of non-Muslims in central Waqf councils and boards. "How can the state decide whether and how, I am a Muslim or not, and hence, eligible to create a waqf?" Sibal asked. The new law says a person has to be a practising Muslim for the last five years to create a waqf, he added. Sibal referred to Article 26 of the Constitution, saying subject to public order, morality, and health, every religious denomination has the right to establish and maintain institutions for religious and charitable purposes and manage its own affairs in matters of religion. He said Muslims have the right to own and acquire property as waqfs and legally administer them. "These are fundamental rights and any law impinging on essential religious practices or property rights must be reasonable and proportionate," he added.

Rajesh Kujur, a resident of Dalki village in Raiboga police station area, sustained a head injury due to a fall at the special jail in Rourkela, officials said.

He was immediately admitted to the Rourkela Government Hospital, where he died, they said.

His wife Amrita alleged that her husband was murdered in judicial custody.

West Bengal teachers stage protest at Delhi's Jantar Mantar

PTI, NEW DELHI: A group of teachers and non-teaching staff from West Bengal, who lost their jobs following a Supreme Court verdict in a case on irregularities in their recruitment process, staged a protest at Delhi's Jantar Mantar on Wednesday, demanding to be reinstated.

The teachers, who have been agitating in West Bengal, staged the protest here under the banner of "Jogyo Shikkok Shikkhika Adhikar Manch", a platform advocating for the reinstatement of those who had cleared the exam on merit.

The protesting teachers and non-teaching staff said the SSC failed in distinguishing between fraudulent and legitimate candidates, leading to a blanket cancellation of

appointments, adding that they have urged the state government and the commission to devise a mechanism to reinstate the deserving candidates.

Chinmoy Mondal, one of the teachers appointed in 2019, following the examination held in 2016 that is under the scanner, said they have come to Delhi to

make an appeal to President Droupadi Murmu and Prime Minister Narendra Modi regarding their situation.

"We want to tell the people of the country how we are suffering. The education system is collapsing in our state and our rights are not being protected," Mondal told PTI.

Bomb threat to Palakkad RDO office via email was hoax: Police

PTI, PALAKKAD (KERALA): A bomb threat received via email at the Office of the Revenue Divisional Officer (RDO) here on Wednesday turned out to be a hoax, as no explosives were found during an inspection by the bomb and dog squads, police said.

"Nothing was found during the inspection carried out by the bomb disposal and dog squads. So, it was a hoax," a senior police officer told PTI. He further said the Cyber Cell division of the police is trying to identify the source of the email.

Earlier in the day, after receiving the threat, the staff and general public were evacuated from the RDO office premises. Subsequently, fire force personnel, the bomb dis-

posal unit, and the police dog squad were deployed to search the entire premises, as shown in visuals aired on TV channels.

Police said similar emails were received in other districts of the state as well. The content of the email, as shown on the TV channel, claimed that an RDX explosive had been planted at the RDO office and would detonate at 1.30 pm.

The email allegedly claimed the explosion was timed to coincide with the "elimination" of AIADMK General Secretary Edappadi K Palaniswami. Last month, bomb threats were also received via email at the district collector office in Thiruvananthapuram, Pathanamthitta, and Wayanad-all of which turned out to be hoaxes.

SC junks PIL for gender-neutral dowry harassment, maintenance sections; says it's up to Parliament

PTI, NEW DELHI: The Supreme Court Tuesday dismissed a PIL for making dowry harassment and maintenance provisions "gender neutral" to prevent their "misuse", saying courts cannot legislate law and it was up to the Parliamentarians to look into it.

During the hearing in the PIL filed by an NGO, its counsel submitted that there were instances of the provisions being misused to harass the husbands and their family members.

The bench of Justice Surya Kant and Justice N Kottiswar Singh, however, said, "We understand this would make a spicy news item, but tell us which provisions in law are not being misused?" It added that instead of the NGO, the aggrieved persons should have approached the court.

The PIL had sought making section 498A of IPC (dowry harassment) and section 125 of CrPC for payment of mainte-

nance "gender neutral". Dismissing the plea, the apex court bench said no sweeping statements could be made that the provisions meant for the protection and empowerment of women were "misused".

Observing that every case needs to be decided based on its own facts and circumstances, Justice Surya Kant said, "Where the husband or his family has been victimised, the law must take its course

accordingly. If a woman has been harassed, the law must come to her rescue also. So what is wrong with the provision?"

"We see no reason to interfere with the legislative policy/mandate behind Section 498A IPC, now read as Section 84 of the BNS," the bench said.

The plea that such provisions were violative of Article 14 is wholly misconceived and misdirected, it said, adding Article 15 of the Constitution explicitly

empowers Parliament to enact a special law for the protection of women and children.

"The allegation that the provision was being misused is vague and evasive as no opinion with respect thereto can be formed while exercising jurisdiction under Article 32 of the Constitution. Suffice it to observe that such an allegation can be examined on a case-to-case basis," the Supreme Court bench said.
