Meet CM on highway expansion issue; demand formal communication from Centre that aligns with Goa govt's assurances; Sawant says plan changes will delay the project

PANJIM: The residents of Bhoma on Monday stated that homes can be rebuilt, but the culture of the temple cannot, reiterating their demand that the Goa government should consider a bypass instead of a flyover. However, Chief Minister Pramod Sawant stated in reality, only a 25-metre-wide flyover is proposed at Bhoma and making changes to the plan would require fresh permissions, which would significantly delay the project.

Alleging that politics is being played over the highway expansion issue, the residents demanded a formal communication from the Centre that aligns with assurances given by the State government.

Speaking to mediapersons, after meeting Chief Minister Pramod Sawant over the long-pending issue of expansion of National Highway, the villagers said that during the meeting they were told that four roadside structures would be affected, but no houses or temples would be impacted.

Putu Gaude, a villager, said,

"We have been protesting for the past two-and-a-half years, and not a single official has visited our village. If this plan was made in 1999, why were land acquisition notices not issued then?"

Alleging that politics is being played over the highway expansion issue, he said that the firm decision of the villagers is that there should be a bypass road.

He said, "We are being asked to show the place where the bypass can be constructed. If we show the place then what is their role?

Pointing out that the original highway plan included two alternative routes, Kishore Naik, another resident, said, "We brought this to the Chief Minister's attention, but he was unwilling to discuss the bypass options. Our demand has been clear since 2010. We want a bypass, not a flyover. Our demand is firm. We want bypass only. This was assured by former Chief Minister late

Manohar Parrikar and Union

minister Shripad Naik." Alleging that the authorities are changing plans as per their requirement, another villager said, "We came here to meet the Chief Minister because our meeting with the MLA and discussion with him did not bear any fruit. Homes can be rebuilt but the culture of the temple cannot. If we have to save our village then we need a bypass."

ACB raids KR police station, seizes cash from cop's cabin

MARGAO: Following allegations of corruption, the Anti-Corruption Bureau (ACB) of the Goa Police conducted a raid at the Konkan Railway (KR) police station and seized Rs 25,000 from a police officer's cabin.

ACB sources reported that officers at the KR police station summoned a meat trader from Karnataka after seizing beef and demanded Rs 2 lakh from him. Allegedly the officers told the traders: "We have evidence that you are the main supplier of this consignment, but we will let you off if you pay Rs 2 lakh and allow you to continue your trade, provided you pay Rs 25,000 a month as protection money."

When the dealer refused to meet their demands, the officers threatened to arrest him. The dealer reportedly contacted senior officials in Paniim, recounting how the police had threatened him with false charges and arrest.

Sources indicate that after negotiations, the dealer agreed to pay Rs 25,000 per month to continue his trade. Subsequently, a police constable and a senior officer negotiated the deal. A trap was set, and the dealer went to the Konkan Railway Police Station and paid the money.

ACB personnel then raided the office and recovered the money from a senior officer's cabin.

Wife arrested in K'taka former DGP Om Prakash murder case

'Domestic violence' was the reason behind the extreme step: Pallavi

PTI, BENGALURU: Police probing former Karnataka DGP Om Prakash's murder case have arrested his wife Pallavi on a complaint by their son Kartikesh that he suspected that his mother and sister were involved in the murder.

Officer "Investigation has arrested Pallavi Om Prakash (64). She will be produced before the Magistrate," an officer said.

He added that the case has been transferred to the Central Crime Branch of Bengaluru (CCB) for further investigation.

Meanwhile, when police took Pallavi to the scene of crime, she told reporters present there that "domestic violence" was the reason behind the extreme step. "I rushed home (located in HSR Layout) and found police officers and people present on the spot. My father was lying in a pool of blood with injuries on his head and body. A broken bottle and a knife were there next to his body. He was then taken to St John's Hospital," he explained.

China's tough stand came against the backdrop of reports that several countries, against whom US President Donald Trump imposed varied tariffs, are now seeking to work out bilateral trade deals with Washington to resume their exports to access the lucrative US market.

Last week, the Wall Street Journal reported that the US plans to use tariff negotiations to pressure dozens of countries into imposing new barriers on trade with China.

Several countries and groups, including Japan, the EU and ASEAN, have lucrative trade with both China
