# Parents alarmed as tobacco sale near Margao schools continues unchecked

Sale of tobacco is prohibited within 100 yards of a school; parents say lack of regular monitoring is endangering their children; point out that shop sealed a few months ago is back in business

MARGAO: Despite previous enforcement action and clear legal prohibitions, the illegal sale of tobacco products near schools in Margao continues unabated — fuelling widespread concern among parents and citizens who warn that authorities are failing to protect students from harmful exposure and addiction.

The issue has returned to the spotlight after a shop, previously sealed by officials for violating anti-tobacco laws, was once again found selling tobacco products close to a school.

In February this year, enforcement authorities seized tobacco items worth Rs 1.5 lakh from the same establishment. Although the shop had been shut down at the time, locals report that it has since resumed operations and con-

tinues to sell tobacco in defiance of the law, raising serious concerns about the consistency and follow-through of en-

forcement in the area. Worried parents have stepped forward, stating that the unchecked sale of such products near schools is endangering children and teenagers. They allege that the cameras near school premises Awareness campaigns targeting

students and parents to educate them about the dangers of tobacco products- especially vapes

absence of regular monitoring has emboldened shopkeepers to flout the law with impunity.

"No regular checks on the shops located near educational institutions have encouraged the shop owners to continue this activity," said Rina D'Souza, a parent and resident of Margao. "The easy access to these products is drawing students towards them, putting their health and future at risk. There is an urgent need for authorities to carry out regular raids and ensure strict compli-

Echoing this, another parent, Amriz Fernandes, said, "Many times, school-going boys are seen standing near such shops during break time, often smoking or buying tobacco products. This is a serious issue that needs immediate attention."

Under the Cigarettes and Other Tobacco Products Act (COTPA), 2003, the sale of tobacco products is strictly prohibited within 100 yards of any educational institution.

Violations are punishable with fines and even imprisonment, and authorities are mandated to conduct regular inspections to ensure adherence.

When contacted, Additional Collector-I Srinet Kothwale acknowledged the issue and said

that enforcement agencies had already been directed to take immediate and sustained ac-

"The district administration is taking this matter very seriously. We cannot allow our students to fall prey to tobacco addiction. Regular checks are being conducted, and further steps will be taken as necessary," he stated.

Despite these assurances, parents and concerned citizens argue that the existing measures are falling short. They are calling for a more robust, transparent, and continuous enforcement strategy.

Community leaders also stress that the responsibility must be shared. "It's not just the job of the police or the administration," said a local social worker. "Parents, schools, and local NGOs need to work together to keep our children safe."

Appearing for the SWR, Deputy Solicitor General of India Pravin Faldessai informed the Court that the railways had halted the proposed works and would approach the Directorate of Settlement and Land Records (DSLR), City Sur-

vey, with relevant plans to prove that the railway project does not pass through the petitioner's land.

Representing the petitioner, senior advocate S S Kantak argued that the site contains coconut trees and saplings, which require regular watering. He claimed that the disruption of electricity had affected the water supply, placing the trees at risk. He urged the Court to grant a temporary electricity connection, which would enable the irrigation system to be used to water the plants. The matter has now been posted for further hearing on May 7.

### Electricity prices likely to be hiked for 3 years

5.95% tarrif hike proposed, public hearing on May 9, consumers may give feedback within 21 days

PANJIM: The Electricity Department has proposed an overall power tariff hike of 5.95% across consumer categories for the financial year 2025–26, under the Multi-Year Tariff (MYT) framework submitted to the Joint Electricity Regulatory Commission (JERC).

According to the department's petition, further hikes of 5.64% and 4.88% are proposed for the fiscal years 2026-27 and 2027-28, respectively. No tariff increases are planned for the financial years 2028-29 and 2029-30.

For domestic consumers, the proposed revision includes an increase of Rs 0.60 per kW per month in fixed charges, and an energy charge hike ranging from

Rs 0.06 to Rs 0.35 per kWh, depending on consumption slabs. The department estimates a revenue gap of Rs 408.76 crore for FY 2025–26, with projected revenue at Rs 3,081.97 crore against a net requirement of Rs 3,490.73 crore.

Two petitions have been submitted—one seeking approval of the Business Plan for the 4th MYT Control Period (FY 2025-30), and another for the true-up of FY 2023–24 and tariff determination. The petitions are available on the websites www.jercuts.gov.in and www.goaelectricity.gov.in.

Public objections and suggestions may be submitted within 21 days, in advance of the public hearing scheduled on 9 May 2025 at 10 am at the Institute Menezes Braganza Hall, Panjim.

### Margao to get 18 new pay parking zones; Traffic cell identifies 350+ vehicle slots

MARGAO: In a bid to streamline vehicle parking and ease congestion in the city, the Margao Traffic Cell has identified 18 new locations for the implementation of a pay parking system for both cars and two-wheelers. The system aims to offer systematic and organised parking, optimising available space while ensuring the safety of vehicles.

According to the proposal, over 350 cars and numerous two-wheelers can be accommodated across these identified spots.

The plan also includes a pilot phase at key congested areas such as Margao Square near SBI. Fatima Convent, and Isidore Baptista Road. (see box)

Additional spots identified for pay parking include the stretch from the Old Collectorate building to Grace Church Corner (Khadi Gramodyog Shop), and parts of Mariana Gracias Road, Francisco Luis Gomes Road and Francisco Road.

Around the MMC building on NH-66, with space reserved for MMC staff and omcial venicles

Open two-wheeler parking area near the Communidade building, designated for private vehicles From Vaz Enterprises (opposite Lohia Maidan) to Gaylin Restaurant, with capacity for 30 cars and two-wheelers

■ De Souza Chambers to Sadekar **Building (via Kris Kross & Cartier** Shop), accommodating 42 cars ■ Bajaj Allianz to Blue Isidore Dart Office near Adarsh High School, with 11

#### **Tanavade urges State** support for rly flyover

MARGAO: The Rajya Sabha MP Sadanand Shet Tanavade has urged the Goa government to support the long-pending demand for a railway flyover at Davorlim to ease traffic congestion.

Tanavade, who inspected the site on Thursday along with Navelim MLA Ulhas Tuenkar, panchayat members, and Konkan Railway officials, said the level crossingjust after Margao Railway Station—remains shut for up to 25 minutes per cycle due to the passage of 20-30 trains daily. This, he said, severely affects students, workers, and daily commuters.

"This is a key link between Davorlim and areas like Aquem-Baixo, Quepem, and Cuncolim. A flyover is essential, especially with the upcoming educational hub here." he said.

Tanavade noted that land acquisition will be a challenge and urged the Chief Minister to visit the site. He also called for coordination between the state, Konkan Railway, and South Western Railways to expedite the project.

"For the safety and convenience of the people, this issue must be addressed without delay," he concluded.

Rs 24.26 crore in

subsidies disbursed to

37,000 ryots in S Goa

Farmers urged to tap subsidies; organic

and collective farming get a boost as

government steps up support

MARGAO: At a time when farmers are demanding greater support from the government, the Agriculture Department has revealed that subsidies amounting to Rs 24.26 crore were distributed to 37,685 beneficiaries in South Goa during the financial year 2024-25.

The subsidies were disbursed under various state schemes aimed at boosting agricultural productivity, promoting mechanisation, and supporting sustainable

District Agriculture Officer Rajesh Prabhudesai stated that the highest subsidy-Rs 1.97 crorewas released under the Support Price Scheme, which provides compensation for crops such as coconut, rice, and cashew. This scheme benefited 6,101 farmers.

The second-largest allocation of Rs 3.95 crore was disbursed under the Farm Mechanisation Scheme, supporting services related to tractors, rice harvesting, and milling machinery. This alone benefited 19,298 farmers.

Prabhudesai explained that the South Goa District Agriculture Office, operational since 2014, implements these schemes across talukas including Salcete, Quepem, Sanguem, Dharbandora, Canacona, Mormugao, and Ponda. Proposals are processed at the district level and funds are transferred directly to farmers via the divisional agriculture offices. In line with the push for sus-

tainable agriculture, the government also promoted organic and collective farming. During the year, Rs 65.77 lakh was disbursed to 799 farmers under the Organic Farming Scheme, and Rs 35.50 lakh was provided to six groups practising Collective Farming.

Prabhudesai encouraged more farmers to take advantage of the schemes, particularly to bring unused farmland back into cultivation. However, he acknowledged that some subsidy applications remain pending due to funding limitations.

### Benaulim beach parking lot 'hub of nuisance and neglect', complain locals

MARGAO: A formal complaint has been lodged with the South Goa Superintendent of Police (SP), regarding the alarming state of the Benaulim public parking lot. Social worker Warren Alemao met with authorities to raise concerns about the facility becoming a hub for illegal activities during nighttime.

In his written complaint Alemao said, "Every night, this area transforms into a hotspot for illegal activities, with drunken miscreants littering, drug peddlers operating freely, and absolute lawlessness prevailing." He emphasised that "the absence of police enforcement has made it a haven for criminal elements, putting

the safety of locals and tourists at risk."

Alemao informed the Superintendent that "despite multiple concerns raised by the community, no concrete action has been taken." He has specifically requested "immediate police patrolling and strict enforcement of the law" in the area. This complaint follows longstanding concerns from residents about the misuse of the government car park. Residents have complained that groups gather after dark, consuming alcohol and playing loud music.

Local residents have specifically called for CCTV surveillance and increased police presence, particularly concerned about "the safety of women, especially young female tourists".
