**ALL-PARTY MEET ON PAHALGAM**

# Leaders seek action against terror camps, assure govt of full support

**PTI, NEW DELHI:** Leaders across party lines on Thursday assured their support to the government in taking decisive action against terrorism and destroying terror camps, even as they flagged security lapses in Jammu and Kashmir's Pahalgam, where 26 people were gunned down by terrorists.

During an all-party meeting to discuss the April 22 Pahalgam terror attack, the government said it was taking all measures to ensure security. It noted that the attack was aimed at vitiating the atmosphere at a time when the economy was on the upswing and tourism was booming in Jammu and Kashmir.

The government did not spell out any kind of action against terrorism during the meeting and the opposition also did not seek any such details.

After the meeting, all leaders assured their full support to any government action against the perpetrators of the terror attack.

Minister Kiren Rijiju said everyone agreed that India should fight terror unilaterally and all parties said that they are with the government in this fight.

All political parties have given this message and their leaders have said in one voice that whatever step the government takes, they will support it.

Leader of Opposition in Lok Sabha Rahul Gandhi

said everyone at the meeting unequivocally condemned the terror attack and offered full support to the government. He also raised the issue of security lapses at the tourist spot, asking why no security personnel were deputed there, sources said.

Leader of Opposition in Rajya Sabha and Congress president Mallikarjun Kharge said there has

been a security lapse and the government did not act promptly after the attack.

"We will support the government decision in the best interest of the nation," he said.

TMC's Sudip Bandyopadhyay demanded that the prime minister convene a meeting of all party chiefs at the earliest.

Sanjay Singh said all parties demanded action by

the government for the destruction of terror camps.

Bandhyopadhyay said the issue of possible security lapses was also discussed but the opposition assured that it was with the government in the fight against terrorism.

"The nation must be totally united in this fight to eliminate terrorism," he said.

The government briefed leaders of various political parties on the Pahalgam terror attack and heard their views at the all-party meeting here.

At the beginning of the meeting, a moment of silence was observed for the victims of the attack.

While Defence Minister Rajnath Singh initiated the discussion at the meeting, Intelligence Bureau Director Tapan Deka gave all leaders a 20-minute briefing on the attack and how it happened. Later, he answered the questions of several leaders and Home Minister Amit Shah joined him in answering the queries.

External Affairs Minister S Jaishankar and Finance Minister Nirmala Sitharaman were also present at the meeting from the government's side.

## Raised Modi's absence at all-party meet: Kharge

**Expressed support for whatever action government takes**

**PTI, NEW DELHI:** Congress president Mallikarjun Kharge said the opposition raised the issue of Prime Minister Modi's absence at Thursday's crucial all-party meeting on the Pahalgam terror attack as well as the "security lapse" in the incident but extended full support to the government in dealing with terrorism.

pointed out that PM Modi should have joined the meeting because he has the power to take the final decision.

"We emphasised that his (PM's) presence is important as he can take decisions but they (government) said that they will explain (or brief) later. We said explaining is one thing and taking a decision by hearing things first hand is another," the Congress president said.

"Secondly, we raised the question about the security lapse... There is three-tier security but in spite of that, how did such a lapse take place and a lot of innocents have died," Kharge said.

## 6 Naxalites carrying ₹17 l bounty surrender in Chhattisgarh

**PTI, NARAYANPUR/ KAWARDHA:** Six Naxalites, including a couple, carrying a cumulative bounty of Rs 17 lakh on their heads, surrendered before security forces in two districts of Chhattisgarh on Thursday, officials said.

While four Naxalites surrendered in Narayanpur district, the couple laid down arms in Kawardha town in Kabirdham district, they said.

The four Naxalites - Sameer Kashyap, Baisakhu Nureti alias Deval alias Amit, Phulmati alias Phulo and Kamal Singh alias Kamalesh Usendi - turned themselves in citing disappointment with the "holow" and "inhuman" Maoist ideology and growing differences within the Maoist outfit, a police official said.

They were active in the Kutul Area Committee of the Naxal organisation, he said. Amit, who carried a reward of Rs 5 lakh, was active as a press team commander/Area Committee Member (ACM) of the outlawed Maoist outfit, he added.

Kashyap was Maad Division Communication team Commander, Phulo was Local Organisation Squad (LOS) as well as press team member and Kamlesh was a militia member, the official said. Kashyap had a reward of Rs 3 lakh and two others carried a bounty of Rs 1 lakh each on their heads, he added.

They were also impressed by the state government's 'Niyad Nellanar' (your good village) scheme, aimed at facilitating development works in remote villages around security camps, he said, adding that 101 Naxalites have quit violence in the district so far this year.

The surrendered Naxalites were provided assistance of Rs 50,000 each and will be further rehabilitated as per the government's policy, he said.

The couple, who surrendered in Kabirdham, was identified as Ramesh alias Atam Guddu (29) and his wife Savita alias Laxhi Oyam (21). They laid down arms in Kawardha town.

## Delhi: FIR against AAP MLA for 'assault' on ex-legislator

**PTI, NEW DELHI:** The Delhi Police has registered an FIR against AAP MLA Virender Kadian in connection with an alleged assault on former BJP legislator Suresh Singh at a wedding function in Outer North Delhi's Alipur, a senior official said on Thursday. Kadian, the MLA from Delhi Cantonment, refuted the claim and accused Singh of filing "fake" cases against him.

The incident allegedly took place on April 20 at a farmhouse.

An FIR on Singh's complaint was lodged against Kadian at the Alipur police station on Wednesday under sections 115(2) (punishment for voluntarily causing hurt), 126(2) (wrongful restraint), 351(3) (criminal intimidation) and 3(5) (joint liability) of the Bharatiya Nyaya Sanhita (BNS).

In his statement to police, Singh alleged that Kadian issued threats regarding a case lodged against his son and, along with his associates, allegedly assaulted and abused him in public.

## MONEY LAUNDERING CASE ED arrests former Rajasthan minister Mahesh Joshi

**PTI, NEW DELHI/ JAIPUR:** The Enforcement Directorate Thursday arrested Congress leader and former Rajasthan minister Mahesh Joshi in a money laundering case linked to alleged irregularities in the Jal Jeevan Mission scheme, officials said.

Joshi, 70, was taken into custody under the Prevention of Money Laundering Act by the federal probe agency after about seven-eight hours of questioning at its office in Jaipur, they said.

He is expected to be produced before a special

PMLA court in Jaipur on Friday where the ED will seek his remand for sustained interrogation.

The ED's money laundering case stems from an FIR registered by Rajasthan's Anti-Corruption Bureau to probe the alleged irregularities in the scheme that aims to provide safe and adequate drinking water through household tap connections.

The scheme was being implemented in Rajasthan by the state's Public Health Engineering Department during the previous Ashok Gehlot govt.
