PICNIC AT DUDHSAGAR RIVER

PONDA: Anand Belegal, a 32-year-old resident of Shantinagar, Vasco, drowned during a picnic at the Dudhsagar river in Davkon, Dharbandora. According to Collem police, Belegal had arrived at the site around 5.30 pm yesterday with three friends. While his friends were bathing, he reportedly went missing. A search operation was immediately launched, and a missing person report was filed. His body was recovered from the river this morning. The deceased was sent for post-mortem examination at South Goa District Hospital (SGDH), Margao, where a police surgeon confirmed the cause of death as "asphyxia as a result of drowning in water."

LPG CYLINDER BLAST GUTS HUT;

SANGUEM: A hut was completely gutted in a fire triggered by an LPG cylinder blast late last night at Velipwada, Bhatim in Sanguem. The hut owner, Shrimati Gaonkar, and her young daughter had a narrow escape as they were at a neighbour's house at the time of the incident. The blaze destroyed all house-

MARGAO: A fire broke out in a shop near Madina Hotel at Gandhi Market, Margao, causing damage but fortunately resulting in no injuries. The incident occurred two days ago and was attended by firefighters from the Margao Fire Station. According to Station Fire Officer (SFO) Gil Souza, the team was alerted after passers-by noticed smoke and attempted to control the fire themselves before alerting emergency ervices. One fire tender, led by SFO Gil Souza, was deployed, and it took over an hour to bring the blaze under control. Leading Firefighter P P Dessai conducted the operation. While the extent of the damage is yet to be assessed, there were no casualties. The cause of the fire remains unknown. SFO Souza stated that the department will write to the Electricity Department to determine the origin of the blaze. In a separate incident, a mango tree fell onto a footpath in Benaulim. Sub-Officer A K Velip and a team of firefighters responded and successfully cleared the area.

MARGAO: Francisco Martinho Pereira, 61, of Chadwaddo, Davorlim, who held a Portuguese national passport, passed away at his residence. Maina-Curtorim Police stated that they were informed after Pereira was brought dead to SGDH, Margao, by a 108 ambulance. Enquiries revealed that the deceased. who was residing with his mother, had been suffering from a heart condition. The body has been preserved at the SGDH morgue for medico-legal formalities.
