Russia launches 150 drones at Ukraine as **Trump doubts Putin's peace intentions**

sweeping drone assault and airstrikes across Ukraine early Sunday, killing at least four people, officials said, after US President Donald Trump cast doubt over Russian President Vladimir Putin's willingness to end

Three people died and four were wounded in airstrikes on Kostyantynivka in the Donetsk region of eastern Ukraine, the regional prosecutor's office said.

Another person died and a 14-year-old girl was wounded in a drone attack on the city of Pavlohrad in the Dnipropetrovsk region, which was hit for the third consecutive night, Gov. Serhii Lysak said.

The attacks came hours after Russia claimed to have regained control over the remaining parts of the Kursk region that Ukrainian forces seized in a surprise incursion in August 2024.

Trump said Saturday he doubts Putin wants to end the more than 3-year-old war, expressing new scepticism a peace deal can be reached soon. Only a day earlier, Trump had said Ukraine and Russia were very close to a deal."

"There was no reason for Putin to be shooting missiles into civilian areas, cities and towns, over the

last few days," Trump wrote in a social media post as he flew back to the US after attending the funeral of Pope Francis at the Vatican, where he met briefly with Ukrainian President Volodymyr Zelenskyy. Trump also hinted at further sanctions against Russia.

US Secretary of State Marco Rubio said Sunday the coming week would be "very critical," and that the US would need to "make a determination about whether this is an endeavour that we want to continue to be involved in."

Asked on NBC's "Meet the Press" about possible concessions to Russia. Rubio emphasised the need to be 'grownups and realistic."

"There is no military solu-

tion to this war. The only solution to this war is a negotiated settlement where both sides are going to have to give up something they claim to want and are going to have to give the other side something they wish they didn't," he said.

Russia fired 149 exploding drones and decoys in the latest wave of attacks, the Ukrainian air force said, adding that 57 were intercepted and another 67 iammed.

Thousands pay respects before Pope Francis' tomb in Rome

AP, VATICAN CITY: Roman Catholic faithful began visiting the tomb of Pope Francis on Sunday, filing past the simple white tomb in St. Mary Major Basilica a day after he was bade farewell by the powerful of the world and a crowd of hundreds of thousands.

A single white rose was placed on the tomb that said "Franciscus" — the pope's name in Latin. A light cast its warm glow over the tomb and a reproduction of the late pontiff's pectoral cross on the wall above it.

People filed past, many crossing themselves or snapping photos with their phones. Ushers urged them to keep moving to accommodate the thousands who flocked to the Rome basilica to see the tomb, forming a long line outside.

"Pope Francis for me was an inspiration, a guide," said Elias Caraval-

respects to Francis when the body was lying in state in St. Peter's Basilica after his death on Easter Monday at the age of 88. He said he visited the tomb "to thank him for what he has done."

The tomb was opened on the second of nine days of official mourning for Francis, after which a conclave will be held to elect the next pope.

A special Mass was also celebrated in St. Peter's Square on Sunday by Cardinal Pietro Parolin, the Vatican's secretary of state. Parolin is considered a possible contender to be the next pope due to his prominence in the Catholic hierarchy.

No date has yet been set for the conclave, but it is expected to start between May 5 and May 10. Cardinals who travelled to Rome for Francis' funeral will be meeting regularly this week ahead of the conclave as they start to chart a way forward for the 1.4 billion-strong Catholic Church.

UK counter-terror police probe crossbow, firearm attack in England

PTI. LONDON: Britain's counter-terrorism police are investigating an attack involving a crossbow and a firearm, which resulted in two women being seriously injured in northern England.

West Yorkshire Police said its officers were called at the scene in the city of Leeds on Saturday to find two women injured and a 38-year-old man with a self-inflicted injury. All three were rushed to hospital, with the man held under arrest and the two weapons being recovered

from the scene. The police said extensive enquiries continue to establish the full circumstances of the "serious incident" and explore any potential motivation.

The assault has not been designated a terrorist attack as West Yorkshire investigation continues.

Police said the force is "keeping an open mind as we are gathering as much information as possible to find out exactly what happened".

"Although our enquiries are still at a very early stage, the circumstances surrounding this incident have resulted in Counter Terrorism Policing taking the lead for this investigation," said Detective Chief Superintendent Dunkerley, Head of Counter

Terror Policing North East. "From the enquiries undertaken so far, there is no evidence to suggest anyone else was involved in the attack. and. at this time, we are not looking for anyone else in relation to the incident" he said

US deploys anti-ship missiles in Philippines, stages drills near China flashpoints

AP, BATAN ISLAND (PHIL-IPPINES): The US military has deployed an anti-ship missile launcher for the first time on Batan Island in the Philippines, as Marines unloaded the high-precision weapon on the northern tip of the archipelago, just a sea border away from Taiwan.

US and Philippine forces separately unleashed a barrage of missile and artillery fire that shot down several drones acting as hostile aircraft in live-fire drills on Sunday in Zambales province facing the disputed South China Sea.

The mock battle scenarios over the weekend in the annual Balikatan exercises between the US and its oldest treaty ally in Asia, the Philippines, not only simulated real-life war.

Insurance Amendment Bill set for monsoon session The proposed amendment primarily focuses on promoting policyholders'

PTI, NEW DELHI: The Insurance Amendment Bill, which proposes 100% FDI in the insurance sector, may be introduced in Parliament in the upcoming monsoon session, sources said.

The draft bill is ready and will be placed before Cabinet for its approval soon, sources said, adding, after Cabinet nod the Department of Financial Services under the finance ministry would begin the process for introduction of the Bill in the Parliament.

The ministry hopes to table the Bill in Parliament during the upcoming monsoon session, sources said.

Monsoon session of Parliament usually commences in July.

Finance Minister Nirmala Sitharaman in this year's Budget speech proposed to raise the foreign investment limit to 100% from existing 74% in the insurance sector as part of new-generation financial sector reforms.

"This enhanced limit will be available for those companies which invest the entire premium in India. The current guardrails and conditionalities associated with foreign investment will be reviewed and simplified," she had said.

China lowers min amount for tax refunds for tourists to boost spending

AP, BEIJING: China announced a lower threshold for tax refunds for foreign tourists among a series of policies on Sunday to boost consumption as its economy comes under pressure during a trade war between Beijing and Washington.

Travelers can apply for a tax refund if they spend 200 yuan (about \$27) at the same store on the same day and meet other requirements starting Saturday, according to a joint statement by the Ministry of Commerce and other authorities. Previously, the minimum amount was 500 yuan (about \$69).

The upper limit for their tax rebate in cash also has been doubled to 20,000 yuan (\$2,745).

The government will expand the coverage of tax refund shops and streamline the procedures. Officials encourage some regions to set up refund points for travellers to get rebates immediately after their purchases in areas highly concentrated with tourists, the statement said.
