'Surla not a wasteland': Greens say no to 'eco-tourism' project

Campaign promoted by Goa Foundation and Save Mollem demands scrapping the proposed project inside Mhadei Wildlife Sanctuary — home to tigers, other rare flora & fauna

MARGAO: A petition promoted by environmental groups including the Goa Foundation and the Save Mollem campaign is gaining traction, calling on the Goa government to revoke permissions for a proposed 'eco-tourism' project on the Surla Plateau. The campaign warns that the plan, which is to be located within the Mhadei Wildlife Sanctuary, threatens to destroy a highly sensitive laterite ecosystem that supports several endemic species and protected wildlife, including the tiger. Citing scientific research and court directives, the petition accuses authorities of greenwashing and urges that the plateau be conserved instead of developed.

The petition, which has attracted a large number of signatures, stresses that high-altitude laterite plateaus like Surla are wrongly **ENVIRONMENTALISTS ALLEGE**

labelled as barren 'wastelands', when in fact they are rich ecological zones. Research has documented over 300 plant species on such tablelands, particu-larly monsoon-dependent herbaceous species. These seasonal blooms play a crucial role in sustaining pollinators like bees and flies, while the grassy terrain serves as vital habitat for open-area bird species such as Malabar larks and quails.

Surla Plateau is also home to rare fauna, with recent studies identifying species like the scorpion

Hottentota vinchu and the frog Fejervarya goemchi, both considered range-restricted and possibly endemic to the area. Wildlife such as sloth bears, leopards, pangolins, and gaurlisted under Schedule 1 of the Wildlife Protection Act—have been observed in the area. Of particular concern is the confirmed presence of tigers, with camera traps capturing images of the animal on the plateau and in adjoining

The petition underscores that the Surla Plateau lies within the Mhadei Wildlife

largest and most biodiverse protected areas—and that the National Tiger Conservation Authority, along with the Bombay High Court at Goa, has already directed the state government to declare the sanctuary a tiger reserve. Despite this, no clearance has been obtained from the NTCA for the proposed tourism de-

velopment.

Environmentalists are also concerned that the plateau's categorisation under the Wasteland Atlas of India has facilitated its vulnerability to infrastructure projects. Across Goa, similar laterite tablelands have been concretised for industrial estates and townships—such as those at Verna, Kundaim, Colvale, Kadamba, and Mopa-leading to ecological consequences, including reports of wells drying up in nearby villages.

In a joint social media

Sanctuary—one of Goa's appeal, Goa Foundation and the Save Mollem campaign described the effort as an "urgent campaign" to prevent irreversible ecological damage. "Mhadei Wildlife Sanctuary is one of the most biodiverse forests in India, home to endemic species and the majestic tiger. But the Goa Forest Department, instead of prioritising its protection, is planning to destroy a sensitive

groups stated. They warned that the project could interfere with tiger movement and harm the hundreds of unique species found in this ecosystem. "We urge the Goa Government and Forest Department to cancel this proposed project," they said, encouraging citizens to read, sign, and share the petition in support of the

After Kharebhand fire, delay in structural report raises concern

MARGAO: Concerns are mounting among residents after a major fire recently broke out in a multi-storey residential building at Kharebhand, Margao. While emergency services responded swiftly and no casualties were reported, the authorities' continued delay in releasing a structural stability report has sparked widespread anxiety and allegations of negligence. The fire, which caused significant damage, led to the immediate evacuation of several families. Local authorities were expected to conduct a structural audit to assess the safety of the building before allowing residents to return. However, despite the urgency and visible damage, no official report has been made public to date. This has prompted criticism from displaced residents and civil society groups, who have

accused the authorities of poor communication and lack of transparency. "We were told that an assessment would be carried out immediately, but it's been days and there's no word from the authorities. Are they waiting for something worse to happen?" questioned Savio Coutinho, echoing the frustration of several affected families. Attempts by **O Heraldo** to reach Margao Municipal Council (MMC) Chief Officer Melvyn Vas went unanswered. However, MMC Chairperson Shirodkar confirmed that inspections had been carried out. Court to decide on bail plea of suspended Konkan Rly PI today

MARGAO: The bail application of suspended Police Inspector (PI) Sunil Gudlar, attached to the Konkan Railway Police Station and recently arrested by the Directorate of Vigilance's Anti-Corruption Branch (ACB), came up for hearing before the Additional District and Sessions Judge court has re-

served its order for Tuesday, April 30. PI Gudlar

was arrested for allegedly demanding and accepting a bribe of Rs 25,000 from a meat trader from Belagavi.

During Monday's hearing, the court heard arguments from both sides after having issued notices to the ACB, the public prosecutor, and the defence counsel.

Public Prosecutor V.G. Costa strongly opposed the bail plea, arguing that the investigation is still in its preliminary stage and that custodial interrogation is necessary. He expressed concerns that the accused may tamper with evidence or influence witnesses if released on bail.

Defence advocate Galileo Teles, appearing for PI Gudlar, countered that the

police response submitted in court does not establish that his client demanded or accepted any bribe. He noted that the original FIR was registered against a police constable named Hussain. also attached to the same police station, and not against Gudlar.

Teles argued that Gudlar was not present at the scene during the ACB raid, in Margao on Monday. The and according to the police

April 21 for patrolling duty. Gudlar, he said, was later brought back from outside the station premises after the trap was already exe-In his bail application,

Gudlar stated that the complaint was originally filed against Constable Hussain and that the complainant had never named him in the case. He further claimed that he had made a diary entry documenting his departure for patrolling duty prior to the raid and has had no interaction with the complainant at any stage.

He also denied interfering in the investigation of the case, maintaining that he has been falsely implicated.

caterer dumping garbage on plateau

MARGAO: Α Loutolim-based caterer was caught red-handed on Monday illegally dumping wet waste on the village plateau, sparking outrage among residents and prompting official action.

The waste was dumped on land belonging to the Communidade of Loutolim. Alert villagers, acting on suspicion, confronted the individual as he offloaded a large quantity of food waste.

The accused, reportedly linked to a local catering business, allegedly claimed he had received verbal permission from the panchayat secretary to dispose of waste at the site.

However, this claim was



swiftly and firmly denied by the Loutolim Village Panchayat. Sarpanch Joana Fernandes clarified that while the catering unit had been issued a No Objection Certificate (NOC) to operate, no permission had ever been given for dumping waste on communidade

"Neither the panchayat nor the secretary has granted any kind of permission for dumping waste on communidade land. It was clearly communicated to the business owner that managing their waste would be their own responsibility," Fernandes said.

lodged a police complaint against the caterer for unauthorised dumping and creating a public nuisance.

Blaise Brito, President of the Communidade of Loutolim, who visited the site after the incident, said, "We caught the accused red-handed while disposing of wet waste. His claim that the panchayat gave him permission is both false and deeply troubling. Such environmental neg-

ligence will not be tolerated. We are committed to protecting communidade land," Brito said. The incident has intensified long-standing concerns among villagers over the lack of oversight on waste disposal by businesses operating in the area. Residents are now calling for the panchayat to impose stricter conditions on enterprises like caterers. hotels, and event venues, which tend to generate substantial amounts of waste.

"This is not an isolated incident. We've been dealing with similar problems for a while now. If strong action isn't taken, we risk long-term environmental degradation," said one concerned resident.

FDA shuts down three unhygenic food businesses

MARGAO: The South Goa team of the Food and Drugs Administration (FDA) recently carried out an inspection drive in Salcete taluka, targeting food manufacturing and service establishments for hygiene and safety compliance. The inspections, which covered two manufacturing units and one restaurant, led to all three being ordered to shut down until corrective measures are implemented.

The first unit, a bakery, was found operating in deplorable sanitary conditions. Officials noted dirty floors, peeling paint, exposed wiring, and unclean storage trays. The facility lacked essential infrastructure, including proper washing areas, pest control certification, and sanitary cards for employees. Authorities ordered the immediate suspension of operations and asked the



chips manufacturing unit was discovered cooking food in the open, on a public footpath, without basic facilities such as washing stations or an exhaust system. None of the products bore proper labelling, and the unit had no valid operating licence despite previous warnings. Items worth Rs 20,000 were seized and marked for destruction. The operator has been instructed to cease all business activities until necessary licences are obtained.

The third establishment, a restaurant in the Margao market area, was found in a deteriorated condition with broken tiles, soot-covered walls, an open toilet, and a defunct exhaust system. The premises had no documentation of pest control or hygiene practices. It too was directed to stop operations and initiate urgent repairs and upgrades.

The inspection was led by Designated Officer Sanjyot Kudalkar along with Food Safety Officers Madhav Kavlekar, Pradiksha Chopdekar, and Amardeep Gaude.

WHERE GOANS ARE HEARD

Residents of Old Goa are protesting the government's decision to relocate the Old Goa Police Station to the Exposition Secretariat site, in front of the iconic Basilica. Activists have long demanded a Master Plan to curb illegal constructions in the heritage area

The temporary structure was erected for a particular purpose - for the Exposition. As per the permission of the Archeological Survey of India, it was only for 45 days and it would be demolished thereafter within 10 days. Four months later, it has still not been demolished. Now they have given it as a temporary structure for the Old Goa police station. It is necessary that the ASI answer for this because it is within the 200 metre zone of the UNESCO World Heritage site - Mariano Ferrao, social activist

I don't think the government has understood the value of the Old Goa UNESCO Heritage site. Otherwise what is the explanation for all the illegalities that are going on? Bringing the police station to the Exposition secretariat site, when it was assured that the office would be demolished. Now they are saying it is temporary, only till the police station building is built. The building will not come up for another two-and-a-half years. The sensitivity of the Old Goa heritage site seems to be lost on this government
