GOVT AGREES TO CASTE DATA IN NEXT CENSUS

Oppn claims victory, says BJP has been compelled to bow to the will of the majority

PTI, NEW DELHI: In a major Modi comes ahead of assemdecision, the government on Wednesday announced that caste enumeration will be included in the next census exercise in a 'transparent' manner and slammed the opposition parties for using caste survey as a 'political

The Congress and other opposition parties have been vociferously demanding a nationwide caste census, making it a major election issue, and some states like Bihar, Telangana and Karnataka have conducted such surveys.

The decision taken by the Cabinet Committee on Political Affairs(CCPA) at its meeting here presided by Prime Minister Narendra



bly elections in Bihar, where caste is a key political issue and several parties including some BJP allies have been coming out in support of the caste census.

The opposition parties said it is a victory for their long-standing demand and claimed that the BIP has been compelled to bow to the will of the majority.

Congress leader Rahul Gandhi had also raised the slogan of "jitni aabadi, utna haq" or proportional representation.

Announcing the decision taken by the CCPA at a news conference. Union Minister Ashwini Vaishnaw said the census comes under the purview of the Centre, but some states have done caste enumeration in the name of surveys "non-transparently" which has created doubts in the society.

Noting that caste was not included in all census operations conducted since Independence, Vaishnaw alleged that the Congress governments have always opposed caste census and the party had used the issue as a political tool.

Rahul wants time-line for its implementation

PTI, NEW DELHI: Former Congress president Rahul Gandhi on Wednesday said he welcomes the government's 'sudden' decision to include caste enumeration in the forthcoming census after '11 years of opposing it' but asserted that the Centre should give a time-line for its implementation.

Crediting the sustained campaign run by the Congress for the government's announcement on the caste census, Gandhi said his immediate suspicion is that this could go the women's bill way in terms of implementation and demanded a specific date for it.

Asserting that having "successfully pressured" the government to conduct a caste census, Gandhi said the Congress will break the "barrier" of 50 per cent cap on reservations and demand the implementation of Article 15(5), which pertains to reservations in private educational institutions.

"We urge the government to implement it (Article 15(5) promptly," the Leader of Opposition in

Lakhs paid to daily wagers in turtle zone raises corruption stink

Beach cleaning outsourced to pvt firm, but daily wagers were paid ₹31 L for same work

GALGIBAGA: The Wildlife and Eco Tourism division in South Goa has come under scrutiny after a payment estimate of nearly Rs 31 lakh was approved for daily wage workers reportedly



employed during the turtle nesting season despite official records indicating that beach cleaning services had already been outsourced to a private agency

Documents accessed by O Heraldo reveal that an estimate was submitted on January 1, 2025, seeking payment for daily wage labourers deployed between December 12, 2024, and February 28, 2025.

Far from smart: E-buses neither disabled-friendly nor digitally efficient

Contrary to claims made by Smart City CEO Sanjit Rodrigues on Tuesday, a ground check shows inaccessible ramps and overwhelmed drivers

PANJIM: A day after Imagine Panaji Smart City Development Limited (IPSCDL) claimed credit for efficiently operating 48 e-buses highlighting a revenue of Rs 1.93 crore in the first nine months — a reality check on the ground revealed a much starker picture.

One of the long-standing promises made since the launch of the e-bus fleet was that it would be disabled-friendly. IPSCDL CEO Sanjit Rodrigues stated, "All the buses are of low floor and have ramps which open out. If a wheelchair-bound person wants to get in, then each bus has a place for wheel chair inside. You just have to make a request to the driver."

However, conversations with several drivers painted a contrasting picture. While the ramps technically exist, they are rarely used or functional — due to

the lack of support staff. Speaking to **O Heraldo**,

Avelino D'Sa of the Disability Rights Association of Goa (DRAG) said, "They do have a ramp but there is no one to unroll it. If a disabled person wishes to board one of these buses, he or she cannot because there is nobody to as■ Drivers quitting jobs due to excessive workload of handling ticketing, digital payments and passenger management all by themselves

sist them. In Panjim, buses operate with a lone driver and he cannot get out of the bus to help the user. In order for it to be disabled-friendly, they should have another person who can take the ramp out and take the wheelchair in."

conductors: "There has to be conductors because it is not just a matter of putting the wheel chair inside but one has to climb onto the wheelchair. The conductor-less buses may be feasible for normal persons but in the case of disabled He stressed the need for persons, it doesn't help."

A driver echoed the same concerns, noting that driving itself is a specialised responsibility. "Having a conductor is must. If a disabled person tries to board a bus and he requires assistance, then how can the driver leave the steering to help him? When buses are full, what is the driver supposed to do? Will he handle the passengers, issue tickets or drive the vehicle? The work load of a driver increases when there is no conductor. The problem aggravates if the bus is caught n a traffic congestion.'

He further said: "If any untoward incident takes place, then driver is blamed. There is so much unemployment, I do not know why this concept is being introduced. At least some youth will get jobs if there are conductors in the buses. Conductor-less buses may work in foreign countries
