## NEET-UG held at over 5,400 centres under

strict security; sporadic incidents of protest NEW DELHI: More than 20.8 lakh students appeared for medical entrance exam NEET-UG on Sunday at more than 5,400 centres under strict security measures amid sporadic incidents of protest and arrest. More than 22.7 lakh candidates had registered for the exam, which was also conducted in 14 cities abroad. National Testing Agency (NTA) officials said more than 20.8 lakh candidates appeared for the exam. Mock drills were held at all National Eligibility cum Entrance Test-Undergraduate (NEET-UG) centres on Saturday to ensure smooth conduct of the nationwide exam. Most of the centres were located in government and government-aided schools, colleges, universities and institutions.

#### Senior citizen held for double murder in Delhi's Adarsh Nagar

NEW DELHI: A 65-year-old man wanted in a double murder case has been arrested, police said on Sunday. The accused, identified as Nand Kishore alias Thuria, a native of Rajasthan, is a history-sheeter whose criminal history spans over four decades. There is one more accused in the case; however, he remains large. According to police, the incident occurred in northwest Delhi's Adarsh Nagar area on April 21 when the victims, Kamal (40), Amzad (42) and Abid (26), were attacked by Thuria and the other assailant with a knife over a parking issue. While Abid sustained a few injuries but survived the attack, Kamal and Amzad succumbed to theirs, Deputy Commissioner of Police (Northwest) Bhisham Singh in a statement said

#### Murshidabad riots: Guv files report to MHA, says 'radicalisation' posing challenge to Bengal

KOLKATA: West Bengal Governor C V Ananda Bose has submitted a report on the recent riots in Murshidabad district to the Ministry of Home Affairs, stating that the "twin spectre of radicalisation and mi poses a serious challenge to the state. In the report, he suggested a few measures, including setting up an inquiry commission and outposts of central forces or the BSF in districts bordering Bangladesh, besides writing, "needless to add, the provisions under Article 356 of the Constitution also remain". The imposition of Art 356 refers to President's rule in a state. Asked about this, an official told PTI: "The governor has not proposed implementation of Art 356. He meant that the provisions of Art 356 are open to the Centre if the situation in the state further deteriorates."

# My responsibility to give befitting reply: Def Min

PTI, NEW DELHI: Defence Minister Rajnath Singh on Sunday said it is his responsibility to work with the armed forces and give a 'befitting reply' to those who cast an evil eye on India, his remarks coming in the backdrop of the recent Pahalgam terror attack.

Addressing an event here, Singh said people know Prime Minister Narendra Modi very well and are quite familiar with his working style, his determination and the way he has learned to "take risks" in his life.

"I want to assure you that under Prime Minister Modi's leadership, what vou desire will certainly happen," the senior Bharativa Janata Party (BJP) leader said, without elaborating.

His assertion, however, came as India is mulling retaliatory measures against Pakistan in view of the cross-border linkages to the April 22 Pahalgam terror attack that has killed 26 people, mostly tourists.

"As the defence minister, terror strike. Singh had said, "The government will it is my responsibility to work with my soldiers and take every step that is necessary and appropriate."

"We will not only trace those who perpetrated this incident, we will also reach out to those who, sitting behind the scene, have conspired to carry out the nefarious act on Indian soil," he had said.

Those involved in the attack in Jammu and Kashmir's Pahalgam will get a strong response in the

"near future" and India cannot be "intimidated" by such terrorist activities, the defence minister had asserted

The terror strike has drawn condemnation from several countries and world leaders.

Citing the "cross-border linkages" to the horrific attack, India has promised severe punishment to those involved in it.

New Delhi has already asserted that the "perpetrators, backers and planners" of the Pahalgam attack must be brought to justice. At a high-level meeting with the top defence brass on Tuesday, the prime minister said the armed forces have "complete operational

freedom" to decide on the mode, targets and timing of India's response to the terror strike, according to government sources. The prime minister also

affirmed that it is a national resolve to deal a crushing blow to terrorism, the sources said after the meeting.

#### Warren Buffett shocks shareholders by announcing his plan to retire at end of year

OMAHA: Billionaire Warren Buffett shocked an arena full of shareholders Saturday by announcing that he will retire at the end of the year, bringing the curtain down on a six-decade run leading Berkshire Hathaway that made him the most influential investor in the world. Buffett said he will recommend to Berkshire Hathaway's board on Sunday that Vice Chairman Greg Abel should replace him. "I think the time has arrived where Greg should become the chief executive officer of the company at year end," Buffett said. Abel has been Buffett's designated successor for years, and he already manages all of Berkshire's noninsurance businesses. But it was always assumed that he would not take over until after Buffett's death. Previously the 94-year-old Buffett always said he had no plans to retire. Buffett announced the news at the end of a five-hour question and answer period without taking any questions about it. He said the only board members who knew this was coming were his two children, Howard and Susie Buffett. Abel, who was sitting next to Buffett on stage, had no warning. Abel returned an hour later without Buffett to conduct the company's formal business meeting, and he responded to the news.

Monitor top advance tax payers, check fake claims: CBDT to I-T dept

PTI. NEW DELHI: The CBDT has directed income-tax officials to 'closely' monitor top advance tax payers and identify bogus claims of exemptions and deductions as part of the strategy to improve direct tax collections during the current financial year.

Official sources told PTI that the Central Board of Direct Taxes, the policy-making body for the department, had recently issued the central action plan (CAP) for 2025-26 that acts as the guiding light to steer 'key performance areas' for the department vis-à-vis revenue collection work.

The Union government has set a target of Rs 25.20 lakh crore for the I-T department under the direct taxes head for the current fiscal, as per the Budget estimates presented in February.

The sum consists of Rs 10,82,000 crore under the corporate tax head, Rs 13,60,000 crore under non-corporate taxes that includes personal income tax and others, and Rs 78,000 crore from securities transaction tax (STT).

The net direct tax collection for the 2024-25 FY narrowly missed the target, growing 13.57% to

over Rs 22.26 lakh crore, owing to issuance of the highest-ever amount of refunds issued, official data revealed.

The government had set a target of Rs 22,07,000 crore for the direct tax administration as per the budget receipt of July 2024 and revised it to Rs 22,37,000 crore during the budget presented in February.

The CAP has suggested the I-T department undertake a "sectoral analysis" for better tax collection by addressing "negative" trends of tax payments, a source said.

The plan has also sought "close" monitoring of top advance tax payers, including individuals and companies, and "encourage" them to reassess their advance tax liabilities if required, the person said.

Advance tax is the tax amount paid in advance through instalments in a financial year. It facilitates smooth tax collection for the government while preventing taxpayers from a lump sum tax burden at the year-end.

The department has also been asked to "identify" incorrect claims of exemptions and deductions that lead to loss of genuine revenue, the source said.

The CAP also recommended "profiling" of certain districts or regions for net positive or negative revenues and in cases where the revenue is not up to the mark, to take "suitable action."

The department has been asked to place "special emphasis" on collecting arrears and current demand and take action in case of 'non-compliant" tax payers.

It has also been asked to focus on collection of tax demand confirmed by the office of Commissioner of Income Tax (Appeals), the first appellate mechanism in the direct tax system available to taxpayers followed by various courts, high courts and the Supreme Court.

According to the official data, the CIT (Appeals) confirmed demands worth Rs 1.95 lakh crore in the 2024-25 fiscal and the assessing officers

have been asked to make "all possible" efforts to collect this revenue within the current financial year.

The CAP has also asked the tax department to conduct "outreach" programmes and enhance awareness among the taxpayers about correct claims for deductions and exemptions, and also educate them on filing updated Income Tax Returns — a provision that allows a certain period of time to those who missed reporting correct income, the source said.

These efforts stand to "potentially" result in significant increase in taxpayers opting for the new tax regime, where no deductions or exemptions are allowed against a flat rate of tax, thus reducing the misuse of deductions, the source said.

The tax department has also been asked to issue "prompt" refunds so that interest payments and "negative impact" on the overall Budget can be "avoided."

The department, as per data, issued the highest-ever refunds, Rs 4,76,743 crore, during the 2024-25 fiscal – an increase of 26.04% as compared to the Rs 3,78,255 crore issued in refunds during the 2023-24 fiscal.
