# **CROWD CONTROL ALARM SOUNDED TWO** DAYS BEFORE ZATRA

Temple committee says it had little time to act on police recommendations; CCTV and barricading was not feasible

PANJIM: A crucial meeting between the Shree Lairai Temple committee, North Goa police, and district administration was held just two days before the annual festival, leaving the temple authorities with only a day to act on several crowd management recommendations, a timeframe they claim was not feasible for implementing key safety measures like CCTV installation and barricading.

Six people died and several others were injured in a stampede at the Shree Lairai Temple in Shirgao village, North Goa, during the early hours of Saturday.

During the meeting held on April 30, authorities had instructed the temple committee to install CCTV cameras at the entrance and exit

reported to Goa Medical College is 21 while two have been discharged. Today we had 3 new admissions; some of them have reported one or two days after the event. The three patients who were admitted today had earlier gone to the District Hospital at Mapusa. One patient is being treated for brachial plexus injury, while two have rib fractures." Among the five patients initially reported to be in a serious condition, he said four were now

stable, while was in a

### Adani in talks with Trump admin to end **US bribery cases**

AGENCY, NEW DELHI: Representatives of businessman Gautam Adani have held meetings with officials from the Donald Trump-led US administration to discuss the possibility of dropping criminal charges filed against him in connection with an overseas bribery investigation, according

The meetings reportedly began earlier this year and have intensified in recent weeks. If the current pace continues, the matter could move towards resolution within a month.

According to the report, Adani's representatives have argued that the case does not align with President Donald Trump's current policy priorities and have requested that it be reconsidered. Adani, owner of the multinational conglomerate Adani Group, was indicted alongside his nephew, Sagar Adani.

## SC notices to Raina, four others over disability jokes

PTI, NEW DELHI: The Supreme Court on Monday directed five social media influencers, including "India's Got Latent" host Samay Raina, to appear before it or face coercive action after a plea alleged that they ridiculed persons having a rare disorder Spinal Muscular Atrophy (SMA) and those suffering from disability on their show.

The court termed the influenc-



ers' conduct as 'damaging' and 'demoralising' and said some serious remedial and punitive action was needed so that these things don't happen again. A bench of

Justices Surya Kant and N Kotiswar Singh observed that the fundamental right to freedom of speech and expression is not absolute.

## Field fire smokes residents out of Taleigao apartments

PANJIM: A fire that broke out in a dry grass field at Cambrabhat in Taleigao on Monday raged for over six hours before it was doused by fire tenders, causing panic in the surrounding residential areas and forcing some residents to evacuate from their apartments.

The blaze began around 11:30 am and sent thick plumes of smoke into nearby homes and flats. Residents reported that the fire, initially limited to a small patch of dry grass, rapidly spread across the field, overwhelming fire services despite their swift response. Fire tenders from Panjim

vorim Fire Stations were deployed to the scene. However, the lack of accessible roads to the field made it difficult for emergency personnel to fully control the

## After a brief pause, noise demons are back in Baga

Xavier Retreat House residents in distress as decibel levels rise; in a strange coincidence, noise was muted on day of cop and PCB inspection

BAGA, CALANGUTE/ VAGATOR: The cat-andmouse game between decibel violators and policemen - so far a regular feature in the Anjuna-Vagator belt - is now becoming common in Baga as well.

A few days after **0 Heraldo** highlighted the disturbance caused by noise from the Baga shacks for residents of Xavier Retreat House, a member of the Goa State Pollution Control Board (GSPCB) and Goa police conducted a surprise inspection at the Xavier Retreat House. was silence. No shack could be heard playing music," he said.

Father Pereira, however, expressed his surprise at the timing of the visit. "The day the O Heraldo report appeared, no loud music could be heard. unusual quiet. "There But what surprised me

was that a policeman and a GSPCB official arrived to check noise levels - and exactly on that day, no music could be

heard," he shared. However, on Saturday May 3 – a weekend party day - it was back to nor-

mal. Around 9.15 pm,

decibel readings outside the Retreat House indicated a high of 92 dB, with average readings fluctuating between 84 dB and a minimum of 76 dB. "It's ironic that when they come for an inspection, no music was played. It gives me the feeling that they are being pre-warned, or how else can you explain the noise tonight?" Father Pereira remarked.

Father Pereira further explained that after the shacks close for the night, loud music from nearby clubs continues until the early hours, disturbing the peaceful environment of the retreat.
