All three leaders have demanded the immediate reinstatement of the scheme, along with a clear and transparent explanation from the government on why it was withdrawn. They also urged Goans across the State to voice their opposition.

## Betalbatim farmers accuse hotel of 'blocking' access to their agricultural fields

#### Claim that the hotel encroached upon the nullah by erecting a gate recently

MARGAO: Tensions escalated in Betalbatim as farmers and residents protested against a hotel for "illegally" obstructing traditional access to their agricultural fields and encroaching upon a nullah.

The issue has reportedly been persisting for years with limited intervention from local authorities.

The point of contention is a gate recently erected by the hotel across the nullah.

The villagers asserted that this gate blocks a centuries-old pathway essential for nearly 40 farmers to reach their fields. They emphasised that this access route is ancestral and has been crucial for their agricultural activities for generations

"This path has been in use for several decades, possibly centuries. Blocking it has severely impacted our farming. There have been several inspections, but they've resulted in no action," said Fidol Pereira, a local farmer and resident.

environmental and landuse regulations. Their demands include the immediate removal of the gate and punitive measures against the hotel owner for these multiple violations.

The residents claim to have lodged complaints with various government departments and the local panchayat, since 2004. Despite these efforts and repeated follow-ups, no substantial measures have been implemented to address their grievances.

"The building does not have occupancy permissions. There are several illegalities, yet the panchayat has failed to act," said another protesting farmer.

Frustrated by the inaction from the authorities. the community has now sought the intervention of the higher authorities to resolve the critical issue. They have demanded the restoration of their traditional right of way and the protection of the natural water channel, which they

believe has been damaged

due to private develop-

The villagers have vowed to continue their protest until justice is delivered and their ancestral access is reinstated.

Sarpanch Anthony Fernandes, who was present during the recent inspection, acknowledged the villagers' concerns. He said that the Town and Country Planning (TCP) Department officials failed to turn up for the inspection despite being notified. Fernandes assured that the inspection report would be

## Margao municipality moves ahead to enhance urban greenery

Sonsoddo among three potential sites identified for afforestation

MARGAO: Moving forward with the State-wide directive to enhance urban greenery, the Margao Municipal Council (MMC) has identified three potential locations for afforestation, including the well-known Sonsoddo area.

Recently, a joint inspection was conducted at the Sonsoddo site, which involved both municipal officials and representatives from the Forest Department to assess the feasibility of this location.

The initiative stems from the Forest Department's instruction to all municipalities across the State to find suitable sites for afforestation. The overarching aim is to increase green cover within urban areas and lessen the negative impacts of rapid urbanisation.

Kamat noted, "The Margao Municipality has proposed three possible locations for afforestation, and we visited these sites today. Sonsoddo, in particular, has been identified as a priority area due to its potential for green development."

During the inspection, each proposed location was evaluated based on factors like soil quality, accessibility, adjacent land use, and the long-term viability for tree growth. The objective is to create tailored plantation plans emphasising native species, biodiversity preservation, and sustainable urban landscaping.

This initiative is in line with the broader state policy aimed at counteracting the urban

heat island effect, improv-

ing air quality, and restoring

ecological balance in densely populated urban centres. Officials believe that focused afforestation efforts within municipal limits will not only enhance the aesthetic appeal of cities but also provide lasting bene-

fits for climate resilience. The Forest Department will make the final decision on the sites after a thorough evaluation and will then work with the respective municipalities to carry out the plantation work. Community participation is also anticipated in the ongoing maintenance of these green spaces.

### Rape-accused doc hospitalised, Cong Mahilas want clinic sealed

MLA demands revoking clinic's licence

MARGAO: Following his arrest and remand in iudicial custody at Colvale Jail in the alleged sexual assault on a nurse, Dr Samuel Arawattigi has been admitted in the North Goa District Hospital at Mapusa citing health reasons with the Goa Pradesh Mahila Congress Committee demanding that his clinic be sealed immediately.

Cuncolim Police sources indicated that Dr Samuel is currently in the hospital under day and night police guard. Four officers have been assigned for this duty.

His bail application before the Sessions judge has been adjourned for hearing on May 8. The court has directed the Cuncolim Police. the defence lawyer, and the public prosecutor regard-

ing the bail application. Meanwhile the Mahila Congress strongly con-demned the incident and called for urgent action.

"The crime committed by Dr Samuel is of a serious nature and cannot be tolerated. As an immediate step, the clinic should be shut. We will not remain silent and continue to raise our voice until justice is served," said Pratiksha Khalap, Mahila Congress president.

District Congress President Savio D'Silva, Zilla Panchayat member Michelle Rebello, former ZP Moreno Rebelo, and several other party workers partic-

ipated in the protest. Highlighting concerns about women's safety in the State, D'Silva questioned the silence of the lo-

cal political leadership. "Our women are not safe. The local MLA should have taken a firm stand against such crimes in the Velim

constituency," he stated. Demanding justice for the victim, Michelle Rebello insisted that the safety and dignity of women should be non-negotiable. "We expect swift and strict action from the authorities," she said.

Meanwhile Velim MLA Cruz Silva demanded that Deussua-Chinchinim Village Panchayat revoke the licence of Dr Arawattigi's clinic in Chinchinim.

In a letter addressed to the panchayat, Silva stated that Dr Samuel has been arrested and remains in police custody following allegations of molestation and rape of a nurse employed at the clinic.

#### Say village biodiversity is under threat from unregulated development

'Concretisation' of Nuvem could

MARGAO: Residents of Nuvem are alarmed over the rapid and "unchecked" pace of construction and housing projects in their village.

Following similar concerns raised in Betalbatim, Nuvem residents warned that this uncontrolled development is pushing the village towards a potential environmental crisis.

During a recent gram sabha, the Nuvem Village Panchayat addressed these issues by passing a resolution urging the authorities to take immediate action to address the growing strain on the village's natural resources and existing infra-

structure.

A primary concern among residents is the ongoing "concretisation" of Nuvem, which they fear could lead to a severe water crisis. They worry that vital water sources will either dry up or become contaminated due to this unregulated development.

Jose Roque Andrade, a local environmentalist and expert, presented a detailed study on the village's carrying capacity, stating, "The living creatures, including humans, may soon suffer due to the non-availability

of clean water."

biodiversity, including forests, agricultural lands, hills, and water bodies, all of which are under threat from this rapid and unregulated development. Data obtained through

the Right to Information (RTI) Act reveals a significant surge in development between 2021 and 2024. The village panchayat issued 599 house numbers and 138 construction licences during this period. Simultaneously, the Public Works Department (PWD) provided 207 domestic and 34 commercial water connections, and the Electricity Department issued 585 connections across all categories.

Andrade said, "These numbers show a development rate that far exceeds what our village infrastructure and environment can handle.'

He cautioned that if this growth is not curbed, future generations will inherit a severely degraded environment, suffering the long-term consequences of current decisions.

A growing number of villagers are advocating for a slowdown in the rate of development. They argue that the current trajectory disproportionately benefits wealthy outsiders, leading to the displacement of local residents and a decline in biodiversity.
