After Nuvem, Varca locals demand ban on 'multi family dwellings'

Villagers urge P'yat to stop granting permissions for construction of residential complexes and row houses until carrying capacity of village is studied; cite strain on resources

MARGAO: At a public meeting held in Varca by concerned citizens, the locals demanded that the panchayat halt granting permissions to any multi-dwelling or other mega projects until a carrying capacity study of the village is first completed.

The meeting that was coordinated by youth activist Shohail Furtado, the locals shared concerns about how they, the original villagers, will soon be sidelined as the new population from the multi-dwelling units

that while the panchayat may say they are with the villagers in opposing such projects, the locals would need to see proof and get the panchayats to cancel licences to these projects and not grant any such licences in the future. This past Sunday, the

villagers of Nuvem at their Gram Sabha had unanimously resolved to call for a moratorium on multi-family dwelings in the village. The decision followed a detailed discussion on how rapid development is straining essential services and the local environment.

Fatorda, Arlem farmers want permanent fix for sewage sullying agricultural fields

MARGAO: Farmers from Arlem and Fatorda are calling for a permanent and long-term solution to the repeated leakage of sewage water into their agricultural fields—a problem that has been damaging crops, contaminating soil, and threatening their livelihoods for months.

While the issue has persisted for some time, local frustration recently prompted action. Local MLA Aleixo Reginaldo Lourenco, accompanied by officials from the Sewerage Department and affected farmers, conducted a site inspection to assess the situation firsthand.

"This is not just a farming issue-it's a public health crisis in the making. Despite the recent intervention, what we need is a permanent solution, not just a temporary fix," said

Quadros, who has been vocal about the issue, stressed that the sewage seepage stems from broken or poorly maintained underground pipelines. He emphasised that past attempts to resolve the matter have only offered short-term relief.

"The pipelines need to be replaced, and there must be regular monitoring to prevent recurrence," he added. "The leak may be stopped for now, but the fight is not over," said Quadros. "We need a permanent fix." Farmers allege that their repeated complaints to the ments responsible.

Sewerage and Infrastructure Development Corporation of Goa Ltd (SID-CGL) and the Public Works Department (PWD) were ignored until the MLA intervened.

Many now fear that the issue will be forgotten again. Environmental activists have also raised alarms over the potential longterm damage to soil fertility and nearby water sources due to untreated sewage. The farmers are now planning to approach the Goa State Pollution Control Board (GSPCB) and are urging the MLA to follow up with sustained oversight and pressure on the depart-

MARGAO: With fears mounting over job losses from the proposed privatisation of berths at Mormugao Port Authority (MPA), members of the Mormugao Stevedores Association met Goa Forward Party president Vijai Sardesai, seeking political support to halt the move.

The stevedores highlighted the worsening employment crisis, stating that over 1,200 workers have already been affected. Association president Lyndon Rodrigues warned that nearly 1,000 more could lose their jobs if privatisation goes ahead, severely impacting families and businesses dependent on port activity.

"This is not just about workers," said Rodrigues. "Privatisation threatens the entire ecosystem linked to the port."

South Goa police screen tenants, workers and foreigners in security op

MARGAO: In a nine-day operation to bolster public safety, South Goa police verified 9,209 tenants and 422 domestic workers across the district.

According to the district police headquarters, 125 strangers were verified, 48 persons arrested, and 1,353 individuals rounded up and questioned. Police also checked 315 foreigners and filled 76 C-Forms. Additionally, 123 Kashmiris were verified, and 423 hotels and guesthouses were inspected. Special nakabandis were set up at key locations, where suspicious vehicles were stopped, individuals interrogated, and preventive arrests made. Stranger rolls were updated, and combing operations were conducted in Zuarinagar, Mormugao, Sanguem, Fatorda, Canacona, Birla, and other sensitive areas. Police teams were also deployed at Margao, Canacona, and Curchorem railway stations, as well as bus stands in Margao and Ponda, to screen passengers arriving by train and interstate buses. C-Form verification for foreigners in hotels, guesthouses, and homestays was also carried out as part of the exercise.


Manora-Raia residents angered by unannounced power cut

MARGAO: Residents and business owners in Manora-Raia have voiced their anger following an unexpected power shutdown that left the area without electricity in the swel-

Residents have called on the electricity department to improve communication and provide advance notice of scheduled maintenance to prevent such disruptions

Assistencia also made it clear that the statements given by MoC regarding their departure were made by MoC directly and not by Assistencia.

Assistencia denied the accusation that they were preventing repairs over the last decade and pointed to a proposal worth approximately Rs 15 lakh for major repairs discussed with MoC years ago. Following these discussions, it was decided to continue with the original plan of reconstruction instead, given the poor condition of the premises.

This, Assistencia stressed, was never an attempt to evict MoC, as has been alleged.

Assistencia added that the plan was for MoC to continue using the premises post-reconstruction and that there is no plan to either sell the place or convert it into a commercial project, as has been alleged.

They pointed out that the property falls under the Institutional Zone of the Outline Development Plan (ODP) of Panjim, with Assistencia continuing to retain a smaller portion of the land.

Assistencia clarified that they are not part of the Archdiocese of Goa but an independent registered charitable society founded in 1910 by General Dr Jose Maria Da Costa Alvares, Adv Jose Maria Pereira, and other philanthropists. "Missionaries of Charity were invited in 1976 to assist with running the asylum for the destitute and needy," said the managing committee.

Assistencia also reacted to what they have described as "misinformation" about them and recent developments.

They opined that it was inappropriate to single out individuals for criticism when

Assistencia is run by its managing committee, which can take decisions only with the consent of its general body.

For instance, they pointed out that Neville Monteiro became the president only in April 2024, and not much earlier as has been claimed.

"Given the poor condition of the building and premises, it was proposed that we jointly reconstruct the same, for which an agreement was signed between Assistencia Goa and Missionaries of Charity and approved in 2014. The plans were submitted and duly

approved by the PDA," the managing committee added. The 2014 agreement stipulated sharing the building structure with 78% for MoC and 22% for Assistencia, an arrangement both parties agreed to in writing after negotiations

The outage, which occurred without prior notice, has caused significant inconvenience to households and commercial establishments alike.

Upon inquiry, it was revealed that the power cut was necessitated by ongoing works related to the installation of a new power line in the area. However, the lack of communication from the electricity department has exacerbated the situation.

Residents have called on the electricity department to improve communication and provide advance notice of scheduled maintenance to pre-

vent such disruptions in the future. They argue that timely information would allow them to make necessary arrangements and mitigate the impact of power outages.

As the community continues to grapple with the effects of the power shutdown, the need for better communication and planning remains a pressing concern.

Local leaders have indicated that they will be raising the issue with the relevant authorities to ensure that residents and business owners are not left in the dark in future.

🕐 These fires are being lit in many areas of Goa. In particular, Taleigao has seen massive ecological destruction due to a major fire.
