# **Defunct CCTV cameras leave a** question mark on Margao's safety

State's commercial capital has become susceptible to criminal activities; locals claim violators dump garbage at night without fear of surveillance

MARGAO: Goa's commercial capital is currently facing a significant challenge as its entire CCTV surveillance network has been rendered non-functional, leading to a growing concern for residents and civic leaders, particularly due to the increase in crime, illegal garbage disposal, and the unrestricted entry of unidentified individuals into the town.

The existing surveil-lance system, initially installed in 2013 through the MPLAD scheme, has been inactive for several years due to the lack of a proper maintenance plan. These cameras, which were intended to bolster public safety and improve traffic management, are now merely non-functioning fixtures across key urban areas. Consequently, Margao is becoming increasingly susceptible to both criminal activities and a decline in civic dis-

cipline. Residents have reported a notable rise in public garbage dumping incidents, especially during nighttime hours, as violators operate without fear of surveillance.

There have been break-ins and thefts in the commercial areas, but we have no footage to trace the culprits. What's the point of installing cameras if there's no plan to maintain them?

Highlighting the issue, Cedric D'Costa, a local resident said, "There have been break-ins and thefts in the commercial areas, but we have no footage to trace the culprits. What's the point of installing cameras if there's no plan to maintain them?"

Social activists also emphasised that the absence of working CCTV coverage presents a serious security vulnerability, especially given the town's increasing number of visitors

Vivek Naik, a social activist said, "The town has no idea who's entering or leaving, especially at night. This is not just a municipal oversight-it's a public safety crisis. The cameras are the need of the hour."

## Curtorkars protest 'illegal' tree felling to facilitate housing project at Maina

Allege the cutting had exceeded permitted limits; demand thorough probe by forest dept and action against violators

MARGAO: Curtorim villagers on Wednesday met with Forest Department officials to protest what they described as unauthorised large-scale tree felling linked to a housing project at Maina.

Alleging that the cutting had exceeded permitted limits, residents demanded a full investigation and action against those responsible for the violations.

Congress leader Moreno Rebello told the media that permission had been granted for the felling of just 12 trees, but villagers observed that over 50 had been cut. He said the activity was carried out without proper consultation with the panchayat, under the pretext of development.

"We are not against development, but there must be transparency and accountability. The scale of deforestation here is alarming," Moreno said, urging the Forest Department to probe the incident thoroughly and ensure elected representatives are involved in granting and monitoring permissions. Forest officials have acknowledged the complaint and assured residents that the matter will be looked into.

The meeting came a day after tensions flared at the Curtorim Village Panchayat office over the same project. On Tuesday, agitated residents, including Zilla Panchayat (ZP) member Michele Rebello and Moreno, several panchayat members including the local panch, demanded im-

mediate revocation of the construction licence issued for the housing project.

They pointed out that the panchayat member concerned had been excluded from the inspection process prior to the approval being granted.

Curtorim MLA Aleixo Lourenco. Reginaldo who was present at the panchayat office during this meeting, advised Curtorim Sarpanch Alcinha D'Silva to initiate the process of revoking the licence, but to ensure due legal procedure was followed to avoid giving the developers any grounds for court appeals.

Responding to the back-

lash, D'Silva told the media that the panchayat had issued the licence based on technical clearance from the Town and Country Planning Department (TCP). However, D'Silva said steps would be taken to re-examine the matter and, if needed, revoke the licence following legal proto-

Moreno also alleged that the trees on the property were cut only after the licence was issued, and demanded legal action against the party behind the project. Later on, the villagers, along with the Sarpanch and panchayat members, carried out a site

## Rumbler strips damaging our houses: Nuvem locals

Gorvotte residents complain vehicles passing over them cause noise pollution; claim their appeals have fallen flat

MARGAO: Voicing concerns regarding the rumble strips installed at a busy crossroads in their area. residents of Gorvotte, Nuvem, have complained that vehicles passing over these strips are causing severe noise pollution, disrupting sleep, and causing vibrations that may be damaging nearby homes.

Senior citizens residing close to the junction have particularly highlighted the unbearable noise created by vehicles crossing the rumble strips, especially at night. They claim that their appeals to the authorities have fallen on deaf ears. Expressing disappoint-

ment, Jamin D'Costa, a resident of Nuvem said. "I wrote to all the authorities, but they turned a blind eye. I had demanded an inspection be carried out, but in vain. They should conduct an inspection, as the vibration is damaging nearby houses. Accidents continue to occur despite the rumblers. We demand proper speed breakers instead."

Residents contend that the rumble strips, intended as a traffic-calming measure, have not effectively reduced accidents. Instead, they produce a loud, jarring noise when vehicles, particularly heavy ones, pass over them at high speeds. This noise resonates

hood at night, disturbing residents' sleep. Furthermore, locals are concerned about the structural impact on their homes. They report that the continuous vibrations are beginning to cause cracks and other signs of damage, raising worries about potential long-term structural issues if the situation goes

They have now urged the authorities to replace the rumble strips with more effective and less disruptive solutions, such as speed breakers made from sound-dampening materials or the implementation of appropriate signage and

speed monitoring systems. The residents hope that by bringing this issue to public attention, the authorities will finally take meaningful action to resolve their concerns.
