INDIA FOILS PAK ATTACKS ON THE WESTERN FRONT

Forces destroy air defence system in Lahore; thwart missile and drones at 15 locations, including Jammu, Pathankot and Udhampur

ESCALATING TENSIONS: INDIA STRIKES BACK WITH FORCE

PTI, JAMMU/NEW DEL-HI: Air raid sirens blared and the night sky was lit up by fireballs as Indian defence forces successfully intercepted a series of missile and drone attacks by Pakistan targeting military installations in Jammu, Pathankot, and Udhampur on Thursday evening.

The attacks came amid intense cross-border hostilities that rose by many notches on a tense day that saw the nuclear-armed neighbours engaged in fierce military exchanges. Defence sources confirmed that Indian air defence systems neutralised at least eight missiles aimed at strategic locations in Jammu, including the vital Jammu Airport in Satwari.

Earlier, during the intervening night of Wednesday and Thursday, India had thwarted coordinated Pakistani attempts to strike 15 military sites across northern and western India using drones and missiles. In a calibrated response, Indian forces retaliated, reportedly disabling a Pakistani air defence system in Lahore, fuelling concerns of a broader escalation.

These developments followed India's precision strikes on nine terror camps in Pakistan and PoK just a day earlier.

Kala Academy ailing, shows task force report

Unearths deficiencies in sound, lighting & acoustics; submits report to CM, stating there are 'no shortcuts to fixing these problems'

PANJIM: Constituted to review the infrastructure and suggest improvements to Kala Academy, Goa's premier art and culture centre, the task force has uncovered serious deficiencies in all three critical technical domains of sound, lighting, and acoustics (inclusive of ambient noise control). In its 18-page report, the task force said that in several cases, the basic principles of auditorium system design were overlooked during the renovation and there are sound system deficiencies, lighting system deficiencies and acoustic environment and HVAC noise issues.

"The installed Bose house speaker system fails to provide uniform sound coverage across the auditorium seating. Measurements and listening tests revealed that sound pressure levels drop off significantly towards the back rows. The positioning of the subwoofer cabinets is technically flawed. The auditorium's microphone inventory and miking approach are not aligned with the diverse needs of theatrical and musical performances," the report said.

"On-stage sound for performers (monitoring) is insufficient. Only four stage monitor speakers are provided instead of the six that are normally required for full stage coverage. Earlier, the task force met the chief minister at Mantralaya at Porvorim and submitted him the report. The acoustic feedback observed is also a sign that the system has not been properly

report said. "Another major issue is the dimming capability of the new LED lighting rig. The overall illumination on stage is below acceptable levels for professional productions. The current FOH lighting battens and bars appear to be non-motorised and were re-posi-

tioned during renovation," the report noted.

It has observed that one of the most troubling findings is that the auditorium's famed acoustics have been altered for the worse.

"Prior to Interim Tech Audit Report by Francis Coelho dated May 8, 2025, Page 5 of 18 renovation, Kala Academy's main hall was lauded for its balance of reverberation and clarity," it said.

CJI recommends impeachment of Justice Varma

PTI. NEW DELHI: Chief Justice of India Sanjiv Khanna is learnt to have recommended to the Centre impeachment of Allahabad High Court judge Yashwant Varma following his indictment in the cash discovery row by a Supreme Court-appointed committee.

The CJI wrote to President Droupadi Murmu and Prime Minister Narendra Modi and shared the report of the three-member committee along with the response received from Justice Varma.

The move assumes significance in the wake of the established inhouse procedure which entails the CJI writing to President and Prime Minister for impeachment after their advice to the judge to resign is not complied with.

Shirgao stampede: As usual, temple committee in blame game mode

BICHOLIM: The blame game has begun over the stampede at Shirgao, which killed six people and left several others injured, with the Shree Lairai Devi Temple's managing committee blaming the Shirgao Village Panchayat, administration and the Bicholim Deputy Collector for the tragic incident.

Addressing a press conference on Thursday, temple's managing committee president Dinanath 'Dina' Gaonkar claimed that the panel was not responsible for the horrific incident that occurred during the annual zatra on May 2.

He said that the managing committee will not allow the stalls alongside the lane leading to the temple from next year onwards.

Accusing the temple's former pres-

ident Ganesh Gaonkar of misusing temple property and funds for his personal gain, Dinanath alleged that the outgoing president did nothing for the temple during his three-year tenure

He claimed that a tragic incident had occurred during the annual zatra last year wherein a woman was killed. He further mentioned that the general body had taken a decision to remove the compound wall

Refuting the allegations made by Dinanath, Ganesh said, "During my tenure we had barricaded the area and the devotees were happy. The then Bicholim Mamlatdar and the then Bicholim PI told me to barricade the area. We barricaded the area despite opposition from Dinanath and others

HC bans LED fishing, comes down heavily on **Fisheries Dept**

Tasks Coast Guard with manning the waters to enforce ban, asks for compliance report every 3 months

PORVORIM: The fishing community across Goa celebrated on Thursday as the High Court of Bombay at Goa ordered a complete ban on LED fishing, bull trawling and pair trawling, directing the Directorate of Fisheries to enforce this under the Marine Act.

The order, which came as a 63 page judgment on Writ Petition No 403 of 2022 and was authored by Justice Valmiki Menezes, was a major victory for traditional and smaller fishermen, who have claimed for a long time that they were not being given adequate protection by the Department of Fish-

eries (DoF). Taking cognizance of this, the judgment castigated the DoF for the manner in which it tried to mislead the Court during the hearings. The court has set a timeline for the DoF, Coast Guard and the Coastal Police to file compliance reports every three months, with the first date set for September 2.

"It is the Coast Guard that is required to use all the resources under its power to enforce the State and Central Laws over the Maritime Zones," it said.
