Punjab, Haryana, Rajasthan among states on high alert

Leave cancelled, schools shut

PTI, CHANDIGARH/JAI-PUR: Amid escalating tensions between India and Pakistan, many states have announced the closure of schools, blackouts in border districts, and cancellation of leave of police personnel and administration officials.

The stringent measures were taken by Punjab, Haryana, Rajasthan, Delhi, Gujarat, West Bengal and Bihar after India struck terror infrastructure in Pakistan and Pakistan Occupied Kashmir in retaliation for the April 22 Pahalgalam massacre that killed 26 people.

Punjab shares a 532-km border with Pakistan, Rajasthan about 1,070 km and Gujarat around 506 km. West Bengal shares a 2,217-km border with Bangladesh.

In Punjab, the leave of all police personnel has been cancelled while the state government has shut schools in six border districts, officials said on Thursday.

"Leaves should be granted only in special circumstances with the approval of the competent authority," an order issued by the DGP's office said.

All schools in six border districts of Punjab — Ferozepur, Pathankot, Fazilka, Amritsar, Gurdaspur and Tarn Taran — have been shut until further or-

ders. A blackout was enforced in several districts, including Pathankot, Amritsar, Jalandhar, Hoshiarpur, Mohali, and Gurdaspur in Punjab and the Union Territory Chandigarh on Thursday evening, officials said.

"Punjab shares a 532-km border with Pakistan. Therefore, the role of the Punjab government becomes extremely crucial during any military tension. All districts near the border have been placed on high alert," Punjab minister Aman Arora said on Wednesday.

In neighbouring Haryana, the leave of state police personnel and those working in the health department has been cancelled till further orders.

According to a communication to the civil surgeons of all the districts across Haryana, it has been mentioned that all officials will have to remain present at their current places of posting and shall not leave the district headquarters.

The Delhi government also cancelled leave of all its employees till further orders due to the escalating hostilities.

No leave will be granted to any official of Delhi government till further orders given the prevailing situation and preparedness for any emergency, said an or-

With famous temples like Baba Balak Nath, Maa Chintpurni and Maa Naina Devi located in Hamirpur, Una, and Bilaspur districts, police have intensified security checks there, an official said.

The Rajasthan government too has cancelled

leave of administrative and police personnel deployed near the International Border and closed schools in five bordering districts.

With a high alert sounded in the border districts of western Rajasthan, a blackout has been instituted in these areas.

In Operation Sindoor, nine terror camps were destroyed in Pakistan and PoK and a good number of terrorists were killed. However, if anyone tries to take advantage of this restraint, they will face quality action. We are fully prepared for such responsible responses in the future as well

all proposed accused persons in terms of its previous order.

The judge, however, said, "Since the notice has purportedly been served upon an alternative email ID upon the proposed accused 4 (Sam Pitroda) only today, it is appropriate that submissions on the aspect of cognisance are heard on the next date of hearing."

Nipah virus case confirmed in Kerala

PTI, MALAPPURAM (KERALA): A case of Nipah virus has been confirmed in Kerala's Malappuram district, health officials said on Thursday. State Health Minister Veena George said the infection was found in a 42-year-old woman from Ward 2 of Valanchery municipality.

She is currently being treated at a hospital in Perinthalmanna.

The woman first visited a private clinic on April 25 with a fever. On May 1, she was admitted to the hospital after her doctor advised further treatment.

Initial tests in the state pointed to Nipah, and this was later confirmed by the virology lab in Pune.

Twenty-one samples from seven people who had close contact with the patient, including family members, have all tested negative for the virus, according to the Minister.

After the case was confirmed, George visited the district on Thursday.

6 killed as helicopter crashes in Uttarakhand

PTI, UTTARKASHI (U'KHAND): A helicopter on its way to the Gangotri temple crashed near Gangnani in Uttarkashi district on Thursday, killing six people, including the pilot, and leaving a man seriously injured, officials said. Barring the pilot, who hailed from Gujarat's Vadodara, the five other deceased were women.

The lone survivor of the crash was Maktur Bhaskar (51), a resident of Anantpur in Andhra Pradesh, Ut-

tarkashi's Superintendent of Police (SP) Sarita Dobhal said. Bhaskar, who sustained serious injuries, was brought in an air ambulance from the crash site to the All India Institute of Medical Sciences (AIIMS), Rishikesh for treatment. His wife, Vedanti (48), was also among the dead.

The helicopter of a private company, with seven people on board, crashed over the Rishikesh-Gangotri

national highway at around 8:45 am and fell into a gorge about 200-250 metres deep, the State Disaster Response Force (SDRF) said.

The helicopter had left the Sahas-tradhara helipad in Dehradun for the Kharsali helipad. It was on its way to Gangotri from there when it crashed, an official said.

District Magistrate Meharban Singh Bisht said six people died on the spot. One of the passengers on the helicopter - M Bhaskar (51) from Andhra Pradesh - was seriously injured in the crash and was airlifted to the AIIMS, Rishikesh, the DM added.

Three on board the helicopter were from Mumbai, two from Andhra Pradesh and one each was from Uttar Pradesh and Gujarat. Those killed were identified as Lakshandrakant Soni (61), Vijaya Lakshmi Reddy (57), Ruchi Agrawal (56), Radha Agrawal (79), Vedanti (48) and Captain Robin Singh (60), the pilot.

The SP said it took hours to extract the bodies from the remains of the helicopter, pull those out of the gorge and up to the road. The bodies were sent to the Uttarkashi district hospital for post mortem.

'Not as fragile as flowers': SC raps BJP Nishikant Dubey for 'scandalous' remarks on judiciary, CJI

PTI, NEW DELHI: The Supreme Court has rapped BJP MP Nishikant Dubey for his remarks against it and Chief Justice of India Sanjay Khanna, saying they tend to "scandalise" and lower the authority of apex court.

The top court, in a way, put an end to recent political debates as to who is supreme whether Parliament or the judiciary.

"It is the Constitution that is higher than all of us. It is the Constitution which imposes limits and restrictions on the powers vested in the three organs. The power of judicial review is conferred by the Constitution on the judiciary. Statutes are subject to judicial review to test their constitutionality as well as for judicial interpretation. Therefore, when the constitutional courts exercise their power of judicial review, they act within the framework of the Constitution," a bench of CJI and Justice Sanjay Kumar said.

The top court, which spared the lawmaker

from the contempt proceedings by dismissing a PIL, made scathing observations against Dubey for his remarks against it and the CJI following the hearings on a batch of petitions challenging the validity of 2025 Waqf law.

Dubey sparked a row when he said, "(the) Supreme Court is taking the country towards anarchy" and that "Chief Justice of India Sanjay Khanna is responsible for the civil wars taking

place in the country".

"We have examined the contents of the assertions made by respondent 4 (Dubey), which no doubt tend to scandalise and lower the authority of the Supreme Court, if not interfere or tend to interfere with the judicial proceedings pending before this Court, and have the tendency to interfere and obstruct the administration of justice," the CJI said in the order.

The bench further said, "We are of the firm opinion that courts are not as fragile as flowers to wither and wilt under such ludicrous statements." The comments were stated to be "highly irresponsible", reflecting a penchant to attract attention by casting aspersions on the Supreme Court of India and its judges.

The bench on May 5 heard a plea for contempt action against Dubey over his remarks and said they were the ones who heard the petitions against the amended Waqf law.
