SC flags vacancies in high courts

Prods Centre to clear names for judges' appointment

PTI, NEW DELHI: Observing Indian high courts have more than 7 lakh criminal appeals pending, the Supreme Court on Thursday asked the Centre to expeditiously clear names for judges' appointments to mitigate issues of vacancies and pendency.

A bench of Justices Abhay S Oka and Ujjal Bhuyan said the Allahabad High Court with 2.7 lakh cases pending criminal appeals had a sanctioned strength of 160 judges but was only functioning with 79 judges at present.

The bench said. Similarly, the Bombay High Court with a sanctioned strength 94, was functioning with only 66 judges, it added.

The Calcutta High Court, it noted, was functioning with 44 judges opposed to the total strength of 72 judges.

The bench observed the Delhi High Court currently had 41 judges against the prescribed 60 judges.

"It has a huge pendency of criminal appeals. Hence this is an issue which will have to be handled at a different level," it added.

The apex court said two days ago, recommendation of the Supreme Court collegium for appointment of high court judges was made public on the top court website.

"Four recommendations of 2023 and 13 recommendations made in 2024 are pending with the Centre. The most recent recommendations made on September 24, 2024 are also pending," it said.

The top court was hearing a suo motu petition relating to delays marring bail processes and expeditious release of undertrials granted bail.

The court passed the directions after examining suggestions from senior advocate and amicus curi-

ae Liz Mathew. The apex court noted as on March 22, the total number of criminal appeals was 7,24,192.

"Madhya Pradesh has pendency of 1,15,382 cases. Even in smaller states, pendency is high. Patna High Court has pendency of 44,664; Punjab & Haryana High Court has 79,326 and Rajasthan has pendency of over 56,000 pending cases. Bombay has pendency of 28,257. Chattisgarh more than 18,000 cases. Therefore, this a huge problem faced by all HCs," it said.

Aside from the suggestions on mitigating the pendency, the administrative side of the CJI prepared and approved a model action plan for reduction of arrears which was shared with all high courts.

Air travel for Int'l passengers to get costlier at Mumbai airport

Each disembarking Int'l business and economy class passenger will have to pay Rs 304 and Rs 260, respectively

PTI, MUMBAI: Passengers flying in and out of the Mumbai International Airport will have to shell out up to Rs 695 as a user development fee from May 16 following the airport tariff regulator AERA allowing the airport operator to revise the fee.

Earlier, a charge of Rs 120 per departing domestic passenger was levied till August 2024 in the form of development fees while international passengers pay

Rs 187 as UDF. As per the new tariff order, which will be applicable for the fourth traffic control period (FY 2024-2029), each embarking domestic passenger will pay Rs 175 as UDF and Rs 75 for disembarking while an embarking international business class passenger will have to shell out Rs 695 as against Rs 615 by the international embarking economy class passenger, as per AERA.

Each disembarking international business and economy class passenger will have to pay Rs 304 and Rs 260, respectively.

The Airport Economic Regulatory Authority (AERA) has the mandate to determine all tariffs for major airports in the country.

AERA said it has decided to set the UDF for domestic passengers at the rate of Rs 175 per departing domestic passenger, which will remain constant throughout the Fourth Control Period, adding the UDF has been set nominally at Rs 175 for domestic air passengers who comprise 75 per cent of the total passenger air traffic at CSMT Airport, "underscoring the commitment to protect passenger interests, ensure affordability, and foster growth in the domestic aviation sector."

Fire breaks out in Delhi factory, 1 dead

PTI, NEW DELHI: A 35-year-old man was killed in a fire that broke out at a factory in the Okhla Industrial Area of Delhi on Thursday morning, an officer said.

Police had earlier said that the fire had broken out in a courier company. However, the investigation revealed that it was a dye manufacturing company.

Police said a call regarding the fire breaking out at a building, where hair dye was manufactured, was received at 11.38 am on Thursday.

Abnesh was trapped inside the fire and suffered 90% burn injuries and died, police said.

A case has been registered under sections 287 (negligent conduct with respect to fire or combustible matter), 289 (negligent conduct with respect to machinery) and 106 (1) (causing death by negligence) of the Bharatiya Nyaya Sanhita against the owner, Athar Aftab and a manager, police said.
