#### **BSNL CABLES DAMAGED IN VALPOI, COMPLAINT FILED IN POLICE STATION**



PORIEM: The Bharat Sanchar Nigam Limited (BSNL) cables have been damaged during the excavation work for an underground power line in Sattari due to which telecommunication services in Sattari region is severely affected. The disruption has left residents and businesses without internet connectivity.

Irked by hundreds of calls from the consumers everyday complaining of no network, the BSNL official on Saturday filed a police complaint at the Valpoi police station regarding the damage of their cables by the electricity depart-

An official of BSNL, Valpoi said that the services of BSNL have been disrupted due to the mischief of contractor of electricity department who is not discharging his duties in responsible manner as a result the BSNL cables have been damaged at Dhave-Tar, Thane, Zarme, Valpoi town and several other places in Sattari. "The whole administration including Police, emergency services is disrupted" he said. Official from BSNL further said that the contractor of electricity department should replace the damaged cables at his own cost or else strict action would be taken against him since they have already filed a complaint.

# Sewage leak leaves Pajifond's Junta Quarters stinking

Residents demand immediate intervention by PWD & Margao civic body; want damaged sewage line repaired and affected area sanitised to prevent disease outbreak

MARGAO: For over a week, untreated sewage continuously leaking into the open spaces surrounding residential buildings of Junta Quarters in Pajifond, Margao, has triggered major health concerns among the locals, with the authorities yet to address the issue.

The residents have complained that the leak appears to be due to a damaged underground pipeline. The foul smell and stagnant water have created extremely unhygienic conditions, especially for children who often play in the area.

"This is not just an inconvenience, it's a serious health hazard," said Sobha

Desai, a long-time resident of Junta Quarters. "The authorities have been in-

formed multiple times, but there has been no response. We are forced to live with this unbearable stench and the fear of disease," she added

Despite repeated complaints to the civic body, the residents claim there has been no inspection or repair work carried out so far. The open sewage is not only an eyesore but also a breeding ground for mosquitoes, increasing the risk of diseases like dengue and malaria.

# Ponda eivic body to build shelter for strays at Varkhandem

Passes resolution to increase both house and commercial taxes

PONDA: In the wake of the tragic death of a 19-monthold child in a stray dog attack last month, the Ponda Municipal Council (PMC) has decided to construct a dog shed to address the growing stray dog menace and ensure the safety of locals.

The new facility will be built on a 2000 square metre plot of land in Bandora Comunidade, located behind the PMC crematorium at Varkhandem. PMC Chairperson Anand Naik confirmed that the land acquisition was made possible through the

efforts of Agriculture Minister Ravi Naik. Currently, PMC spends

between Rs 40,000 to Rs 45,000 monthly on dog sterilisation programmes. Chairperson Naik also stressed that dog feeding should be confined to designated areas by dog lovers and warned against feeding dogs raw chicken waste, as locals have reported that it leads to aggressive behaviour in the animals.

In another significant move, the PMC passed a resolution to increase both house and commercial taxes after a long period. The last house tax increase occurred in 1996, when it was raised to Rs 5 per square metre, with a further increase to Rs 7 in 2019.

The new hike will raise the rate to Rs 10 per square metre, a modest Rs 3 increase. Compared to other councils in Goa, where house tax is above Rs 20, the PMC's tax remains relatively low. Commercial tax has also been increased by

legality of the panchayat resolution approving the school extension, as both Cardozo and Robin Rodrigues, who supported the move, face disqualification over foreign citizenship. The residents argued that the resolution is null and void from the date of their disqualification.

However, despite not even experiencing a single monsoon season, this newly hotmixed road has already begun to

cave in. This situation appears to be a clear case of substandard work and a lack of coordina-
