# Panjim's Latin quarter seeks fire risk assessment, safety plan

In absence of a dedicated fire safety plan, Sao Tome & Fontainhas locals request fire dept to initiate a thorough assessment and propose appropriate preventive measures

**MARGAO:** Concerned about the fire risk facing their neighbourhood, residents of Sao Tome and Fontainhas—heritage wards in the heart of Panjim—have written to the Director of Fire and Emergency Services (DFES), Nitin V Raiker, seeking a detailed risk assessment and safety plan for the twin residential ar-

In their letter, the residents, who are represented by the Community Association of Residents and Establishments (CARE), noted that the Latin Quarter is made up of tightly clustered colonial-era homes, many of which are built using wooden materials for roofing, flooring, doors, and windows. The buildings are connected by common walls and accessed



through narrow streets and lanes, which makes emergency response particularly difficult.

"To say the least, these wards are highly prone to fire risk considering the area structure, high tourist footfalls and increasing number of restaurants in the locality," CARE stated. "This gets more pronounced due to haphazard parking and major traffic snarls—sadly, a disaster in

the making."

The residents stressed that the conservation status of the area, combined with the influx of visitors and commercial activity. requires greater attention from the authorities. They expressed concern over

CARE has highlighted the high fire risk in the Latin Quarter due to tightly clustered wooden colonial-era homes, connected by common walls and narrow lanes, complicating emergency response

It stated that the area's structure, high tourist numbers, and increasing restaurants exacerbate this risk, further compounded by haphazard parking and traffic congestion, creating a potential disaster

the absence of a dedicated fire safety plan for the neighbourhood, despite its historical and cultural sig-

CARE's letter also referenced recent appeals made by civil society group GOACAN for a Statewide fire safety strategy and urged the fire department to prioritise vulnerable zones like the Latin Quarter. They requested Raiker to initiate a thorough assessment and propose appropriate preventive measures.

In addition to approaching the fire department regarding the fire audit. CARE has also recently submitted its suggestions on other issues to the Tourism Department on ways to safeguard the area and address the concerns they are facing in general due to overtourism. This follows their recent engagement with the Corporation of the City of Panaji (CCP) on similar issues.

# Law to regularise unauthorised houses on Comunidade &

# Alvara lands: CM

BICHOLIM: Chief Minister Pramod Sawant on Monday said that the State government is considering enacting a new law to regularise unauthorised houses built on private, Comunidade lands and Alvara lands where owner's name is reflected in the 1971 land survey records.

Speaking at the foun-

dation stone laying ceremony for the construction of the government office complex at Bicholim, the Chief Minister said nearly 10,000 people had applied under the existing Goa Regularisation of Unauthorised Construction Act (RUCA), but only 2,000 have benefitted so far. To address this gap, the government plans to amend the law so that more people, especially those who have built homes on their own land, are given a chance to regularise their houses, possibly after paying a fine.

According to the chargesheet, the incident occurred in August last year when the accused Joaquim Joao Benjamin

inally residing at Saligao had come from Oman and along with his business partner was staying with the complainant. Following arguments on August 4, 2024, the accused in a fit of rage punched Martins on his left eye causing bleeding. Martins immediately called his friend Milton D'Costa

Joseph Mascarenhas, orig- hospital, where the staff the accused refused to pay told him to go to the Goa Medical College and Hospital (GMC), Bambolim. At GMC, the accused, who was also present and requested Martins to inform the medical officer that he had fall at home and sustained bleeding injuries to his eye.

Martins underwent a surgery at the hospital the medical expenses and without informing Martins left for Oman. Later, the victim lodged a police complaint and an offence punishable under Section 117 (2) of BNS was registered against Mascarenhas.

# Study feasibility to set up nuke power plant: Khattar

# Agrees to consider request for 24x7 water supply scheme for Goa

PANJIM: Union Minister for Power, Urban Development and Housing Manohar Lal Khattar on Monday said that the Centre has asked State government to consider the possibility of establishing a nuclear power facility as a longterm measure for energy security and sustainability.

He also agreed to consider the request for 24x7 water supply Drink from Tap (DfT) Scheme for the State.

Khattar who was in the State to review progress of power sector and urban development scheme in the State, stated that the State does not have thermal hydro or solar power plants and given that around 80 per cent of Goa's electricity is procured from outside the State, he asked the government to examine the feasibility of setting up nuclear power plant in the State and submit proposals.

The review meeting attended by Chief Minister Pramod Sawant, Power Minister Sudin

Dhavalikar, Urban Development Minister Vishwajit Rane and senior officials, focused on the power sector developments, loss reduction initiatives, and the progress under the Revamped Distribution Sector Scheme (RDSS).

Commending the Electricity Department for its effective efforts in ensuring power availability and achieving universal electrification, Khattar said, "Goa has shown exemplary performance in reducing AT&C losses to 9.32 per cent, which is significantly below the national average. This is a testament to the State's sustained efforts in improving the efficiency of its power distribution system."

The Union Minister appreciated the State's significant progress in implementing infrastructure works under RDSS aimed at reducing losses. However, he emphasised the need to accelerate the pace of smart metering, which has the potential to revolutionise consumer engagement with DIS-COMs through data analytics and AI/ML tools.

"Now that the contracts have been awarded, I am confident that the implementation will gain momentum. Prioritising saturation of smart meters in government offices, colonies, commercial and industrial units, and high-load consumers will help ensure digitisation and improved service delivery," Khattar noted.

Highlighting the importance of operational efficiency, Khattar

encouraged the State to further reduce utility losses and integrate more Renewable Energy into the grid. He mentioned that this would help lower the cost of power supply and enhance overall performance.

He also acknowledged Goa's citizen-centric efforts in simplifying procedures for rooftop solar installations and new electricity connections, enhancing the ease of living for consumers.


During the meeting, the Chief Minister requested to consider special assistance for 24x7 water supply Drink from Tap (DfT) (Project cost about Rs 652.61 crore) special financial assistance of Rs 326.30 crore minimum for Water Source Augmentation, Infrastructure Development, Rehabilitation of Existing Network, pilot Drinkfrom-Tap projects including smart metering, IoT and SCADA-based monitoring systems to the State under AMRUT 2.0.

Sawant requested to consider given Goa's unique urban challenges, particularly due to the significantly high volume of tourist inflow placing additional burden on civic infrastructure and requested that the State be considered as a special case for enhanced and expedited support under both AMRUT 2.0 and SBM-U 2.0.

The Union Minister advised the State to complete all pending works related to water supply (new/service tap connections and new/service sewer connections) under AMRUT; revision of action plan, expedite tendering work for toilets (community toilets, public toilets, aspirational toilets, urinals), Solid Waste Management, STP/co-treatment facilities under SBM; submit proposals, inform and educate citizens about PMAY-U 2.0 to get benefits of affordable housing; profile street vendors under PM SVANidhi, clear eligible loan applications and increase women participation.

Khattar also directed the State to submit proposal for PM-eBus Sewa Scheme and further reviewed the progress under Smart Cities and DAY-NULM.
