The victim's mother, a resident of Curchorem and native of West Bengal, reported that unknown individuals kidnapped her daughter at approximately 9.45 pm on May 12. Police have circulated descriptions of the missing girl to police stations in Goa and neighbouring States. Curchorem PSI Dinesh Gaonkar is investigating the case.

#### BHATPAL RESIDENT DIES IN SELF-ACCIDENT

MARGAO: Esabareto Fernandes of Bhatpal, Canacona, travelling from Ordhofond, Bhatpal-Canacona towards Chaudi, Canacona, died in an accident involving two bulls at Khalwadem, Canacona on Monday. Police investigation revealed that two stray bulls suddenly ran onto the road and collided head-on with his scooter. Esabareto succumbed to his injuries sustained in the accident. Following the incident, the panchanama was conducted, and the body was sent for a post-mortem examination. The police surgeon reported the cause of death as "Cranio cerebral damage consequent to blunt force impact." The body was handed over to the family for final rites. Canacona Police have registered an unnatural death case, and further investigation is ongoing.

#### UTTAR PRADESH NATIVE DIES IN GMC DUE TO SUSPECTED POISONING

MARGAO: Nineteen-year-old Divay Kumar Paramhans, a native of Uttar Pradesh, died in Goa Medical College and Hospital at Bambolim due to suspected poisoning. ## State has enough water for two months: Minister

**PONDA:** Stating that Goa's rivers and dams currently hold sufficient drinking water reserves, WRD Minister Subhash Shirodkar said the present water storage capacity can comfortably meet the State's needs for the next 1.5 to 2 months.

He said "This buffer extends beyond the anticipated arrival of the monsoon in June, ensuring no water shortage even in the absence of immediate rain-

Shirodkar reassured citizens that there is 'no need to worry'. The minister highlighted

the presence of approxi-

mately 374 traditional water harvesting structures (bandharas) along Goa's rivers, with plans to increase this number to 500. Addressing the recent crocodile attack at Saton-Dabal, he said, "The government is taking proactive steps to ensure public safety for those who rely on rivers for their daily needs. Plans are underway to construct designated washing platforms at a safe distance from the riverbanks in areas like Ambe Dulai and Shignewal. These platforms will also be equipped with water access for pumping

and bathing." Meanwhile, officials at the Opa water works assured that there will be no disruptions with regards

Notably, all but one of the 24 bandharas on the Dudhsagar river are at full capacity. The recent release of water from the Ambe Dulai bandhara has further replenished the Opa barrage. While the minimum water level required for smooth pumping is 3.5 metres, authorities are confident they can easily maintain levels above this threshold thanks to the various available water sources that help rejuve-

nate the Opa River. Adding to this positive

to the drinking water sup- outlook, Sunil Kerkar, an Asthe water level at the Opa barrage on the Khandepar River is currently at 3.72 metres, which is higher than the 3 metres recorded on the same day last year.

Officials also highlighted that the Water Resources Department (WRD) maintains 24 bandharas on the Khandepar, Kalay, and Udnai rivers, collectively capable of storing 35.3 lakh cubic metres of water, most of which are vet to be utilised. Furthermore, the Opa Water Works receives 48 (MLD) per day from the Selaulim Dam, and an additional 70 MLD is sup-

plied to the Khandepar River via the Ganjem Water Scheme. As a contingency, the WRD has pumps ready to draw up to 30 MLD of water daily from mine pits in Dharbandora, which can then be channelled into the Khandepar River to further rejuvenate the Opa River and support its five water treatment plants.

These treatment plants, with capacities of 8 MLD. 12 MLD, 54 MLD, 40 MLD, and 27 MLD, collectively supply 152 MLD of water to the Ponda and Tiswadi talukas.

The officials also noted that the extended monsoon last year played a crucial role in replenishing the dams across Goa. The monsoon season concluded around October 15 last year, and the subsequent heavy rain showers further contributed to ensuring sufficient water storage in the dams.

### Camorlim panchayat to monitor migrants
