India to send delegations abroad to expose Pak on terror

The exercise aimed at presenting India's stance against Pak on terror comes in the wake of Operation Sindoor

PTI, NEW DELHI: As part of a major diplomatic offensive, the government will send several all-party delegations to different countries, starting next week, to expose Pakistan-sponsored terrorism on the world forum.

The exercise is aimed at presenting India's stance against Pakistan on terror comes in the wake of Operation Sindoor - the Indian offensive against terror camps in Pakistan and Pakistan-occupied Kashmir (PoK) following the April 22 terror attack in Pahalgam in which 26 people, mostly tourists, were killed.

Senior leaders, including MPs, of various parties from both the ruling and the opposition, have been sounded out by the government and some parties have also given their go-ahead to the presence of their members for the

Former Union minister Anurag Thakur and BJP MP from Odisha, Aparajita Sarangi, are among the ruling party members to be part of the delegations, the sources said.

Eleventh woman judge in SC history, Justice Bela M Trivedi bids adieu

PTI, NEW DELHI: Justice Bela M Trivedi, who was the eleventh woman judge to be elevated to the Supreme Court in its 75-year-old history on Friday demitted office after spending three-and-ahalf years on the bench.

Justice Trivedi, who had the rare distinction of being elevated to the top court after starting out as a trial court judge in Gujarat in July 1995, was part of the top court's several landmark judgements.
