#### MAN ARRESTED FOR BRUTALLY STABBING GIRLFRIEND AT QUEPEM

MARGAO: Anant Kadam (25), a resident of Aguem, Margao, was arrested by Quepem Police in Sangli, Maharashtra, after allegedly stabbing his girlfriend with a knife at Shirvoi, Quepem, and fleeing the scene. Police said Kadam was tracked based on his location and apprehended in a local market before being brought back to Quepem. He is charged under Section 126(2) and 109 of the Bharatiya Nyaya Sanhita (BNS), 2023, following a complaint filed by Angel Travasso of Panchwadi, Ponda. According to the complaint, on May 12, between 1.15 and 1.45 pm, Kadam followed the victim in his car, rammed their scooter, and then physically assaulted both. He allegedly punched the complainant, causing both riders to fall, then kicked the victim and insisted she get into his car. When she refused, he reportedly stabbed her in the abdomen with a knife. Police said the accused later admitted the victim to South Goa District Hospital before absconding with the car. The victim is now in the ICU at Goa Medical College, Bambolim, and is in a critical condition. Her statement will be recorded once she stabilises. The knife used in the attack is yet to be recovered. Kadam was produced before the Judicial Magistrate First Class (JMFC), Quepem, and remanded to six days in police custody.

#### MOBILE PHONE STOLEN WHILE MAN SLEPT AT SANGUEM MUNICIPAL BUILDING

MARGAO: The Sanguem police have registered a theft case after an unknown person allegedly stole a mobile phone worth approximately Rs 16,000 from Pawan Kumar Gupta of Mapusa. According to the complaint filed on May 17, Gupta was sleeping under the Sanguem Municipal building around 7:30 am when the mobile, kept in his shorts, was stolen. LPSI Kavita Rawat has registered the offence under Section 303 of the BNS 2023. A police team visited the scene, conducted a panchanama, and further investigation is underway.

#### CANACONA COPS, FRRO INSPECT HOTELS FOR FOREIGNERS' REGISTRATION COMPLIANCE

MARGAO: Canacona Police, in coordination with the Foreigners Regional Registration Office (FRRO), Panaji, conducted a joint inspection in the Agonda area to verify compliance with foreigner accommodation regulations. During the drive, 110 hotels, guesthouses, and resorts were inspected, and around 70 foreign nationals were checked. The objective was to ensure adherence to the Registration of Foreigners Rules, 1992, particularly the submission of Form 'C' within 24 hours of a foreign national's arrival and the updating of departure details. Property owners and managers were instructed to strictly follow the legal protocols. Authorities warned that failure to comply would invite legal action.

#### **SCOOTER RIDER GRIEVOUSLY** INJURED IN FATORDA COLLISION

MARGAO: A 22-year-old Margao resident, Rohit Rathod, suffered grievous injuries in a collision involving his scooter and a car near the water tank behind Junta Quarters, Pajifond-Fatorda. The incident occurred on May 15, when the accused driver, Joyrus Greger, allegedly drove the car in a rash and negligent manner, endangering human life while heading from Motidongor towards Old Hospicio. His vehicle collided with Rathod's scooter coming from the opposite direction. Rathod, who had recently taken up employment, was admitted to Goa Medical College, Bambolim, with serious injuries.

## MENTALLY ILL MAN DIES AT IPHB, BAMBOLIM

MARGAO: Aman Mez, 35, a native of Jharkhand who had been admitted to IPHB Bambolim by order of the JMFC Margao, died while undergoing treatment. Fatorda Police stated that the man, reportedly mentally ill and behaving abnormally, was lodged at the institution by police staff. Jpon being notified by the duty medical officer of his death, police visited the scene and preserved the body at South Goa District Hospital, Margao, for medico-legal formalities. An investigation into the case is underway.

#### E-BOOK ON FUNGAL DISEASES RELEASED, HIGHLIGHTS GROWING GLOBAL THREAT

PANJIM: An e-book on fungal diseases, edited by Dr RG Wiseman Pinto - professor of Pathology, former Dean of Goa University and President of the Asian Society of Cytopathology - was recently released and is available free of cost on www.pathoindia.com. The e-book, titled Fungal Infections: The New Superbug, outlines how fungal diseases are emerging as a major global health threat. The e-book covers the full clinical and diagnostic spectrum of fungal infections, including laboratory tests, smears, staining techniques, cultures, biopsies, morphology, cytology, histopathology findings, and organ involvement. It also outlines current treatment protocols. Common fungal infections discussed include Candida, Aspergillosis, Mucormycosis, Cryptococcosis, and Histoplasmosis. The main line of treatment includes liposomal amphotericin B and surgical intervention. However, the book also warns of severe side effects such as renal and liver failure associated with the drug. Dr Pinto also presented a lecture titled Fungal Diseases: Recent Advances at the 22nd ICC International Congress of Cytology held in Florence, Italy, on May 13, where he also served as chairman.

# **High Court orders demolition of** 16 illegal structures in Calangute

## Directs BDO to provide necessary assistance within two weeks from date of order

PANIIM: The High Court of Bombay at Goa has directed the Calangute Village Panchayat to proceed with the demolition of 16 structures, as per the demolition order issued on December 22, 2011.

The Court also instructed the Block Development Officer (BDO), Mapusa, Bardez Taluka, to provide the necessary assistance within two weeks from the date of

In March this year, the Calangute panchayat had written to Joseph Rosa, stating that he had failed to submit an approved plan, construction licence, and occupancy certificate for the structures listed in the demolition order. However, as the structures were not demolished, Sylvester D'Souza filed a writ petition seeking directions to the panchayat for their removal. Following this, an inspection was conducted on April 8, 2025, and the struc-



tures were again ordered to be demolished.

During the hearing, Advocate J A Lobo, counsel for respondent Joseph S Rosa, referred to directions previously issued by the Court in a 2020 public interest litigation (PIL) that instructed the Goa Coastal Zone Management Authority (GCZMA) to inspect the site to determine whether the structures violated Coastal Regulation Zone (CRZ) notifications.

Advocate Lobo pointed out that an earlier demolition order dated January 28, 2010, pertained to the demolition of the second floor of a ground-plus-two structure, while another order dated October 12, 2012, referred to the demolition of a ground-plus-one structure and a swimming pool. He submitted that, as per an inspection report, both these structures had already been demolished.

However, the Court noted that another site inspection, conducted specifically with reference to the notice dated December 22, 2011, and detailed in a report submitted by the panchayat secretary on April 8, 2025, confirmed that the structures shown in the attached sketches were still present on site and that no demo-

lition had been carried out. The Court observed that, as the Calangute Village Panchayat was now proceeding with the execution of the original demolition order, the respondent's objections held no weight, since the structures in question were unauthorised.

### Rider killed after crashing into parked concrete pump

VASCO: Shivdas Vengurlekar (45), a resident of Mapusa, died after his two-wheeler crashed into a parked concrete pumping machine near the Chicalim post office on Friday evening.

According to Vasco Police, the fatal accident occurred while Vengurlekar was travelling from Cortalim to Vasco on his two-wheeler. As he approached the Chicalim post office, his vehicle rammed into the concrete pumping machine, which had been parked along the

Vengurlekar sustained serious injuries in the collision and was rushed to the Sub-District Hospital (SDH), Chicalim, where doctors declared him brought dead.

Police conducted an inquest panchanama at the hospital and later shifted the body to the Margao hospital for a post-mortem examination. The autopsy revealed the cause of death as "damage to chest, abdomen and spine consequent to blunt force impact."

## CM warns of strict action against misuse of 'Atal Asra' housing scheme

BICHOLIM: Chief Minister Pramod Sawant has issued a stern warning against the misuse of the 'Atal Asra' housing scheme, stating that any diversion of funds will attract strict action.

Speaking at a programme organised by the Social Welfare Department at Ravindra Bhavan, Sankhali on Saturday, Sawant said all pending applications under the scheme will be processed and cleared by May 30, ahead of the monsoon season. He assured that financial assistance would be credited directly to beneficiaries.

The Chief Minister urged beneficiaries to use the funds strictly for repairing or rebuilding their homes, cautioning that misuse—such as using the money to purchase a vehicle—would result in the government seizing the vehicle and recovering the funds.

He added that the second instalment of Rs 75,000 would be sanctioned only after submission of bills and a photograph of the repaired or rebuilt house.

Social Welfare Minister Subhash Phal Dessai, Director of Social Welfare Aiit Panchwadkar, and other officials were present at the event. Around 600 beneficiaries are expected to receive assistance under the 'Atal Asra' scheme.

## Activists slam authorities for inaction over land filling in Taleigao paddy fields

PANJIM: Twenty days after filing formal complaints with Goa's flying squad and the North Goa Collectorate, activists Cecille Rodrigues, Francis Coelho, and Nathan D'Souza on Saturday condemned the State authorities for failing to act against alleged illegal land filling in Taleigao's ecologically sensitive paddy fields behind St Michael's Church.

Despite what they termed blatant environmental vandalism and fraud, the Revenue Department, Chief Secretary, and Agriculture Department have remained inactive, exposing what they alleged to be a nexus between political interests and bureaucratic apathy.

Rodrigues said she had alerted the flying squad and followed up with the North Goa Collectorate, but to no avail. She further alleged that a member of the Talei-

gao panchayat was found supervising the illegal dumping operation. When asked to produce authorisation documents, the panchayat member reportedly fled the scene with vague assurances.

The authorities also ignored repeated appeals from local resident Vito Gomes, who had formally petitioned the BDO, Chief Secretary, and the Secretary (Agriculture), the activists stated.

Residents have now demanded that all illegal land filling and construction in the field be halted immediately. They have called for criminal prosecution of the individuals involved, including government officials, and urged the courts to initiate contempt proceedings against the Revenue Department for alleged dereliction of duty.

They further demanded that the damaged paddy fields be restored at the offenders' expense.

## Sangolda resident alleges house number misused

PANJIM: A resident of Liveramento Waddo, Sangolda has alleged that his house number has been wrongly allotted to four other structures in the village.

Lucio Joao Mascarenhas, in his complaint, claimed that his neighbour Damodar Naik had illegally obtained a bifurcation of house number 284, which has now reportedly been allotted to seven other structures or rooms. Mascarenhas said he had lodged a complaint with the village panchayat, demanding that the permissions granted to these structures be revoked and that their electricity and water connections be disconnected.

To support his claim, Mascarenhas submitted copies of his house tax receipt and an electricity bill issued in Naik's name bearing house number 284.

When contacted, Sangolda sarpanch Neeta Kandolkar confirmed that the complaint was taken up during the ordinary meeting held on Friday. "It was decided to issue call letters to both parties, asking them to appear before the panchayat office with their respective documents," she said.

Meanwhile, the gram sabha of the Sangolda panchayat is scheduled to be held at 10:30 am on Sunday, May 18.

# Vishwajit apologises to Digambar, acknowledges him as political mentor
