# Locals blame construction work for Odxel mudslide

Mud dug up from a pit flowed down and into their homes, claim villagers; builder's rep claims 'no mudslide, issue resolved'

PANJIM: Three families residing in Odxel, Taleigao, who were forced to evacuate on Tuesday evening after heavy rain sent a torrent of mud cascading down the hill behind their homes, managed to return home on Wednesday.

The residents blamed the mudslide on an excavation site where a builder is reportedly undertaking construction for a new phase of the Anantam Project. They said the mud that was piled up after a pit had been excavated got washed down in the rain.

However, Nirav MG, sales executive for the Anantam Project, said, "There is not much issue. We had approval from RERA, and there was no mudslide. We spoke to the villagers, and the issue is resolved."

Local authorities, including Panjim Deputy Collector and Sub-Divisional Magistrate Rajendra Ajgaonkar and Tiswadi Taluka Mamlatdar Kaushik Dessai, conduct-

following a complaint. The North Goa Collector B Yashaswini has since directed the Public Works Department (PWD) and the Town and Country Planning (TCP) Department to submit a detailed report on the matter.

For many residents, the mudslide is not just an isolated incident but part of a larger pattern of neglect. Nisha Sarmalkar, one of the affected residents, expressed frustration: "We have been staying here for many years, but this is the first time ed an emergency inspection such a thing has happened.

When we noticed the pit being dug, we approached the builder and warned them. No action was taken."

The Sarmalkar family had previously suffered damage to their home when a mango tree fell on their property three years ago. "We couldn't rebuild the wall due to financial constraints, and our appeals to politicians went unheard," said Nisha, adding that the local MLA only visits the area during elections. Despite the latest evacuation, she declared, "We will not leave our home again, no matter what."

PANJIM: The mudslide that triggered panic in Odxel on Tuesday night also sparked a political firestorm as activist and Aam Aadmi Party (AAP) member Cecille Rodrigues confronted Taleigao MLA Jennifer Monserrate over the incident, leading to a heated exchange and a scuffle. The altercation occurred around 8.50 pm on Tuesday when Monserrate, accompanied by panchayat member Sidney Barreto and her supporters, arrived at the site where Rodrigues and AAP's Francis Coelho were interacting with anxious and distressed residents affected by the mudslide. According to eyewitness accounts, the confrontation turned physical when Monserrate allegedly pushed Rodrigues.

### Relief for Veena Kumar as SC puts her back in chair

Says govt failed to provide valid justification for her replacement as animal husbandry head

PANJIM: The Supreme Court on Wednesday reinstated Dr Veena Kumar as the officiating Director of Animal Husbandry and Veterinary Services (AH&VS), with immediate effect.

A Bench comprising Justices Sanjay Kumar and KV Viswanathan stated, "Dr Veena Kumar shall continue as the in-charge Director of Animal Husbandry and Veterinary Services, Panjim, until further orders."

Dr Kumar, the senior-most officer in the department, was initially appointed as the officiating director. However, she was later replaced by Deputy

lowing a recommendation by Animal Husbandry Minister Nilkanth Halarnkar. Challenging the appointment of Dr Naik, Dr Kumar approached the High Court of Bombay at Goa, which declined to intervene. She then filed a Special Leave Petition (SLP) before the Supreme Court, represented by Adv

During the hearing, State counsel Adv Abhay Anturkar read from the affidavit filed before the High Court and sought time to submit a counter affidavit. However, the Bench remarked that Dr Kumar's initial appointment had been made by the government and that

Director Dr Nitin Naik, fol- her subsequent removal — allegedly influenced by "someone pulling strings" —warranted explanation.

The Court observed that the State failed to provide a valid justification for replacing Dr Kumar with Dr Naik, despite her appointment on June 4, 2024. It suspended the June 20, 2024 order issued by the Under Secretary (Personnel-II), Department of Personnel, which had appointed Dr Naik, and directed Dr Kumar's immediate reinstatement.

The matter has been posted for further hearing on July 22, with the Court granting the State time to file its response.

# Landslide fear stalks Mandrem, Morjim

Villagers blame unchecked construction; is the panchayat 'powerless'?

MANDREM/MORJIM: The fruits of unchecked development are being reaped in Mandrem and Morjim as villagers living on the foothills were pummelled by rain over the past two days, sparking fears of a landslide.

As they prayed for the rain to stop, all eyes were turned towards 18 villas and 60 apartments that

have been granted permission despite protests.

"The roads were flooded because the PWD has not completed their work. With work on the roads half done and water outlets choked, water remained on the road and started entering shops," explained Mandrem Sarpanch Robert Fernandes.

### SC grants interim bail to Ashoka University professor

Raps prof for 'cheap publicity' in Op Sindoor post; asks Haryana DGP to set up 3-member SIT to probe case

PTI, NEW DELHI: The Supreme Court on Wednesday granted interim bail to Ashoka University professor Ali Khan Mahmudabad, arrested for his contentious social media posts on Operation Sindoor, but refused to stay the investigation against him. A bench of Justices Surya Kant and

N Kotisar Singh directed the Haryana director general of police to constitute a three-member special investigation team (SIT) headed by an inspector general (IG) rank officer also including a superintendent (SP) rank woman officer within 24 hours to investigate the case.

The top court said the interim bail was granted to the petitioner to facilitate further investigation and directed Mahmudabad to surrender his passport.

The SIT, the bench said, should comprise three directly recruited IPS officers – not from Harvana but serving in the State. The bench said aside from the IG rank officer, two others should be police superintendents or above rank officers.

The bench, which examined the online post by the professor, who heads the political science department in the Sonipat-based Ashoka University, questioned his choice of words, saying they were used deliberately to humiliate, insult, or put others in discomfort.

The bench said though everybody had the right to freedom of expression, Mahmudabad's remarks seemed like "dog whistling", used in legal parlance.
