

6 killed, including 3 children, in Baloch school bus attack

PTI, KARACHI: A suicide attacker targeted a school bus in Pakistan's restive Balochistan province on Wednesday, killing at least six people, including three children, and wounding 38 others, officials said.

The incident occurred in the Khuzdar district when the bus carrying schoolchildren was targeted, the army said in a statement.

Three children and three

adults were killed, and multiple other children sustained injuries, it added.

No group has claimed responsibility for the attack.

In a statement on X, the Interior Ministry said the blast was carried out through a vehicle-borne improvised explosive device (VBIED).

Khuzdar Deputy Commissioner Yasir Iqbal Dashti said that 38 people were injured in the blast, which oc-

curring near the Zero Point area, the Dawn newspaper reported.

After the attack, law enforcement agency personnel reached the site to collect evidence for an investigation, Yasir said, adding that preliminary findings indicated that the attack was a suicide blast.

The bodies and those injured were taken to the Combined Military Hospital, from where those with serious injuries were referred to medical facilities in Quetta and Karachi, he said.

In its statement, the army alleged that the groups linked to India carried out the attack, a claim dismissed by New Delhi as

"baseless".

In New Delhi, the Ministry of External Affairs said it has become "second nature" for Pakistan to blame India for all its internal issues in order to divert attention from its reputation as the "global epicenter" of terrorism.

"India rejects the baseless allegations made by Pakistan regarding Indian involvement with the incident in Khuzdar earlier today," Jaiswal said.

India condones the loss of lives in all such incidents, he said.

Prime Minister Shehbaz Sharif strongly condemned the terrorist attack on the school bus. In a statement, he expressed deep sorrow

over the deaths of innocent children and their teachers in the incident, Geo News reported.

Sharif also alleged that the attack was carried out by terrorists backed by India. He, however, did not provide any evidence to support his claim.

He also instructed authorities to identify the perpetrators and bring them to justice.

President Asif Ali Zardari strongly condemned the attack and extended condolences to the families of the victims.

Interior Minister Mohsin Naqvi also condemned the explosion and said, "The beasts who target innocent children do not deserve any leniency."

Balochistan, bordering Iran and Afghanistan, is home to a long-running violent insurgency.

Maha: Drones to make emergency announcements

PTI, CHHATRAPATI SAMBHAJINAGAR: As the monsoon looms large over Maharashtra region in central Maharashtra, the police plan to use drones for making emergency announcements in vulnerable riverside villages to safeguard their lives, officials said on Wednesday.

This approach aims to overcome the traditional challenges of reaching remote areas in the region during emergencies and ensure timely warnings for residents living along the riverside.

The Maharashtra region has seen villages bearing the brunt of floods since 2005 in major rivers like Godavari, Purna, and Manjara.

The police department, which is a part of the district disaster management committees across the eight districts in the region is now actively seeking to integrate drones into their disaster response toolkit.

SC grants anticipatory bail to ex-IAS probationer Khedkar

Questions Delhi Police on gravity of crime

PTI, NEW DELHI: Is she a drug lord or a terrorist? The Supreme Court asked Delhi Police on Wednesday as it granted anticipatory bail to former IAS probationer Puja Khedkar, accused of cheating, and wrongly availing OBC and disability quota benefits in the civil services examination.

A bench comprising Justices B V Nagarathna and Satish Chandra Sharma directed Khedkar to fully cooperate in the probe cautioning against any misuse of her liberty.

She was ordered not to influence witnesses or tamper with the evidence.

"What is the grave crime she has committed? She is not a drug lord or a terrorist. She has not committed 302 (murder). She is not an NDPS offender. You should have a system or a software. You complete the investigation. She has lost everything and will not get a job anywhere," the bench said.

The top court went on, "The appellant is entitled to

the relief claimed under Section 482 of Bharatiya Nagarik Suraksha Sanhita. We, therefore, allow this appeal and set aside the order passed by the high court."

The relief was allowed on a cash security of Rs 25,000 with two like sureties.

Delhi Police was, however, allowed to move for cancellation of the anticipatory bail in case of any violation of conditions.

Senior advocate Sidharth Luthra, appearing on behalf of Khedkar, said the investigation had been going on since July, 2024 and cited his client's complete cooperation in the probe.

Khedkar was stated to have appeared seven times before the police.

Luthra contended the high court ought to have granted bail given the nature of offences and bearing in mind the facts and circumstances of the case.

The Delhi Police counsel opposed the plea citing Khedkar's non-cooperation in the probe.


