The delegation also held fruitful interaction with Minoru Kihara, Former Defence Minister of Japan, and Shinako Tsuchiya, Director General of the International Bureau, Liberal Democratic Party (LDP).

AP. SEOUL: North Korea is seeking to arrest those responsible for the failed launch of its second naval destroyer, as it denied the warship suffered major damage a claim quickly met with outside scepticism.

A statement from North Korea on its handling of the botched launch came after leader Kim Jong Un expressed fury over the incident that he said was caused by criminal negligence. The main military committee said Friday that those responsible would be held accountable for their "unpardonable criminal act."

Satellite imagery on the site showed the vessel lying on its side and draped in blue covers, with parts of it submerged. North Korea says it will take about 10 days to repair the damage, but outside observers question that timeframe because damage to worse than what North Korea claims. North Korea's state
