DOUBLE-TRACKING DISASTER PLAYS OUT AT ISSORCIM

Locals accuse rail officials of adopting faulty construction methods, which left their fields buried and century-old drainage system in ruins

MARGAO: Call it a manmade disaster. South Western Railway's (SWR) double-tracking project has caused widespread environmental destruction in Issorcim, with residents alleging that unseasonal rain exposed the catastrophic impact of faulty construction methods which left their paddy fields buried under mud and the century-old drainage system in ruins.

It is pertinent to note that Issorcim falls in the Velsao-Pale-Issorcim Panchayat jurisdiction.

According to affected residents, the disaster stems from the Railway authorities destroying the century-old storm water tunnels that were built by British engineers beneath the existing single railway track. These tunnels, the locals say, were connected to an ancient drainage network that had effectively channelled rainwater from East to West for over a century, preventing landslides and soil erosion in the ecologically-sensitive forest

They alleged that Rail Nigam Limited (RVNL), executing the project for SWR, buried the ecologically tenable drainage system while constructing the second track burst open with tremen-

Ragging row: Activist says pressure on arch students to back off

Demands inquiry by retired judge or SP; principal says he's following due process

PANJIM: The alleged ragging incident involving Goa College of Architecture students that took place in September last year has seen a further twist, with social worker John Nazareth claiming on Saturday that the college authorities are now pressuring first-year students to give in writing that they are not willing to pursue the matter.

Nazareth, who is also the Goa Government Employees' Association president, demanded an impartial inquiry by a retired Judge or a retired Superintendent of Police (SP) and has challenged the college principal's order before the State Information Commissioner. The matter is fixed on June 17.

As many as 24 first year students had complained about ragging which occurred during a freshers' party held in a private hall in Panjim, but no stern action was taken against the senior students involved in ragging and were while let off probe was closed after reportedly asking the victims to withdraw their complaint.

Nazareth further alleged that the students were harassed and the incident came to light only after he

The event is now being described as a "private party" to deflect the matter and avoid institutional responsibility, he said, reiterating his demand for an impartial probe.

He said after **O Heraldo** highlighted the ragging, the first year students are reportedly pressured to give in writing that they are not interested in pursuing their complaint.

PTI. NEW DELHI: The southwest monsoon hit Kerala on Saturday, marking its earliest arrival over the Indian mainland since 2009 when it reached the southern state on May 23, the India Meteorological Department (IMD) said.

Normally, the southwest monsoon makes its onset over Kerala by June 1 and covers the entire country by July 8. It starts retreating from northwest India around September 17 and withdraws completely by October 15.

The monsoon had set in over the southern State on May 30 last year; June 8 in 2023; May 29 in 2022; June 3 in 2021; June 1 in 2020; June 8 in 2019; and May 29 in 2018, IMD data showed.

Data available since 1975 showed that the monsoon reached Kerala the earliest in 1990 (on May 19), 13 days before the usual date.

Road-digging ban can't hide mess on streets

North Collector's two-month ban on road digging with monsoon just days away makes citizens ask: what will happen to the roads already dug up?

PANJIM: The North Goa District Collector's order on Saturday prohibiting the digging of roads without written permission has evoked anger, irritation and plain ridicule from the long-suffering residents of the district.

The order that came into force with immediate effect will remain in operation for two months up to July 24. But a ban on digging will not stifle the question on everyone's lips: what about the roads that have been dug up already? With the rains, they are now either open pits for mosquitoes to breed or are covered in rubble that pose a threat to vehicles on water-

Justice Nagarathna set to be first woman CJI

DELHI: Justice BV Nagarathna, in line to become the first wom-



an Chief Justice of India. is set to become a member of the Supreme Court Collegium after the retirement of Justice Abhay S Oka.

Being the fifth seniormost judge now, Justice Nagarathna will officially become part of the collegium on May 25 and will be part of it until she retires as Chief Justice of India on October 29, 2027.

The Collegium will now comprise Chief Iustice Bhushan Ramkrishna Gavai, Justice Surya Kant, Justice Vikram Nath, Justice J K Maheshwari, and Justice Nagarathna.

According to apex court sources, CJI Gavai is likely to convene his inaugural collegium meeting on Monday to address vacancies in the top court and make crucial appointments in several high courts.

After Justice Oka's retirement, there will be a vacancy of three judges in the top court.

Under the collegium system, which came into existence in 1993 after a Supreme Court judgement, five top judges of the apex court recommend the appointment, transfer and elevation of judges to the Supreme Court and the 25 high courts.

The government can return the recommendation to the collegium under this
